Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Synod Residential Services 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 15, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1 through November 15, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Synod Residential Services 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF THE PLAN

The following description of Synod Residential Services 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan originally effective January 1, 2007. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective January 1, 2022. The Plan excludes nonresident aliens and contingent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On May 25, 2023, the Plan Sponsor entered into a merger agreement with a Michigan non-profit corporation. The Plan merger was effective October 1, 2023 or as soon as administratively feasible following merger approval. At the same time, all employees became employees of Renaissance Community Homes and eligible to participate in the Renaissance Community Homes 401(k) Profit Sharing Plan and Trust. On November 15, 2023, all assets of the Plan were transferred into the Pathlight Community Services 401(k) Profit Sharing Plan and Trust (formerly Renaissance Community Homes 401(k) Profit Sharing Plan and Trust).

Eligibility

Employees (except nonresident aliens and contingent employees) of Synod Residential Services (the Company) are eligible to participate in the deferral component of the Plan immediately when the employee attains age 18. Employees are eligible to participate in Company matching contributions and profit sharing contributions on the first day of each Plan quarter following six months of employment.

Effective October 1, 2023, employees are eligible to participate in Company matching contributions and profit sharing contributions on the first day of each Plan quarter following one year of employment.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their annual pretax compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company provides a discretionary matching contribution equal to 1% of each participant's qualified compensation and a discretionary profit sharing contribution, determined based on the Company's operating results. The Company discretionary profit sharing contribution was 2% from January 1 through September 30, 2023.

Effective October 1, 2023, based on the merger described above, the Company discretionary matching contribution was 100% of the first 3% of eligible compensation that a participant contributed to the Plan.

Contributions (Continued)

Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contribution, allocations of matching and discretionary contributions made by the Company, and earnings or losses of the participant's selected investments. Discretionary contributions are based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings or losses thereon. Vesting in Company matching and discretionary contribution portion of their accounts, plus actual earnings or losses thereon, is based on years of continuous service, as defined. A participant is fully vested upon completion of three years of credited service. Notwithstanding the above, a participant is fully vested upon death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their actual balance or \$50,000 for hardship reasons only. Loan transactions are treated as a transfer between the investment fund and the participant's note. Loan terms range from one to five years unless used to purchase a principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates plus 1%, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to normal retirement, early retirement, late retirement, disability or termination, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in regular installments over a period of time not to exceed certain life expectancy guidelines. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce administrative expenses and/or used to reduce future Employer contributions. Forfeited nonvested accounts as of November 15, 2023 and December 31, 2022 totaled \$345 and \$134, respectfully. There was \$1,183 of forfeitures used to pay administrative expenses for the period ended November 15, 2023. There were no forfeitures used to reduce Company contributions for the period ended November 15, 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Brokerage fees are included in the cost basis of assets purchased and reduce the proceeds of assets sold.

Notes Receivable from Participants

Notes receivable from participants are obligations and are stated at the amount of unpaid principal balance plus any accrued but unpaid interest. Payments of notes receivable from participants are applied to the specific accounts comprising the balance. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan agreement.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses represent charges from Alerus Financial, N.A. for recordkeeping and other services. These are generally paid by the Plan. The Company pays all other administrative expenses, including internal costs, incurred with respect to operating the Plan.

Subsequent Events

The Plan has evaluated subsequent events through July 15, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Alerus Financial, N.A., the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net asset available for benefits as of November 15, 2023 and December 31, 2022, and the statement of changes in net assets available for benefits for the period January 1 through November 15, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at November 15, 2023 and December 31, 2022.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN TERMINATION

As discussed in Note 1, the Plan Sponsor entered into a merger agreement and consequently, all plan participants were merged November 15, 2023 into Pathlight Community Services 401(k) Profit Sharing Plan and Trust, which was as soon as administratively feasible following merger approval. The participants continued the same vesting schedule once merged into the new plan. Contributions into the Plan ceased on November 6, 2023.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan to Alerus Financial, N.A., the trustee of the Plan, qualify as party-in-interest transactions and amounted to \$16,841 for the period January 1 through November 15, 2023.

NOTE 8 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The accompanying statement of net assets available for benefits reports assets and liabilities as of November 15, 2023 as the Plan assets were not liquidated as of that date for the merger described in Note 1 and 5. The Form 5500 reports no assets or liabilities of the Plan as of November 15, 2023 as legal control was transferred to the receiving plan, and as such, there is no ERISA-required supplemental schedule of assets (held at end of year).

NOTE 1 DESCRIPTION OF THE PLAN

The following description of Synod Residential Services 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan originally effective January 1, 2007. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective January 1, 2022. The Plan excludes nonresident aliens and contingent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On May 25, 2023, the Plan Sponsor entered into a merger agreement with a Michigan non-profit corporation. The Plan merger was effective October 1, 2023 or as soon as administratively feasible following merger approval. At the same time, all employees became employees of Renaissance Community Homes and eligible to participate in the Renaissance Community Homes 401(k) Profit Sharing Plan and Trust. On November 15, 2023, all assets of the Plan were transferred into the Pathlight Community Services 401(k) Profit Sharing Plan and Trust (formerly Renaissance Community Homes 401(k) Profit Sharing Plan and Trust).

Eligibility

Employees (except nonresident aliens and contingent employees) of Synod Residential Services (the Company) are eligible to participate in the deferral component of the Plan immediately when the employee attains age 18. Employees are eligible to participate in Company matching contributions and profit sharing contributions on the first day of each Plan quarter following six months of employment.

Effective October 1, 2023, employees are eligible to participate in Company matching contributions and profit sharing contributions on the first day of each Plan quarter following one year of employment.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their annual pretax compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company provides a discretionary matching contribution equal to 1% of each participant's qualified compensation and a discretionary profit sharing contribution, determined based on the Company's operating results. The Company discretionary profit sharing contribution was 2% from January 1 through September 30, 2023.

Effective October 1, 2023, based on the merger described above, the Company discretionary matching contribution was 100% of the first 3% of eligible compensation that a participant contributed to the Plan.

Contributions (Continued)

Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contribution, allocations of matching and discretionary contributions made by the Company, and earnings or losses of the participant's selected investments. Discretionary contributions are based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings or losses thereon. Vesting in Company matching and discretionary contribution portion of their accounts, plus actual earnings or losses thereon, is based on years of continuous service, as defined. A participant is fully vested upon completion of three years of credited service. Notwithstanding the above, a participant is fully vested upon death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their actual balance or \$50,000 for hardship reasons only. Loan transactions are treated as a transfer between the investment fund and the participant's note. Loan terms range from one to five years unless used to purchase a principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates plus 1%, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to normal retirement, early retirement, late retirement, disability or termination, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in regular installments over a period of time not to exceed certain life expectancy guidelines. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce administrative expenses and/or used to reduce future Employer contributions. Forfeited nonvested accounts as of November 15, 2023 and December 31, 2022 totaled \$345 and \$134, respectfully. There was \$1,183 of forfeitures used to pay administrative expenses for the period ended November 15, 2023. There were no forfeitures used to reduce Company contributions for the period ended November 15, 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Brokerage fees are included in the cost basis of assets purchased and reduce the proceeds of assets sold.

Notes Receivable from Participants

Notes receivable from participants are obligations and are stated at the amount of unpaid principal balance plus any accrued but unpaid interest. Payments of notes receivable from participants are applied to the specific accounts comprising the balance. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan agreement.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses represent charges from Alerus Financial, N.A. for recordkeeping and other services. These are generally paid by the Plan. The Company pays all other administrative expenses, including internal costs, incurred with respect to operating the Plan.

Subsequent Events

The Plan has evaluated subsequent events through July 15, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Alerus Financial, N.A., the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net asset available for benefits as of November 15, 2023 and December 31, 2022, and the statement of changes in net assets available for benefits for the period January 1 through November 15, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at November 15, 2023 and December 31, 2022.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN TERMINATION

As discussed in Note 1, the Plan Sponsor entered into a merger agreement and consequently, all plan participants were merged November 15, 2023 into Pathlight Community Services 401(k) Profit Sharing Plan and Trust, which was as soon as administratively feasible following merger approval. The participants continued the same vesting schedule once merged into the new plan. Contributions into the Plan ceased on November 6, 2023.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan to Alerus Financial, N.A., the trustee of the Plan, qualify as party-in-interest transactions and amounted to \$16,841 for the period January 1 through November 15, 2023.

NOTE 8 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The accompanying statement of net assets available for benefits reports assets and liabilities as of November 15, 2023 as the Plan assets were not liquidated as of that date for the merger described in Note 1 and 5. The Form 5500 reports no assets or liabilities of the Plan as of November 15, 2023 as legal control was transferred to the receiving plan, and as such, there is no ERISA-required supplemental schedule of assets (held at end of year).
