We have performed audits of the financial statements of Seattle Children's 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements For the Year Ended December 31, 2023

Note 1 - Plan Description

The following description of the Seattle Children's 403(b) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

General - The Plan is a defined contribution plan established by Seattle Children's Healthcare System (the Company) under the provisions of Section 403(b) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility and Vesting - Employees of the Company, except for those in an excludable group as defined in the Plan, are eligible to participate upon date of hire.

Participants are fully vested in their contributions and earnings thereon.

Contributions - Participants may elect to defer up to 75% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). There are no employer contributions to the Plan.

Plan Administration - The Plan is administered by the Retirement Administrative Committee of the Company. Fidelity Management Trust Company (Fidelity), Voya Retirement Insurance and Annuity Company (Voya), Calvert Investments (Calvert), Ameriprise Trust Company (Ameriprise), and The Variable Annuity Life Insurance Company (VALIC) are the custodians of the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Benefit Payments - Upon termination of service or retirement, a participant or beneficiary may elect to receive either a lump-sum distribution equal to the value of the participant's interest in their account, periodic installment payments, or the distribution method available under applicable investment arrangements with the custodians of the Plan. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document.

Investment Management and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Note 1 - Continued

Investment Options - Plan participants may direct contributions into various registered investment company fund options held by Fidelity and the Fidelity BrokerageLink self-directed accounts where participants agreeing to provisions under the account may invest in a variety of registered investment company funds. Participants may change their investment election or make transfers between the investment options as allowed under the Plan on a daily basis. Transfers may be made between the accounts held by Voya, Calvert, Ameriprise, VALIC, and Fidelity. Prior to January 1, 2009, participants could invest contributions to accounts held by all of the Plan's custodians.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared using the accrual basis of accounting. The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds which are valued as described above.

Separate Accounts - Valued using the accumulation unit values provided by Voya which is based on the NAV of the underlying mutual funds or, in some cases, collective investment trusts.

Fixed Annuity Contracts - The majority of plan assets invested in fixed annuity contracts are held in contracts that are not considered fully benefit-responsive and, therefore, are measured at fair value. Participant initiated withdrawals or transfers may be subject to certain liquidity restrictions and/or fees. Contracts are reported by the issuer at contract value which is the aggregation of contributions, plus interest, less any withdrawals. Contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market rate which correlates closely with historical crediting rates for these contracts. Fair value is determined annually for financial statement reporting purposes. The average yields and crediting rates of the contracts were approximately 3.8% for 2023. The interest rates on the contracts are variable and based on agreed upon formulas with the issuers.

Note 4 - Tax Status

Management adopted a Fidelity Workplace Services LLC volume submitter plan document with a restatement effective date of January 1, 2010. Fidelity Workplace Services LLC received an advisory letter from the IRS dated August 7, 2017, which states that the volume submitter plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan's management believes that the Plan is currently designed and being operated in a manner that would not jeopardize the tax benefits associated with these arrangements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Note 6 - Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2023 and 2022, and investment income or loss for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, Voya Retirement Insurance and Annuity Company, and The Variable Annuity Life Insurance Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Registered investment company funds totaling approximately \$2.6 million held by Calvert are not certified and are not material.

Note 7 - Party-in-Interest Transactions

Certain plan investments are managed by Fidelity, Voya, Calvert, Ameriprise, and VALIC or their affiliates. Fidelity, Voya, Calvert, Ameriprise, and VALIC are custodians as defined by the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers. These transactions are party-in-interest transactions.

Note 8 - Subsequent Events

The Plan's Management has evaluated subsequent events through July 16, 2024, the date the financial statements were available to be issued.
