Notes to Financial Statements

November 10, 2023

1. Description of the Plan

The following description of the AZ Pet Vet Holding LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan available to eligible employees of AZ Pet Vet Holding LLC (the Employer), who completed six months of eligible service and were age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer was responsible for the administration of the Plan and entrusted the maintenance of records and the day-to-day administration to TAG Resources, LLC (TAG) who processed transactions through Transamerica Financial Life Insurance Company (Transamerica), the custodian.

The Employer elected to terminate the Plan effective August 31, 2022 (termination date). In accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis of accounting in presenting the 2023 and 2022 financial statements. The liquidation basis of accounting did not have a significant impact on the Plan's financial statements.

As a result of the decision to terminate the Plan, effective the termination date, no new participants were admitted to the Plan, all participant accounts became fully vested and contributions ceased. The net assets of the Plan were allocated as prescribed by ERISA and its related regulations. Upon termination, any unallocated assets of the Plan reverted back to the Employer, unless required otherwise under the terms of the Plan. The Plan distributed all Plan assets by November 10, 2023.

Contributions

Each year, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time.

1. Description of the Plan (continued)

Contributions (continued)

Prior to the termination date, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation.

In addition, the Employer also made matching contributions to the Plan equal to 50% of employee's elective deferral up to 6% of the employee's compensation. Owners were excluded from receiving matching contributions. The Employer could also make discretionary profit sharing and qualified nonelective contributions to the Plan. No contributions were made to the Plan during 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Employer's matching, discretionary profit sharing and qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Prior to termination date, participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's matching contribution and discretionary profit sharing contribution portion of their accounts plus related earnings thereon was based on years of vesting service in which the participants completed 1,000 hours of service, as follows:

Less than 1	0%

Effective the termination date, all participants became 100% vested in their accounts.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or early retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age could choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permitted in-service and hardship withdrawals under certain conditions.

Forfeitures

Forfeitures were created when participants terminated employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could be used to pay administrative expenses and to reduce future Employer contributions. As of the period ended November 10, 2023, the forfeitures balance was fully distributed and as of December 31, 2022, forfeited non-vested accounts held in the stable value advantage option total \$72,341.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value except for its benefit-responsive investment contract, which was valued at contract value (Note 6). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determined the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Prior to the plan termination, contributions from Plan participants and the matching contributions from the Employer were recorded in the year in which the employee contributions were withheld from compensation.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses has been recorded as of November 10, 2023 or December 31, 2022. If a participant ceased to make scheduled repayments and the Plan administrator deemed the note receivable to be in default, the note receivable balance was reduced and a benefit payment recorded.

Excess Contributions Payable

Amounts payable to participants totaling \$7,715 as of December 31, 2022, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants during 2023.

Benefits Paid to Participants

Benefits were recorded when paid.

2. Significant Accounting Policies (continued)

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2024, the date the financials were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held as of November 10, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest income from stable value advantage option, and interest income on notes receivable from participants for the period ended November 10, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

4. Concentrations

The Plan has one investment representing greater than 20% of net assets available for benefits as of December 31, 2022.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value: There have been no changes in the methodologies used as of December 31, 2022.

Pooled separate accounts: Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

6. Group Annuity Contract

The Plan invested in a fully benefit-responsive investment contract with Transamerica totaling \$158,034 as of December 31, 2022. Transamerica maintained the contributions in a general unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest was established every January 1 and July 1 and was based on the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. There was no guaranteed minimum or maximum interest rate under this contract, no unfunded commitments, and redemption frequency and notice period could occur daily.

The contract met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts, because it was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

6. Group Annuity Contract (continued)

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other Employer events that caused a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. Even though the Plan terminated, this event did not limit the ability of the Plan to transact at contract value with the contract issuers or limit the ability of the Plan to transact at contract value with the participants.

7. Related Party Transactions and Party-in-Interest Transactions

Plan investments were in accounts of Transamerica; therefore, these transactions qualified as party-in-interest transactions. Notes receivable from participants and participant contributions were also considered to be party-in-interest transactions. Employer contributions were considered to be both party-in-interest and related party transactions.

8. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan which had received an opinion letter dated August 17, 2021, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan was designed and was operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invested in various investment securities, which were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the value of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
