Notes to Financial Statements

1. Background and Organization:

Effective January 1, 2020, Temperpack Technologies Inc. (the "Company") established the Temperpack Technologies Inc. Group Health Benefit Plan (the "Plan") and related Temperpack Technologies, Inc. Health Benefit Trust (the "Trust"), to hold assets required to pay medical and prescription claims associated with the Plan.

2. Description of the Plan:

The following description of the Temperpack Technologies Group Health Benefit Plan provides only general information. Participants should refer to the Plan document or summary plan description for a more complete and comprehensive description of the Plan's provisions.

General: The Plan provides comprehensive medical and prescription benefits to eligible employees (as defined by the Plan). The Plan covers employees who work at least 30 hours per week and have attained age 18, and their eligible family members (e.g., spouse and children). The Plan does not cover leased employees, independent contractors, consultants, or members of the employer's board of directors, owners, partners, or officers. Eligible employees may enter the Plan on the first day of the subsequent month upon fulfilling eligibility requirements. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Stop Loss Coverage: The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured Benefits: All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only ("ASO") arrangement with UMR, Inc. ("UMR"). UMR pays claims directly to or on behalf of participants and are then reimbursed by the Plan's Trust or general assets of the Company. Despite the Plan's utilization of third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions: Participants help cover some of the costs of covered benefits through contributions, deductibles, out-of-pocket amounts, and plan participation amounts described in the Schedule of Benefits.

The Company makes contributions to the Plan to fund claims in excess of participant's contributions.

Plan Administration: The assets of the Plan are held under an agreement of trust with VERIS Wealth Partners ("VERIS"), the custodian of the Plan's investment assets, and administered by its affiliate, Benecon Group, Inc. ("Benecon"). Overall responsibility for administering the Plan rests with the Company.

2. Description of the Plan, Continued:

Plan Trustees: Certain employees of the Company serve as the trustees of the Plan. The trustees are not compensated by the Plan for services rendered.

3. Summary of Significant Accounting Policies:

Basis of Presentation: The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America on the accrual basis of accounting.

Cash and cash Equivalents: The Plan considers all highly liquid debt instruments purchased with a maturity of three months or less to be cash.

Payment of Benefits: Claims payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrator. These payments are recorded as medical claims in the accompanying statement of changes in net assets available for benefits.

Plan Benefit Obligations: Plan benefit obligations at December 31, 2020 for health claims incurred by active participants but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Stop Loss: The Plan has specific and aggregate stop-loss insurance coverage for medical and prescription drug claims paid per year for any individual exceeding a deductible of \$60,000 and \$1,000,000, respectfully. For the year ended December 31, 2020, the premiums paid for these policies totaled \$213,080 and \$15,708, respectfully. These payments are recorded as stop loss insurance premiums in the accompanying statement of changes in net assets available for benefits.

Accounting Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to assets during the reporting period. Such estimates include those regarding claims incurred but not reported. Actual results could differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through October 15, 2021, the date the financial statements were available for issuance, and has determined there are no subsequent events to be reported in the accompanying financial statements.

5. Administrative Expenses:

The Plan pays administrative expense that consist primarily of administrative fees paid to third-party claims administrators and the custodian. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

6. Tax Status:

The Plan has not received an exemption letter from the IRS and, therefore the trust is not exempt from taxes. No federal or state income taxes have been recorded in 2020, as the Company has determined taxable income associated with trust earnings to be immaterial.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2020. The plan is not currently under audit by any tax jurisdiction.

7. Related Party Transactions:

The Plan's cash is held in a money market deposit account administered by the custodian of the Plan, and its affiliate. As described in Notes 2 and 5, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions.

8. Plan Continuation:

The Company has not expressed any intent to terminate the Plan. In the event a termination of the Plan occurs, remaining assets will be applied toward the provision of benefits for or on account of participants. No assets of the Plan may revert to the Company or be used for the purposes other than for exclusive benefit of the Plan's participants.

9. Concentrations of Credit Risk:

Financial instruments which periodically expose the Plan to concentrations of credit risk consist primarily of cash. The Company maintains its cash in financial institutions with balances that periodically exceed federally insured limits.
