## INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of the  
Pension Plan of The Milford Bank  
Milford, Connecticut

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed audits of the accompanying financial statements of Pension Plan of the Milford Bank (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net liabilities in liquidation as of August 18, 2023 (date of liquidation) and December 31, 2022, and the related statements of changes in net liabilities in liquidation for the period January 1, 2023 to August 18, 2023 (date of liquidation) and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 18, 2023 (date of liquidation) and December 31, 2022 and for the period January 1, 2023 to August 18, 2023 (date of liquidation) and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Basis in Accounting***

As discussed in Note 5 to the financial statements, the governing body of the Plan approved a plan of liquidation on August 16, 2021, and management determined liquidation was imminent. As a result, the Plan uses the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the financial statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

AUGUST 18, 2023 (DATE OF LIQUIDATION) AND DECEMBER 31, 2022

#### NOTE 1—DESCRIPTION OF PLAN

The following description of the Pension Plan of The Milford Bank (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan was a defined benefit plan covering employees of The Milford Bank (the “Company”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Prior to March 31, 2010, employees were eligible to participate in the Plan as of January 1<sup>st</sup> or July 1<sup>st</sup> immediately following the date on which they had attained 21 years of age and completed 1,000 hours of service within one year of their date of hire or 1,000 hours of service within one plan year.

The Company froze the Plan effective March 31, 2010. As of that date, all active participants became 100% vested in their benefits, and employee service time and benefit accruals ceased. Participants’ accrued benefits at retirement were determined as of March 31, 2010 using their average final compensation and years of service as of that date. As described in Note 5, effective August 16, 2021, the Plan was terminated.

##### *Funding Policy*

The Company made all contributions to the Plan in such amounts and at such times as it determined to be necessary to meet required funding rules or desirable to further the purposes of the Plan. The Company made contributions for 2023 and 2022 of \$1,339,758 and \$341,680, respectively, toward the minimum funding requirements of ERISA, which was determined using the unit credit actuarial cost method.

##### *Pension Benefits*

Participants who were former employees with five or more years of service as of March 31, 2010 and all participants who were active employees on March 31, 2010 were entitled to annual pension benefits beginning at age 65 (“normal retirement age”) equal to 2% of their final average annual compensation for the highest paid 60 consecutive months of their final 120 months of service prior to March 31, 2010, minus 1⅓% of their primary social security benefit for each year of service, to a maximum of 30 years. The accrued benefit of participants who were active employees on March 31, 2010 had been determined as if they had terminated employment on that date. Former employees with less than five years of service who terminated employment prior to March 31, 2010 forfeited the right to receive their accumulated plan benefits.

Participants eligible for benefits with years of service prior to July 1, 1985 were entitled to annual pension benefits beginning at normal retirement age equal to 2% of their final average compensation for the highest paid 60 consecutive months of their final 120 months of service for each year of service prior to July 1, 1985 plus 2% of their final average annual compensation for the highest paid 60 consecutive months of their final 120 months of service prior to March 31, 2010, minus 1⅓% of their primary social security benefit for each year of service, to a maximum of 30 years of service.

The Plan permitted early retirement beginning at age 50 provided the participant had 10 years of vesting service. Participants’ benefits were reduced according to a formula for each month they receive benefits prior to normal retirement age. Participants received their pension benefits in the form of a joint and 50% survivor annuity (single-life annuity if unmarried) unless they chose another optional, actuarial equivalent form of payment, as permitted by the Plan.

#### **NOTE 1—DESCRIPTION OF PLAN (continued)**

##### ***Death and Disability Benefits***

If a married employee died after becoming fully vested, the employee's spouse received a death benefit equal to the value of the employee's accumulated pension benefits as if a joint and 50% survivor annuity was chosen as the form of payment. Active employees who became totally disabled received disability retirement benefits that were equal to their accumulated normal retirement benefits.

The disability retirement benefits began on the normal retirement date, and the benefit service included up to 10 years of benefit service for each year prior to March 31, 2010 that an employee was disabled up to the employee's normal retirement. As of March 31, 2010, no additional years were included as years of benefit service.

#### **NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of Accounting***

The accompanying financial statements are prepared on the liquidation basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements. Accordingly, actual results may differ from those estimates.

##### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

#### **NOTE 3—CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held at December 31, 2022, and net investment income/loss for the period January 1, 2023 to August 18, 2023 and the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, the Trustee of the Plan.

#### NOTE 4—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other observable inputs that do not qualify as Level 1, and Level 3 inputs are unobservable and have the lowest priority.

An asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. These techniques may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value or contract value on a recurring basis:

*Pooled separate accounts:* Valued at the fair value per share (unit) based upon the number of shares held by the Plan at year end as reported by the fund managers. The Plan considers the fair value per share (unit) to be a readily determinable fair value which is disclosed and used as the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value or contract value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5—PLAN TERMINATION**

On May 12, 2021, the governing body of The Plan approved a plan of liquidation, and management determined liquidation was imminent. The plan termination date was set as August 16, 2021 and the basis of accounting was changed from ongoing to liquidation at that time. Participants were notified about the termination date in June 2021. The financial statements as of August 18, 2023 (date of liquidation) and December 31, 2022, and for the period January 1, 2023 to August 18, 2023 (date of liquidation) and the year ended December 31, 2022, are presented on the liquidation basis. Final distributions were determined based on all participants being 100% vested.

In August 2021, the Plan transferred all plan assets to a 100% fixed income allocation. The fixed income allocation is invested in LDI (liability driven investment) portfolios so the duration of the Plan's assets match the duration of the Plan's liabilities.

Estimated administrative expenses of \$69,833 have been accrued and are presented on the Statement of Net Liabilities in Liquidation as of December 31, 2022.

The IRS approved the termination of the Plan in a letter dated November 29, 2022. On August 18, 2023, the Plan settlement date, the Plan used all remaining assets of \$7,936,848 and an additional \$1,252,025 of Employer contributions to make final distributions totaling \$9,188,873 through cash distributions, direct rollovers, and the purchase of annuities.

#### **NOTE 6—TAX STATUS**

The IRS determined and informed the Company by a letter dated January 11, 2017 that the Plan, as amended and restated in January 2016, and related trust were designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan has been designed and operated in compliance with the applicable requirements of the IRC. The Plan Administrator believes that Plan is no longer subject to income tax examinations for year prior to 2020.

#### **NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays fees for trustee, investment management and advisory, and recordkeeping services to Principal Trust Company.

The Plan also pays fees for various professional services, such as actuarial and accounting fees. These transactions qualify as exempt party-in-interest transactions under ERISA.

#### **NOTE 8—SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 17, 2024, the date the financial statements were available to be issued. There were no subsequent events which require recognition or disclosure in the financial statements.
