I am writing to request any abatement of penalties that could potentially be assessed related to the late Form 5500 attached for the S&S Ancillary Plan #501.

We acknowledge and deeply apologize for this late filing. This entity was recently acquired by a new broker and there was a bit of confusion as well as a delay in obtaining the Schedule A information necessary to complete their Form 5500 filings as a result in part of being in the process of a conversion into a wrapped plan (this will be the final filing for both plans #501 and #502 as next year they will file wrapped as #503) as well as one of their insurance providers, Humana, recently exiting the group medical market which apparently caused a delay in providing the Sch A for their medical insurance component. Both the #501 and #502 plan filings were completed and submitted electronically today. With the extension that was filed they were due on 6/15/24 so they are a little over a month past due as of today. These are Health and Welfare Form 5500 filings so there are not any related taxes missed or due.

Again, I sincerely apologize and hope that you will consider the abatement of any potential penalties owed based on the reasonable cause for the reasons above for this 2022-2023 plan year filing.
