Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements (in liquidation) of National Education Partners, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 26, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits (in liquidation) for the period ended December 26, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National Education Partners, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 26, 2023 and December 31, 2022, and for the period ended December 26, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Education Partners, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As further discussed in Note 1 to the financial statements, the trustees of the National Education Partners, Inc. 401(k) Plan made a decision to terminate the National Education Partners, Inc. 401(k) Plan, during the year ended December 31, 2022. As a result, the National Education Partners, Inc. 401(k) Plan is reporting the 2022 and 2023 financial statements under the liquidation basis of accounting. Our opinion is not affected with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

National Education Partners, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the National Education Partners, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

During the year ended December 31, 2019, the Plan executed an amendment that changed the Plan's name from Northcentral University, Inc. 401(k) to National Education Partners, Inc. 401(k) Plan.

General – The Plan is a defined contribution plan covering all employees of National Education Partners, Inc. (or the Company) and Northcentral University (the University) who have three months of service as defined by the Plan and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Company merged with System Management Group (SMG), and all employees of the Company became SMG employees effective January 1, 2022, and are no longer participants in the Plan. Subsequent to this merger, the only employees eligible to participate in the Plan were those employed by the University. The Plan sponsor changed from the Company to the University.

Termination – On July 29, 2022, the trustees of the Plan approved to terminate the Plan, effective October 1, 2022, due to the merger of the University with National University. All participants were fully vested in their account balance as of October 1, 2022, pursuant to terms of the termination plan. The Plan has been terminated effective October 1, 2022. Subsequent to October 1, 2022, no employee contributions, loan payments, or new loans were allowed into or out of the Plan. Participants were required to take a total distribution of their account balance from the Plan no later than January 5, 2023. Participants were allowed to elect a lump-sum cash distribution, an eligible rollover, or a combination of a lump-sum cash distribution and an eligible rollover. The participants who did not make an election by January 5, 2023, had their account balances rolled over to an individual retirement account at Pension Benefit Guaranty Corporation. The Plan was fully liquidated as of December 26, 2023.

Contributions

Participant contributions – Prior to the Plan's termination, each year, participants could elect to make voluntary pretax and Roth contributions of up to 85% of their annual compensation. As of December 3, 2018, new employees were automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan. Employees could elect to change or discontinue deferrals at any time. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan.

National Education Partners, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan (continued)

Employer match and discretionary contributions – Prior to the Plan’s termination, the Company provided a match. The employee contribution and company match were broken down as follows:

Additional profit sharing amounts could have been contributed at the option of the National Education Partners 401(k) Committee, and participants directed the investment of their contributions into various investment options offered by the Plan. There were no profit sharing contributions for the period ended December 26, 2023. The Company contributed \$4,025 to the Plan during the period ended December 26, 2023 to pay expenses related to the termination of the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Vesting – Prior to the Plan’s termination, participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on whole years of service worked by the participant. All employees vest as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1	0%
1 but less than 2	33%
2 but less than 3	66%
3 years of service or more	100%

A participant was one hundred percent (100%) vested when the participant reached the age of 65, is disabled, or upon the participant’s death. The interest of each participant in his/her participant elective deferral, and rollover or transfer account, if any, shall at all times be fully vested and non-forfeitable.

For the purposes of determining a participant’s vested interest under the Plan, the term “year of service” shall mean each 12-month period, measured from the date of hire and ending on the last date of employment. For purposes of determining vesting, all of a participant’s years of service with the Company shall be counted.

National Education Partners, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan (continued)

Participant accounts – Prior to the Plan’s termination, each participant’s account was credited with the participant’s contribution and Company matching and discretionary contributions and plan earnings and charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Notes receivable from participants – Prior to the Plan’s termination, participants could borrow from their fund accounts a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made or 50% of their vested account balance. The loans were secured by the balance in the participant’s account and bear reasonable interest rates, which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were paid ratably through bi-weekly but not less than quarterly payroll deductions. Most loans had to be repaid within five years of the loan date. If a loan was made to purchase a principal residence, it must be repaid over a period not to exceed 30 years.

Payment of benefits – Prior to the Plan’s termination, at termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account; receiving the payment in installments or annuity contracts are also options. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. In certain circumstances, participants could take “hardship withdrawals” as defined in the Plan. Active participants could also take distributions from the Plan upon attainment of age 59½.

Forfeitures – Forfeitures of employer profit sharing contributions, matching contributions, and any excess contributions are used to pay administrative expenses or reduce employer contributions. As of December 26, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$40,750, respectively. Forfeitures of \$45,413 were used to pay plan expenses for the period ended December 26, 2023.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the liquidation basis of accounting.

Use of estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

National Education Partners, Inc. 401(k) Plan Notes to Financial Statements

Note 2 – Summary of Significant Accounting Policies (continued)

Investment valuation – The investments are stated at fair value. The Plan’s trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments. Fair value and liquidation value at December 31, 2022, is considered equivalent. The Plan has no investments at December 26, 2023.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are carried at amortized cost, which represents unpaid principal balance plus accrued-but-unpaid interest and are classified as notes receivable. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2022. As of December 26, 2023, the Plan has no notes receivable from participants.

Payments of benefits – Benefits are recorded when paid.

Expenses – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance; thus, they are not separately disclosed in the accompanying financial statements. Participants are assessed separate fees for the administration of loans and repayments thereof, as well as investment advisory services, and such fees are separately disclosed in the financial statements. All other administrative expenses related to the Plan are paid by the plan sponsor.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through July 19, 2024, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022. As of December 26, 2023, there were no investments held by the Plan.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. The Plan held no investments as of December 26, 2023.

Note 6 – Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2022. There were no investments or notes receivable as of December 26, 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period ended December 26, 2023.

Note 7 – Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid by the Company. Certain mutual funds that were held by the Plan were managed by Fidelity Investments, a related party of the trustee, and are considered parties-in-interest. Investment management fees and notes receivable from participants also reflect party-in-interest transactions. During 2023, fees paid by the Plan for investment management services to Fidelity Investments were \$3,898 for the period ended December 26, 2023.
