## *Independent Auditors' Report*

To the Plan Administrator of the  
R.T.I. Savings and Retirement Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of R.T.I. Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of R.T.I. Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1 - Description of Plan**

The following description of the R.T.I. Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Rainsville Technology, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

Eligibility

Effective September 1, 2022, participation in the Plan is available to all eligible employees of the Company who have three months of service and are age 18 or older, excluding nonresident aliens who do not receive any compensation from U.S. sources, leased employees, or Japanese Nationals and employees who become employees as a result of a Code Section 410(b)(6)(c) transaction, unless and until coverage is extended to employees acquired in such transaction. Prior to September 1, 2022, employees became eligible after three months of service and attaining 21 years of age. Eligible temporary employees must complete one year of service for the Company.

Contributions

*Participant Salary Deferral* - Each year, participants may contribute up to 75% of pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants 50 years old or older during the Plan year are eligible to make catch-up contributions, up to maximum amounts established by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

*Participant Roth Deferral* - Participants may designate some or all of the salary deferral as a Roth Deferral at the time the participant makes his or her deferral election. Once made, the election is irrevocable (that is, a Roth Deferral cannot later be re-characterized as a pretax salary reduction). The amount of the Roth Deferral is included in participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Roth Deferral amount.

*Employer Match* - Each year, the Company may make discretionary matching contributions based on a percentage of the participant's pretax contributions. The Company contributed an amount up to 100% of the first 3% of participant deferral during the year ended December 31, 2022, for a total of \$360,053.

*Employer Profit Sharing* - The employer may also elect to make a discretionary profit sharing contribution based on eligible compensation. A participant must be employed on the last day of the Plan year in order to receive an employer profit sharing contribution for such Plan year. The Company did not make a profit-sharing contribution for the year ended December 31, 2022.

*Qualified Non-Elective* - The Company may also elect to make a qualified non-elective contribution to be allocated to all participants meeting the allocation conditions for qualified non-elective contributions as defined in the Plan Agreement either as a ratio of the participant's compensation to the aggregate of all participants' compensation or as a flat dollar amount determined by the Company. The Company made qualified non-elective contributions of \$12,326 for the year ended December 31, 2022.

Investment Options

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. As of December 31, 2022 and 2021, the Plan offered mutual funds, a guaranteed interest account through a group annuity contract, and separate investment accounts which invest in various mutual funds.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of continuous service. A participant is 100% vested after five years of creditable service.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate which is commensurate with local prevailing rates as determined by the Plan Administrator at the time of issuances, as defined by the Plan. A loan is considered in default if the missed loan payment is not remitted by the end of the calendar quarter following the calendar quarter in which the required payment was due but not made. Principal and interest are paid ratably through payroll deductions, with payments to be made not less frequently than quarterly. Loan terms may not be greater than five years unless the loan is used for purchase of primary residence. A participant may have a maximum of one outstanding loan at any time.

Payment of Benefits

Benefits commence upon one of several dates: retirement, disability, death, or termination of employment. Benefits are distributed by means of either direct rollover, lump sum distribution, or by one of various conventional annuity options. In-service distributions are allowed once a participant reaches eligible age, qualifies for a financial hardship as defined by IRS regulations, or meets the criteria for a qualified reservist distribution.

Forfeited Accounts

As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$96,861 and \$70,937 respectively. These amounts will be used to reduce future employer contributions and Plan expenses. Forfeitures of \$11,530 were used during the year ended December 31, 2022 to reduce Plan expenses.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Guaranteed interest accounts held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies**

Investment Valuation and Income Recognition

The Plan's investments in all of the accounts, except the guaranteed interest account, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed interest account is fully benefit-responsive and is reported at contract value. Contract value represents the accumulated contributions plus accrued net earnings less distributions. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan are allocated to the participant's account, in accordance with the Plan document, and are included in administrative expenses. Fees related to the administration of notes receivable from participants and payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Note 3 - Information Prepared and Certified by Custodian & Trustee**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2022, and net appreciation in fair value of investments, interest, and dividends for the year then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Life & Annuity Insurance Company of New York ("ELAINY") and Empower Trust Company, LLC ("ETC") (the Custodians of the Plan for 2022) and Reliance Trust Company (the Trustee of the Plan for 2022) as of and for the year ended December 31, 2022. Investments held at December 31, 2021 were certified as complete and accurate by Great-West Life & Annuity Insurance Company ("GWLA") and Great-West Trust Company ("GWTC") (the Custodians of the Plan for 2021).

The Custodians also certified to the completeness and accuracy of \$1,404,317 of net depreciation in fair value of investments, \$128,966 of interest and dividend income, and \$20,012 of interest income on notes receivable from participants related to the aforementioned Plan assets for the year ended December 31, 2022. Accrued interest on notes receivable from participants of \$633 is included in the Statement of Net Assets Available for Benefits as of December 31, 2022 and the Statement of Changes in Net Assets Available for Benefits for the year then ended, but was not certified.

**Note 4 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Note 4 - Fair Value Measurements - Continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Separate investment accounts:* Valued at fair value as determined by the Custodian. Fair value includes reinvested dividend and interest income, received and accrued, realized gains and losses and unrealized gains and losses of the underlying assets.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 - Guaranteed Interest Account with Insurance Company**

The Plan has a fully benefit-responsive guaranteed interest account through a group annuity contract with GWLA. GWLA maintains the contributions in a pooled account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. The guaranteed interest account is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by GWLA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Note 5 - Guaranteed Interest Account with Insurance Company - Continued**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6 - Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by ETC and ELAINY. ETC and ELAINY are the Custodians as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the Custodians of \$19,935 during the year ended December 31, 2022 which was not covered by revenue sharing.

Fees incurred by the Plan to the Plan's auditor, Anglin Reichmann Armstrong, P.C., also qualify as party in interest transactions and totaled \$24,217 for the year ended December 31, 2022.

**Note 7 - Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As noted in Note 10, the Plan was terminated subsequent to year-end.

**Note 8 - Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 - Risks and Uncertainties**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10 - Subsequent Event**

Plan Merger and Termination

The Board of Directors of the Company voted in 2023 to approve a merger into the plan of a sister company. The R.T.I. Savings and Retirement Plan transferred all assets to the Moriroku Technology North America Inc. Savings & Retirement Plan (formerly known as the G.T.I. Savings and Retirement Plan 401(k) Plan) as of close of business on July 11, 2023. The Plan was subsequently terminated.

Date of Management's Review

Management has evaluated subsequent events through September 28, 2023, the date which the financial statements were available to be issued.
