## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of the Valence Media 401(k) Plan (the “Plan”) provides only general information. The Plan was formerly known as MRC 401(k) Plan but changed its name effective in 2022. Effective January 1, 2024, the Plan changed its name to StarVista Live, LLC 401(k) Plan, and then effective March 15, 2024, the Plan changed its name again to Eldridge Media Group 401(k) Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan with a 401(k) provision covering all employees of Valence Media, LLC (the “Company” and “Employer”). Employees become eligible to participate upon hire, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Contributions.** Participants may elect to defer up to 100% of eligible annual pre-tax compensation subject to maximum amounts established by the Internal Revenue Code (the “Code”). Additionally, participants may also contribute after-tax (“Roth”) contributions. Participant contribution elections may be changed upon notice to the Plan’s administrator (“Plan Administrator”). Employees are automatically enrolled as a participant with a deferral of 3% of pretax annual compensation upon becoming eligible, unless the employee affirmatively elects otherwise.

The Company may make discretionary Employer matching contributions based on a percentage declared for the period by the Board of Directors. Discretionary Employer matching contributions were 50% of each 1% of employee deferrals for a maximum Employer match of 3% of employee deferrals that totaled \$197,951 for the year ended December 31, 2023. Additional amounts may be contributed at the option of the Company’s board of directors as profit-sharing contributions. Discretionary Employer profit-sharing contributions, if applicable, are allocated as of the last day of the Plan year. There were no discretionary Employer profit-sharing contributions elected for the year ended December 31, 2023.

**Participants’ Accounts.** Each participant’s account is credited with the participant’s contribution and allocation of the Employer contributions, Plan earnings, and expenses. Allocations are based on participant earnings or account balances, as defined in the Plan.

**Investment Options.** Employees may direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to Plan provisions.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant becomes 33% vested after one year of service, increasing by 33% for each additional year of service until year 3 when the participant is 100% vested. Effective February 15, 2022, the vesting policy was amended. All active participants hired on or after February 15, 2021, fully vest after one year of service. All active participants hired on or before February 15, 2021, vest immediately upon amendment. For all terminated participants without an hour of service on or after February 15, 2022, the vesting schedule does not change. However, if an active participant dies or becomes disabled prior to attaining the normal retirement age, the participant’s account becomes 100% vested.

**Notes Receivable from Participants.** Participants may borrow from their accounts a minimum of \$1,000 and up to 50% of their vested account balance, provided that such loan does not exceed \$50,000. The loans are secured by the balance in the participant’s account and bear interest at the local prevailing rates, fixed at the time of issuance, as determined periodically by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

**Forfeited Accounts.** Forfeited balances of terminated participants’ non-vested accounts are used to reduce Plan administrative expenses or future Employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Forfeited nonvested accounts totaled \$295,309 and \$421,270 as of December 31, 2023 and 2022, respectively.

**Forfeited Accounts (Concluded).** In 2023 and 2022, Forfeitures totaling \$115,614 and \$35,589 for the years ended December 31, 2023 and 2022, respectively, were used to offset Plan’s administrative expenses and Employer contributions. See Note 5 for additional 2023 adjustment to the forfeiture balance as related to 2020 partial termination.

**Party-In-Interest Transactions.** Substantially all expenses pertaining to the operation of the Plan are paid by the Company. Additionally, various administrative, legal, and accounting services are performed by Company personnel on behalf of the Plan for which no charges are made to the Plan, and for which the Company does not intend to obtain reimbursement. Investment expenses are charged against the Plan’s investment income. Certain Plan investments are shares of mutual funds managed by a related party to Fidelity Management Trust Company, the “Trustee” of the Plan, and therefore these transactions qualify as party-in-interest transactions.

**Payment of Benefits.** Benefit payments are generally made in a lump-sum upon termination or as defined in the Plan agreement. Early voluntary withdrawals are paid based on financial hardship with approval of the Plan Administrator.

**Recent Legislation.** The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting.** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Estimates and Assumptions.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits.** Benefits are recorded when paid.

**Concentration of Credit Risk.** Substantially all the Plan’s assets are held by the Trustee which is qualified institution pursuant to ERISA.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedules that were prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustee that such information is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- Note 4: All investment balances.
- Investments as shown in the schedules of assets held at end of year as of December 31, 2023, as shown on Form 5500, Schedule H, Part IV, Line 4i.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

**Mutual Funds and Money Market Accounts.** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PLAN TERMINATION**

The Plan currently intends to terminate during August 2024. Accordingly, the accounts of all affected participants have become fully vested.

During 2020, the Company terminated a significant number of participants, partially due to financial strains the industry incurred due to COVID-19. The Company was unable to meet CARES Act Section 209 Relief conditions. The Plan corrected its forfeiture balances during 2023 to properly account for the partial termination. Total effect on the forfeiture balances was a reduction of forfeitures in the amount of \$67,573 during the year ended December 31, 2023.

During 2023, the Company terminated significant number of participants due to winding down its operations. As a result, the Plan experienced another partial termination during 2023. All affected participants were fully vested in their discretionary Employer matching contributions as a result of the partial termination.

**NOTE 6 – TAX STATUS**

The Plan uses a prototype plan document sponsored by the Trustee. The Trustee received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Company remitted participant deferrals and loan repayments totaling \$410,111 to the Trustee later than required by the Department of Labor ("DOL") Regulation 2510.3-102 during the year ended December 31, 2020 ("Late Remittances"). The DOL considers Late Remittances to be prohibited transactions. The Company corrected the 2020 late remittances in 2023. Participant accounts were credited with the amount of investment income which would have been earned had the participant deferrals and loan repayments been remitted on a timely basis. The related excise taxes were also remitted.

**NOTE 9 – SUBSEQUENT EVENTS**

Management has evaluated all known subsequent events from December 31, 2023 through July 1, 2024, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that were not disclosed in the notes to the financial statements.
