Scope and Nature of the ERISA Section 103(a)(3)(C) Audit – Liquidation Basis

We have performed audits of the accompanying financial statements of the AHC Management, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As disclosed in Note 1 to the financial statements, the Plan was formally amended in 2022 to terminate the Plan effective June 30, 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which the net assets available for benefits and changes in net assets available for benefits are stated, to the liquidation basis in presenting the financial statements. Our opinion is not modified with respect to that matter.

1) Plan Description

General

The following description of the AHC Management, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all full-time employees of AHC Management, LLC (the Company). Unless specifically excluded by the Plan, prior to June 30, 2022, all employees of the Company were eligible to participate. Effective November 5, 2018, the Plan was amended to exclude part-time, temporary and seasonal employees who were regularly scheduled to work less than 1,000 hours per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended on June 21, 2022 to terminate the Plan effective June 30, 2022. All contributions to the Plan ceased on that date and all assets were fully liquidated as of December 31, 2023.

Administration

Retirement Planners & Administrators, Inc. (RPA) was engaged to serve as the recordkeeper that processes and maintains the records of participant data. AdvisorTrust, Inc. was engaged to serve as the Custodian. The Company appointed individual trustees to the Plan. The Company served as the Plan administrator. The Plan administrator and individual trustees were responsible for the day-to-day operations and oversight of the Plan.

Participant Contributions

Prior to June 30, 2022, participants could elect to contribute up to 75 percent of their eligible annual compensation, as defined by the Plan, not to exceed the maximum allowable contributions under the Internal Revenue Code (the Code). Roth deferrals were also permitted. A Roth deferral is subject to income tax when contributed to the Plan and is treated as an elective contribution for all purposes under the Plan. The participant's Roth elective contributions were allocated to a separate account maintained for such contributions. Contributions withheld were invested in accordance with the participant's election and could be redirected online at any time. Participants who attained age 50 before the end of the Plan year were eligible to make catch up contributions, subject to limitations imposed by the Code. Participants were permitted to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such rollover contributions were deposited in the appropriate investment funds in accordance with the participant's election and the Plan's provisions.

Company Contributions

As defined in the Plan document, the Company could match a portion of participant contributions on a discretionary basis each payroll period. Through June 30, 2022, the Company matched 100% of the first 2% of eligible compensation and 50% of the next 2% of eligible compensation. Through June 30, 2022, the Company could also make a discretionary profit-sharing contribution to the Plan, to be distributed pro rata based upon compensation.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution, if any, and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined by the Plan.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their accounts and earnings thereon was based on years of continuous service, as defined by the Plan, in accordance with the following vesting schedule:

Due to the termination of the Plan effective June 30, 2022, all participants became 100% vested in Company contributions.

Forfeitures

Forfeited non-vested accounts were used to reduce Company contributions or pay Plan expenses. As of December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$1,578, respectively. During the year ended December 31, 2023, \$1,580 of forfeitures were used to pay Plan expenses.

Payment of Benefits

Benefit payments were available to participants upon retirement (age 65), termination of employment, death, or attainment of age 59½. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant could be withdrawn for a hardship purpose. Participants were entitled to a benefit equal to the vested portion of their account, which would be distributed in the form of a lump sum payment. Distributions were subject to the applicable provisions of the Plan agreement. In addition, upon termination, the Plan allowed for automatic lump sum distributions of participant vested account balances that did not exceed \$5,000. Certain income taxes and penalties applied to withdrawals or distributions prior to age 59 ½. As of December 31, 2023 and 2022, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan and had not received such distributions prior to year-end.

Notes Receivable from Participants

Participants could borrow not less than \$1,000 and up to the lesser of \$50,000 or 50 percent of their vested account balance. The notes were secured by the participant's vested account balance and no more than one outstanding note was permitted at any time. Such notes bore interest at one percent above the prime rate at the time of note origination and were to be repaid to the Plan within a period of five years unless the note was used to purchase a principal residence. The specified terms and conditions of such notes were established by the Plan administrator. Principal and interest were paid ratably through payroll deductions. Effective January 1, 2022, the Plan was amended to no longer allow new loans to be taken from the Plan. All remaining notes receivable from participants at the date of Plan termination were deemed distributed and included in benefits paid to participants during the year ended December 31, 2022.

2) Summary of Significant Accounting Policies

Basis of Accounting

As a result of the termination of the Plan effective June 30, 2022, the Plan's financial statements are presented using the liquidation basis of accounting as of December 31, 2023 and 2022 and for the year ended December 31, 2023 in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. If a participant ceased to make note repayments and the Plan administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment was recorded based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Plan administration and recordkeeping fees were paid by the Plan and were included in administrative expenses. Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Fees related to specific participant transactions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3) Investments

All investment information disclosed in the accompanying financial statements – liquidation basis, including assets held at December 31, 2023 and 2022, interest and dividend income and net appreciation in fair value of investments for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by AdvisorTrust, Inc., the Custodian of the Plan.

4) Fair Value Measurements

The framework for measuring fair value, Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2

Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds

Valued at quoted market prices in an exchange and active market.

The Plan had no investments as of December 31, 2023.

5) Related-Party and Party-in-Interest Transactions

The Plan investments were managed by AdvisorTrust, Inc., the Custodian of the Plan. The Plan allowed participants to take out notes against their vested account balances. The Company provided certain accounting and administrative services to the Plan for which no fees were charged. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6) Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. As disclosed in Note 1, the Plan was amended effective June 30, 2022 to terminate the Plan. Accordingly, participant accounts became fully vested and non-forfeitable at the termination date.

7) Tax Status

The Plan adopted a pre-approved prototype plan document that received an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the Plan document was acceptable under the applicable requirements of the Code. The Plan was amended since the date of the opinion letter, however, the Company believes that the Plan was designed, and operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt. As such, no provision for income taxes has been included in the Plan’s financial statements. Management believes there are no uncertain tax positions requiring recognition in the financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan was tax exempt and had no unrelated business taxable income, the provisions of ASC 740 did not have an impact on the Plan’s financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan did not have any amounts accrued relating to interest and penalties as of December 31, 2023 and 2022.

The Plan is subject to routine audits by the IRS and Department of Labor (DOL); however, there are currently no audits in progress for any open periods.

8) Risks and Uncertainties

The Plan invested in various investment securities that were exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – liquidation basis.

9) Subsequent Events

Management has evaluated events and transactions for potential recognition or disclosure through May 20, 2024, the date the financial statements were available to be issued. There were no material events that required recognition or disclosure in the financial statements.

10) Other Company Contributions

During the year ended December 31, 2022, it was determined that the Plan did not use the proper definition of compensation when calculating deferrals and corrections totaling \$5,483 were required to be made to participant accounts. In addition, it was determined that the Plan did not withhold deferrals on vacation payouts. The Company calculated the corrections, plus lost earnings, totaling \$14,499. These amounts are included as other Company contributions receivable as of December 31, 2022.

The Company made the necessary corrections to all the affected participants' accounts during 2023.



