Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mid-States Aluminum Corp. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

As discussed in Note 1 to the financial statements, management of Mid-States Aluminum Corp. 401(k) Profit Sharing Plan & Trust approved a plan of liquidation on June 30, 2023, and management determined liquidation is imminent. As a result, Mid-States Aluminum Corp. 401(k) Profit Sharing Plan & Trust has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1: Description of Plan

The following description of the Mid-States Aluminum Corp. 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination

On June 30, 2023, the Company communicated to all participants its intent to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), with a termination date of June 30, 2023. During 2023, the plan assets were fully liquidated and final distributions were made to participants in accordance with participant directives or to a separate retirement account for those who did not respond. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting to value plan assets on the liquidation basis for the year ended December 31, 2023. This change had no effect on the reported net assets available for benefits.

General

The Plan was a defined contribution plan that covered substantially all employees of Mid-States Aluminum Corp. (the "Company") who were over the age of 18, had completed 60 days of employment, and were not considered leased employees or covered under a collective bargaining agreement. Temporary or seasonal employees had to attain age 18 and have completed one year of service to become eligible to participate in the Plan. The Plan was subject to the provisions of ERISA, as amended.

Management of the Company was responsible for the oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Eligibility

Eligible employees entered the Plan on the first day of the month coinciding with or next following the date they satisfied the eligibility requirements for purposes of employee deferral, as well as Company discretionary matching contributions and additional discretionary profit sharing contributions.

To be eligible for the Company's discretionary matching and profit sharing contributions, employees had to be over the age of 18, employed on the last day of the plan year, and had completed at least 1,000 hours of service during the plan year.

Note 1: Description of Plan (Continued)

Contributions

Each year, participants could contribute to the Plan up to 100% of annual compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits by the IRS. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan also included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan or elected an alternate deferral rate. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The amount of such automatic enrollment increased 0.5% per year up to a maximum of 50% of compensation, unless an alternate deferral rate was elected by the participant. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company could make a discretionary matching and discretionary profit sharing contributions to the Plan. Rollover contributions were not matched. For the year ended December 31, 2023, the Company made discretionary matching contributions equal to 40% of participant contributions to the Plan. The Company did not make any discretionary profit sharing contributions for 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's discretionary matching contributions and allocations of (a) the Company's discretionary profit sharing contributions, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts were reduced by withdrawals and were charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Prior to the plan termination, the Company's discretionary matching and discretionary profit sharing contributions and actual earnings thereon vested at a rate of 20% each year beginning with the second year of service. Participants became fully vested after six years of service, or upon death or disability.

Upon plan termination on June 30, 2023, all participants became fully vested in the Company's discretionary matching and discretionary profit sharing contributions, and actual earnings thereon.

Forfeitures

Plan forfeitures arose as a result of participants terminating service with the Company before becoming 100% vested in the Company's contributions. There were no forfeited nonvested accounts at December 31, 2023. Forfeited nonvested accounts totaled \$674 at December 31, 2022. Forfeitures could be used to reduce Company contributions or pay plan expenses. For the year ended December 31, 2023, plan expenses were reduced by \$4,994 from forfeited nonvested accounts.

Payment of Benefits

Plan benefits were available at termination due to normal retirement (age 65), disability, death, and termination of employment with vested interests. Participants could elect to receive benefit payments in the form of a lump-sum distribution or in installments. The Plan also allowed for in-service distributions upon attaining age 59 1/2 if the participant was fully vested. Participants could withdraw amounts from their rollover accounts at any time.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). As discussed in Note 1, the Plan was terminated effective June 30, 2023. Accordingly, the 2023 financial statements are presented on the liquidation basis and the 2022 financial statements are presented on the going concern basis.

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may have differed from these estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to benefit payments were charged directly to the participant's account and were included in administrative expenses. Certain investment-related expenses were allocated proportionately to plan participants based on their respective account balances and were included in net appreciation in fair value of investments. All other expenses paid by the Plan were allocated proportionately to plan participants based on their respective account balances and were included in administrative expenses.

The Plan received revenue sharing income from the Plan's investments in certain mutual funds, which was included in net appreciation in fair value of investments. Revenue sharing income of \$0 at December 31, 2023, and \$2,566 at December 31, 2022, was included in investments on the statements of net assets available for benefits, which was used to offset future administrative expenses. For the year ended December 31, 2023, \$2,643 of revenue sharing income was used to offset administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through July 22, 2024, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There are no assets measured at fair value as of December 31, 2023, due to the plan termination during 2023, as discussed in Note 1.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and non-interest-bearing cash held at December 31, 2022, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank ("Charles Schwab"), the custodian of the Plan.

Note 5: Tax Status

The Plan had adopted a non-standardized pre-approved plan document with an IRS determination letter dated June 30, 2020, which stated the non-standardized pre-approved plan document was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and had no income subject to unrelated business income tax. Therefore, no provision for income taxes was included in the Plan's financial statements.

Note 6: Party-in-Interest Transactions

Nyhart was the recordkeeper, as defined by the plan document; therefore, transactions with Nyhart qualified as party-in-interest transactions. The Plan paid Nyhart \$75,249 in fees during 2023. National Exchange Bank and Trust ("NEBAT") was the investment advisor and trustee, as defined by the plan document; therefore, transactions with NEBAT qualified as party-in-interest transactions. The Plan paid NEBAT \$29,821 in fees during 2023.

Certain fees incurred by the Plan for investment-related expenses were included in net appreciation in fair value of investments, since they were paid through revenue sharing rather than a direct payment.
