As a result, the Plan changed its basis of accounting from the on-going basis of accounting used in the presentation of the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ## **Note 1: Description of Plan**

The following description of Ornua (Whitehall) Ingredients, Inc. d/b/a Ornua Ingredients North America Employee Savings & Retirement 401(k) Plan) (f/k/a Whitehall Specialties Employee Savings and Retirement 401(k) Plan) (the "Plan") provides only general information. The description is for the time period through the transfer of all assets to the successor Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all full-time employees of Ornua Ingredients, Inc. (formerly known as Whitehall Specialties, Inc.) (the "Company") who are in a covered employment classification, have attained age 18, and have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In October 2021, Ornua Ingredients, Inc. purchased Whitehall Specialties, Inc. Effective December 30, 2022, the Company merged Whitehall Specialties Employee Savings and Retirement 401(k) Plan (Whitehall) into the Ornua North America 401(k) Plan (Ornua). This resulted in a short plan year beginning January 1, 2022, and ending December 30, 2022.

### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a discretionary matching contribution that is based on the participant's total compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. For the period ended December 30, 2022, the Company contributed up to 4% of a participant's eligible wages based on a tiered matching formula. During the period ended December 30, 2022, the Company agreed to contribute matching contributions of \$519,428. Payment of the matching contribution is scheduled subsequent to year end to the Ornua North America 401(k) Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## Note 1: Description of Plan (Continued)

### Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions and allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of a participant's account is based on the number of years of service.

Company contributions vest according to the following schedule:

1 year	0 %
2 years	25 %
3 years	50 %
4 years	75 %
5 years or more	100 %

### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 7.00%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions are permitted if certain criteria are met. Effective January 1, 2020, suspension of contributions is no longer required if hardship distributions are taken, in accordance with applicable law and IRS guidance. The Plan also allows for in-service distributions upon attaining age 59 1/2.

## **Note 1: Description of Plan (Continued)**

### **Forfeitures**

At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$18,550, respectively. These accounts were used to reduce future Company contributions or used to pay administrative expenses of the Plan in accordance with the Plan document. Forfeitures in the amounts of \$42,523 were used to pay administrative expenses, \$17,688 to reduce Company matching contributions, and \$6,258 were transferred to the Ornua Plan for the period ended December 30, 2022.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

As discussed in Notes 1 and 6, the Plan was terminated effective December 31, 2022. In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis. The change to the liquidation basis had no material impact on the accompanying financial statements.

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **Note 2: Summary of Significant Accounting Policies (Continued)**

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 30, 2022 or December 31, 2021. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in administrative expenses.

### **Subsequent Events**

The Plan has evaluated subsequent events through October 11, 2023, which is the date the financial statements were available to be issued.

## **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trusts (CIT):* Fair value is estimated using the NAV per unit by the issuer of the CIT. Fair value is based on the fair value of underlying investments held by the CIT.

*Mutual funds held in pooled separate accounts:* Fair value is estimated using the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

**Note 4: Information Prepared and Certified by the Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 30, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest income from notes receivable, and interest and dividends for the period ended December 30, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company (the "Trustee" of the Plan).

**Note 5: Tax Status**

The Company adopted a non-standardized, pre-approved Plan document with an IRS opinion letter, which states the Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **Note 6: Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 30, 2022, the Company merged Whitehall Specialties Employee Savings & Retirement 401(k) Plan into the Ornua North America 401(k) Plan. As part of the merger, all Plan assets of the Whitehall Plan were transferred into the Ornua Plan.

## **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 8: Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the Trustee, as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services for the period ended December 30, 2022, are included in administrative services.

Transamerica Life Insurance Company is the third-party administrator of the Plan. Fees incurred and paid for recordkeeping services are included in administrative expenses.

Fees incurred and paid by the Plan for investment management services from Independent Financial Partners for the period ended December 30, 2022, are included in administrative expenses.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
