We have performed audits of the financial statements of Salo, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 11, 2023 (liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through December 11, 2023, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Emphasis of Matter - Termination Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Plan was terminated effective January 31, 2023. As a result the Plan changed its basis of accounting from going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting in presenting the period from January 1, 2023 through December 11, 2023 financial statements. Our opinion is not modified with respect to this matter.

## Salo, LLC 401(k) Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Salo, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan adopted by Salo, LLC (the Company). Salo, LLC was acquired by Korn Ferry, effective February 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The board of trustees is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's board of trustees.

The Plan was amended and restated effective October 27, 2021.

#### **Plan Termination**

During 2023, Plan participants were notified that the Plan would be terminated effective January 31, 2023, and contributions to the Plan would cease and all assets would be distributed as soon as administratively possible, due to the sale of the Company. All participants became fully vested upon termination. Distributions from the Plan, including residual dividends and appreciation occurred through December 11, 2023.

#### **Eligibility**

Employees are eligible to make salary deferral contributions and participate in Company-sponsored discretionary matching and discretionary nonelective contributions on the first entry date after completing one month of service and attaining age 21. Entry dates are the first day of each calendar month. The Plan provides for automatic enrollment at 6% of eligible compensation once eligibility requirements are met. Participants must notify the Record Keeper to modify the automatic enrollment.

#### **Contributions**

Participants may elect pre-tax salary deferral contributions of at least 1%, up to a maximum of 100% of their salary, subject to certain Internal Revenue Code (IRC) limits. Roth 401(k) deferrals are also permitted. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 for the period ended December 11, 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows rollover contributions from other qualified plans. The Company's matching contributions to the Plan are a discretionary percentage of a participant's salary deferrals determined each year. In addition, the Company may contribute a discretionary nonelective contribution amount determined each year. Participants must earn at least 1,000 hours of service during the Plan's year and must be employed on the last day of the Plan's year end to receive an allocation of Company contributions, unless due to death, disability or having reached normal retirement age. The Company did not make any discretionary contributions during the Plan period from January 1, 2023 through December 11, 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary nonelective contribution and discretionary matching contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. Participants vest 25% per year starting after year one with 100% vesting occurring after completing four years of service, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age 65.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes must be repaid in five years. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Vested benefits of \$5,000 or less are distributed in a single lump-sum as soon as practicable after the event occurs that entitles a participant to a distribution. Vested benefits that exceed \$5,000 are distributed in a single lump-sum after the event occurs that entitles a participant to a distribution and after the participant has requested such distribution. Hardship distributions are also allowed from the participant's contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared under the liquidation basis of accounting for the period ended December 11, 2023, and ongoing basis of account as of December 31, 2022.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income (Loss) Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 4 for discussion of fair value measurements.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income (Loss) Recognition (Continued)**

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2022. The Plan assets were \$0 as of December 11, 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed in 2022 excess contributions to the applicable participants during 2023. No contributions in excess of amounts allowed by the Internal Revenue Service were recorded as a liability as of December 11, 2023, as the Plan assets were \$0.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Plan Expenses**

Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - CERTIFICATIONS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 11, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through December 11, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan). The Plan assets were \$0 as of December 11, 2023.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022. The Plan assets were \$0 as of December 11, 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

*Stable value collective trust fund:* Composed primarily of fully benefit-responsive investment contracts and is reported at fair value using net asset value (NAV) as a practical expedient. The stable value fund calculates NAV per share in a manner consistent with the measurement principles in FASB Accounting Standards Codification Topic 946, Financial Services - Investment Companies. Those measurement principles indicate that, in the determination of a stable value fund's NAV, the relevant measurement is net assets which include the fully responsive benefit investment contracts held by the fund at contract value. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are share of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions but are not prohibited transactions as defined by ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 6 - TAX STATUS**

The Company adopted a volume submitter plan sponsored by Fidelity Management Trust Company. The volume submitter plan sponsor obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that for the period from January 1, 2023 through December 11, 2023 and the year ended December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 24, 2024, the date which the financial statements were available to be issued.
