### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of DNB Holdings, Inc. 401(k) Plan and Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended December 31, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of DNB Holdings, Inc. 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and December 31, 2022, and for the period then ended December 31, 2023 and year then ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, Plan Trustees, elected on September 14, 2023, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about DNB Holdings, Inc. 401(k) Plan and Trust's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## **Note 1. Description of Plan**

The following description of DNB Holdings, Inc. 401(k) Plan & Trust (fka Ray's Holdings, Inc. 401(k) Plan & Trust) (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

### **General**

The Plan was a defined-contribution plan, which was sponsored by DNB Holdings, Inc. (fka Ray's Holdings, Inc.) (Company), for the benefit of its full-time employees who had one year of service and were age 18 or older. The wholly owned subsidiaries of the Company who participated in the Plan include DNB Trash Service, Inc. (fka Ray's Trash Service, Inc.); DNB, LLC (fka Ray's, LLC); and Ray's Demolition, LLC. Another participating employer of the Plan was Farnsworth Metal Recycling, LLC. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). John Hancock Life Insurance Company (John Hancock) served as the Plan's custodian, The Rose Financial Group served as the Plan's recordkeeper, and members of management served as the Plan's trustees.

Effective September 8, 2022, the Company and participating employers names were changed as a result of the sale of these companies to Waste Management of Indiana, LLC on August 31, 2022. Approximately 560 employees were terminated, effective August 31, 2022, resulting in a partial plan termination of the Plan as of December 31, 2022 and those participants became 100% vested in their account.

On September 14, 2023, the Plan Trustees elected to terminate the Plan by December 31, 2023 and all assets distributed on December 21, 2023. The last payroll deposit of contributions to the Plan was November 20, 2023 pay date, thirty days before discontinuance date.

### **Contributions**

The Plan permitted eligible employees, through a salary reduction election, to make annual contributions based on a percentage of eligible compensation up to the maximum allowed by law. Employee rollover contributions were also permitted. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Company could make discretionary matching and profit-sharing contributions determined at the end of the Plan year by the Company's Board of Directors. The Board of Directors elected to make a matching contribution of 25% of the participant's deferral on the first 5% of the participant's eligible compensation for the years ended December 31, 2023 and 2022. Contributions were subject to certain limitations.

### **Participant Investment Account Options**

Investment account options available included various funds. Each participant had the option of directing his contributions into any of the separate investment accounts and could change the allocation daily.

### **Participant Accounts**

Each participant's account was credited with the participant's contribution, the Company's contribution and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant is entitled was the benefit that could be provided from the participant's vested account.

***Vesting***

Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Prior to the partial Plan termination and full Plan termination, vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of credited service. A participant was fully vested in discretionary matching and profit-sharing contributions after three years of credited service. The nonvested balance was forfeited upon termination of service and were used by the Plan Sponsor to first pay administrative expenses and then to reduce any employer contributions. With the partial Plan termination and full Plan termination, all participants became 100% vested in all portion of their account.

***Payment of Benefits***

Upon termination of service, participants could elect to receive or defer a lump-sum amount equal to the value of their account. Withdrawals other than for termination were permitted under certain circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2022, forfeited nonvested accounts totaled \$8,679. \$7,916 of these forfeitures were used to make vesting error corrections during 2023. \$763 of forfeitures were used to pay Plan expenses during 2023. Forfeitures of approximately \$338 were used to offset Company contributions during 2022.

***Notes Receivable From Participants***

Participant loans were not permitted by the Plan.

***Plan Termination***

As noted above, there was a partial plan termination that occurred as of August 31, 2022 due to the sale of certain of the companies participating in the Plan and then the Plan trustees elected on September 14, 2023 to terminate the Plan by December 31, 2023 and participants all became 100% vested in their accounts on that date.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Pooled separate accounts were valued at estimated fair value as provided by John Hancock, utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year.

The stable value fund account represented participation in units of the John Hancock stable value fund collective investment trust which the underlying investment invests primarily in fully benefit-responsive investment contracts and generally honors eligible redemptions at \$1.00 per unit. The underlying investments were valued at net asset value based on their fair value. Certain trade restrictions could be imposed on this account, including, but not limited to, redemption fees and the number, dollar amount, and method of exchanges. Competing funds could not be elected by participants.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operated under a nonstandardized profit-sharing adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by The Rose Financial Group, LLC. The Plan had not submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document had received a favorable opinion letter from the IRS. The Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

***Administrative Expenses***

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The Plan Administrator had elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, had certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate based on the records they maintain:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2022
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the period ended December 21, 2023 and year ended December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Assets**

Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurement must maximize the use of observable inputs and minimize the use of unobservable inputs. There was a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the period ended December 21, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices were available in an active market, securities were classified within Level 1 of the valuation hierarchy. There were no Level 1 securities held by the Plan. If quoted market prices were not available, then fair values were estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Level 2 securities included pooled separate accounts and were valued as described in Note 2. In certain cases where Level 1 or Level 2 inputs were not available, securities were classified within Level 3 of the hierarchy. There were no Level 3 investments held by the Plan.

### **Note 5. Party-in-Interest Transactions**

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invested in certain funds of the Plan custodian. During 2023 and 2022, the Plan paid fees to John Hancock of \$24,210 and \$41,879, respectively. Fees paid to Edward Jones as investment advisor totaled \$13,687 and \$24,965 during 2023 and 2022, respectively. The Plan paid Rose Financial for recordkeeping fees of \$9,150 and \$8,523 during 2023 and 2022, respectively. The Company provided certain administrative services at no cost to the Plan.

### **Note 6. Nonexempt Transactions**

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$294 were not remitted within the required time period for the year ended December 31, 2022.

### **Note 7. Subsequent Events**

Subsequent events have been evaluated through July 18, 2024, which is the date the financial statements were available to be issued.
