The merger of assets was completed in September 2023. Our opinion has not been modified with respect to this matter.

1. Plan Description

The following brief description of the Bryan Hospital Kearney dba Kearney Regional Medical Center Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of Kearney Regional Medical Center (the Company). Effective January 1, 2022, the Plan sponsor was changed to Bryan Hospital Kearney dba Kearney Regional Medical Center and the name of the Plan was changed to Bryan Hospital Kearney dba Kearney Regional Medical Center Retirement Plan.

In November 2022, the Board of Directors of the Company voted to merge the Plan into the Bryan Health Retirement Savings Plan (Bryan Health Plan). Union Bank & Trust Company is the custodian of the Bryan Health Plan. The merger into the Bryan Health Plan initiated a "black out" period which initiated on December 31, 2022 and went through the date of the initial transfer which occurred in early January 2023. During the black out period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the Bryan Health Plan until Union Bank & Trust Company had time to accurately complete the merger. Plan assets totaling \$30,915,924, including notes receivable from participants, were transferred into the Bryan Health Plan in January 2023. The remaining assets of the Plan totaling \$3,427,328 were transferred into the Bryan Health Plan in September 2023. Plan participation was frozen effective December 31, 2022 and the participants began making payroll contributions to the Bryan Health Plan in January 2023.

Employees were eligible to make pre-tax and designated after-tax Roth salary reduction contributions on the first day of the month after attaining 21 years of age and completing six months of service. Participants were also eligible to receive fixed and discretionary matching contributions, safe harbor contributions and discretionary profit-sharing contributions. Participants were eligible for discretionary matching and profit-sharing contributions following one year of service with at least 1,000 hours worked and were employed on the last day of the contribution period to receive an allocation of the Company's contribution.

Contributions

Participants could elect to defer up to 100% of their annual compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants could also contribute amounts representing distributions for other qualified plans. All employees were automatically enrolled with a 4% deferral contribution once they became eligible for the Plan. Six months after auto-enrollment or elective deferral, the employee's deferral rate would be increased by one percentage point until it reached a total of 8% of their eligible salary. At any time, a participant could elect not to contribute or could increase or decrease his or her deferral rate. The Company made a safe harbor contribution of 3% of eligible compensation as well as a matching contribution of 25% of participant deferrals up to 1% of compensation. The Company could also make discretionary matching and

profit-sharing contributions. Participants who were eligible to make deferral contributions and who had attained age 50 before the close of the calendar year were eligible to make catch-up contributions. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of a) the Company's discretionary matching contributions, safe harbor contributions, and discretionary profit-sharing contributions, b) Plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions were allocated among participants based upon each eligible participant's elected salary deferral. The Company's safe harbor contributions and discretionary profit-sharing contributions were allocated based on the eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by each participant. Investments were maintained in individual member accounts managed by Transamerica Life Insurance Company (Transamerica), an affiliate of State Street Bank and Trust Company.

Vesting

Participants were vested immediately in their participant contributions and safe harbor contributions plus actual earnings thereon. All other employer contributions were credited to participants' accounts based on years of continuous service. Participants were 25% vested after two years of service, and vesting increased 25% per year until a participant was fully vested after five years of service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants were secured by the balance in the participant's account and bear interest at rates that commensurate with local prevailing rates. A participant could not have more than one loan outstanding at any time. The term of the notes receivable from participants was limited to five years, unless the loan was for the purchase of a primary residence, in which case a longer term could be permitted. All principal and interest payments had to be made monthly through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary could receive a lump sum payment equal to the value of the vested funds allocated to the participant's account. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Distributions under \$1,000 would be paid out in a lump sum to the participant in the event the participant did not elect a payout option. Participants could also receive hardship and in-service distributions, as permitted in the Plan document. Benefits were recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested would be forfeited. The forfeited portion of any participant's account could be used to reduce Company contributions or to pay Plan expenses. As of September 30, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0. During the period from January 1, 2023 to September 30, 2023 and year ended December 31, 2022, forfeitures of \$0 and \$55,311, respectively, were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for fully benefit-responsive investment contracts, which were reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determined the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invested in investment contracts through a guaranteed interest account.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through May 22, 2024, noting no items requiring disclosure.

3. Information Certified by Transamerica

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Transamerica, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan’s financial statements.

4. Fair Value Measurements

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2023 and 2022.

Cash Reserve Account and Money Market Account: Valued at the daily closing price as reported by the fund and are classified in Level 1 of the fair value hierarchy. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of September 30, 2023.

5. Investment Contract with Insurance Company

The Plan had entered into an investment contract with Transamerica. Transamerica maintained the contributions in a guaranteed interest account. The account was credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Transamerica.

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations could be affected by future economic developments. The guaranteed interest account had certain restrictions on liquidation. The restrictions lapsed in September 2023, at which time, \$3,427,328 was transferred to the Bryan Health plan as the final step in the plan merger.

6. Tax Status

The Plan was qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. Related-Party Transactions

Certain Plan investments were a guaranteed interest account managed by Transamerica. Transamerica was the custodian of the Plan; therefore, this transaction qualified as a party-in-interest transaction.
