NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 29, 2022 AND DECEMBER 31, 2021

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Valuentric, LLC (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established effective January 1, 2009, and was amended, most recently, on January 1, 2017.

Contributions

Each year, participants may contribute up to applicable IRS limits of annual compensation, as defined in the Plan. The Company contributes safe harbor matching contributions. The Company also may make a discretionary employer profit sharing contribution. For the Plan's period and year ended September 29, 2022 and December 31, 2021, the Company made matching safe harbor contributions of \$0 and \$191,184, respectively. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's safe harbor match contribution and Plan earnings (losses). Allocations are based on participants' compensation, deferrals, or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor match contributions, plus actual earnings thereon. Vesting of the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five or more years of credited service.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 29, 2022 AND DECEMBER 31, 2021

NOTE A - DESCRIPTION OF THE PLAN (Continued)***Notes Receivable from Participants***

Participants may borrow, from their fund accounts, up to a minimum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund to (from) the participant notes fund. Each loan is secured by the balance in the participant's account.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum payment or installments equal to the value of the participant's vested interest in his/her account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***Forfeited Accounts***

Forfeited non-vested amounts are to be used by the Company to reduce any future employer contributions. There was \$0 and \$355 in forfeited non-vested accounts at the period and year ended September 29, 2022 and December 31, 2021, respectively.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value, as reported by Principal Life Insurance Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Participant notes receivable are valued at cost, which approximates fair value.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 29, 2022 AND DECEMBER 31, 2021

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)***Investment Valuation and Income Recognition*** (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 29, 2022 and December 31, 2021.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 29, 2022 AND DECEMBER 31, 2021

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Pooled Separate Accounts

These investments are public investment vehicles values using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets of the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is classified within Level 2 of the valuation hierarchy.

Subsequent Events

Management has evaluated the effect of subsequent events on these financial statements through November 14, 2023, the date the financial statements were available to be issued. See Note I - Risks and Uncertainties for further information.

NOTE D - GUARANTEED INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contract in the amounts of \$0 and \$1,008,229 at September 29, 2022 and December 31, 2021, respectively, that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment. The contract issuer, Principal Life Insurance Company, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Principal Life Insurance Company. Examples of such events include the following:

1. Plan termination or merger.
2. Plan amendments or operation of the Plan in a manner which is unacceptable to issuer.
3. The Plan fails to qualify or becomes disqualified under Code Section 401(a).
4. Total amount of contributions received in the preceding 12 months is less than \$25,000.
5. The sum of all Participant Annuity Account Values falls below \$25,000.
6. Premature termination of the contract.

The Plan considers that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE E - PLAN TERMINATION

On December 16, 2021, the Company entered into an agreement to sell or merge certain assets, shares or ownership rights of Valucentric, LLC., (the “Transferor Company”), to Opteon AMC, Inc., (the “Purchaser Company”). As a result of the agreement, the Valucentric, LLC 401(k) Plan will be transferred to the Purchaser Company’s plan, CBR Management Services, Inc., 401(k) Plan, as soon as administratively possible. As of December 31, 2021, the Valucentric, LLC 401(k) Plan had not been transferred into CBR Management Services, Inc., 401(k) Plan. See Note L regarding the transfer of the plan assets.

NOTE F - TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt. The Plan’s Form 5500 information returns are subject to examination by the Department of Labor generally for three years after filing. Management has evaluated the tax positions taken and there are no uncertain tax positions that qualify for either recognition or disclosure in the financial statements.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 29, 2022 AND DECEMBER 31, 2021

NOTE G - ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in the administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

NOTE H - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at September 29, 2022 and December 31, 2021, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 29, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the custodian of the Plan).

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2022 statements of assets available for benefits.

NOTE J - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain trustees of the Company are participants of the Plan, Principal Life Insurance Company is the custodian of the Plan assets as defined by the Plan and, therefore, administrative fees provided to Principal Life Annuity Company qualify as party-in-interest transactions. Prime Benefits, Inc. is the third-party administrator. They earn certain transaction fees that are paid by the Plan, and therefore these transaction fees qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping services provided by Principal Life Insurance Company totaled \$5,626 for the period ended September 29, 2022.

NOTE K - TRANSFER OF ASSETS

Effective December 31, 2020, the Plan changed investment platforms from Great-West Life & Annuity Insurance Company to Principal Life Insurance Company. All 2021 contributions were deposited with Principal Life Insurance Company, and all assets transferred, and the account closed with Great-West Life & Annuity Insurance Company on May 4, 2021.

NOTE L - SUBSEQUENT EVENT-TRANSFER OF PLAN ASSETS AND TERMINATION OF PLAN

On September 27, 2022, all the assets of the Valucentric, LLC 401(k) Plan were transferred into the CBR Management Services, Inc., 401(k) Plan. As a result, on September 27, 2022, the assets of the Valucentric, LLC 401(k) Plan were zero and the plan terminated, with September 29, 2022, as the date of the final audit.
