***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Spin Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended, December 31, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Spin Systems, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

***Opinion***

***Basis for Opinion***

**Note 1 - Description of the Plan**

The following description of the Spin Systems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Spin Systems, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan.

Eligibility

Participation in the Plan is available to all eligible employees of the Company and affiliates who are age 21 or older and have completed a service requirement of 30 days, excluding non-resident aliens and independent contractors or employees of independent contractors, as defined by the Plan.

Contributions

*Participant Salary Deferral* - Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants 50 years old or older during the Plan year are eligible to make catch-up contributions, up to the maximum amounts established by the IRS. Participants made pretax contributions of \$1,514,527 for the year ended December 31, 2023.

Unless a participant makes an alternative salary deferral election, the employer will automatically withhold 6% of the participant's compensation from the participant's pay each payroll period and contribute that amount to the Plan as a salary deferral. This amount will increase each January 1 by 1% up to a maximum of 10% or until the participant makes an affirmative election of the rate the participant wishes to contribute. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

*Participant Roth Deferral* - Participants may designate some or all of the salary deferral as a Roth Deferral at the time the participant makes his or her deferral election. Once made, the election is irrevocable (that is, a Roth Deferral cannot later be re-characterized as a pretax salary reduction). The amount of the Roth Deferral is included in the participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Roth Deferral amount. Participants made Roth contributions of \$319,597 for the year ended December 31, 2023.

*Employer Discretionary Match* - Each year, the Company may make discretionary matching contributions based on a percentage of the participant's salary and Roth deferrals. In 2023, the Company contributed to the Plan an amount equal to 50% of the participants' contributions that are not in excess of 6% of the participants' compensation. The Company made a discretionary match of \$554,985 to the Plan for the year ended December 31, 2023.

Investment Options

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. As of December 31, 2023 and 2022, the Plan offered multiple pooled separate accounts and registered investment companies which all invest in various combinations of stocks, bonds, and other investment securities, and a guaranteed investment contract. The fair value is based on the underlying investments, which include common stock, registered investment companies, and cash.

Vesting

Participants are vested immediately in their voluntary contributions and the Company's discretionary match contributions, plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Recordkeeper at the time of issuances, as defined by the Plan. A loan is considered in default if the missed loan payment is not remitted by the end of the calendar quarter following the calendar quarter in which the required payment was due but not made. Principal and interest are paid ratably through payroll deductions, with payments to be made not less frequently than quarterly. Loan terms may not be greater than five years unless the loan is used for purchase of primary residence. A participant may have a maximum of one outstanding loans at any time.

Payment of Benefits

Benefits commence upon one of several dates: retirement, disability, death, or termination of employment. In-service distributions are allowed once a participant reaches eligible age or qualifies for a financial hardship as defined by IRS regulations. Benefits are distributed by means of either direct rollover, lump sum distribution, or by one of various conventional annuity options.

**Note 2 - Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Guaranteed interest accounts held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments, except investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment in the guaranteed investment contract is reported at contract value. See Note 4 for discussion of fair value measurements. Interest income is recorded on the cash basis. Dividend income is recorded on the ex-dividend date.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recognized when paid generally in accordance with the Company's payroll schedule. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan are allocated to the participant's account, in accordance with the Plan document, and are included in administrative expenses. Fees related to the administration of payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses.

Investment related expenses are paid in part by the participant and charged to the participant's account and are included in administrative expenses while the remainder is included in net appreciation (depreciation) of fair value of investments.

**Note 3 - Certified Investments**

Certain information related to investments and disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, net appreciation (depreciation) in fair value of investments, and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company (the trustee of the Plan).

**Note 4 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Shares of registered investment companies (Mutual funds):* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. The registered investment companies held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV based on the fair value of the underlying investments held in such separate account as determined by the Trustee using generally accepted accounting practices and applicable law. The majority of the underlying securities are mutual funds. The NAV of the PSAs are not publicly quoted but are available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSAs can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies.

**Note 5 - Guaranteed Investment Contract with Insurance Company (Unaudited)**

The Plan's investments include a benefit-responsive guaranteed contract with Principal Life Insurance Company. The Principal Fixed Income Guaranteed Option is a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company to Principal Trust Company as custodian. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The accounts are included in the financial statements at fair value. If the current interest rate is equal to or less than the interest rate on the accounts, the fair market value is equal to the contract value. If the current interest rate is greater than the interest rate on the accounts, the fair market value is the contract value reduced by a percentage. The percentage is equal to the difference between the current interest rate and the interest rate on the accounts, multiplied by the number of years (including fractional parts of a year) until the maturity date. Fair value represents contributions made under contract, plus earnings, less Plan withdrawals and administrative expenses and market adjustments (when applicable).

The Principal Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. The guaranteed crediting rate is determined by calculating the weighted average of its underlying guaranteed interest funds; however, it may not be less than 1%. The crediting rate established in the contract is reset on a semiannual basis. There are no reserves against contract final value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, changes to the Plan's prohibition on competing investment options, deletion of equity wash provisions, and the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 6 - Plan Termination**

The Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See note 9 for plan merger subsequent to December 31, 2023.

**Note 7 - Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 - Subsequent Events**

Plan Merger

The Spin Systems, Inc. 401(k) Plan merged into the SpinSys-Dine 401(k) Plan (the acquiring plan), with an effective date of January 1, 2024. The Plan transferred all assets to the acquiring plan as of close of business on May 17, 2024.

Date of Management's Review

Management has evaluated subsequent events through July 25, 2024, the date which the financial statements were available to be issued.
