1. DESCRIPTION OF PLAN

The following description of TAP & AFFILIATES 401 (K) PLAN provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all full-time employees who have completed one year of service and are age twenty one . It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, participants may contribute up to 100 percent of pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make up catch up contributions. There is no company matching at this time.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's deferred compensation, as defined , and the allocation of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participants' earnings or account balances, as defined. As a participant-directed plan each participant's investments determine his or her share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**1. DESCRIPTION OF PLAN (continued)**

**VESTING**

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon.

**PAYMENT OF BENEFITS**

Upon termination of service, as defined, a participant receives a lump-sum amount equal to the vested value of his or her account.

**FORFEITURES**

Forfeitures are used to reduce future plan fees and future employer contributions. Certain forfeitures may be restored if the participant is reemployed before accruing five consecutive break-in-service years, as defined in the plan document, and if they return their amount of distribution.

**INVESTMENT OPTIONS**

Plan investments are participant directed. Upon enrollment in the plan a participant may choose from 49 different investment options including mutual funds, target date based funds, index funds, bond funds and other financial instruments. Participants may transfer between the funds daily through the internet or by telephone.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**DATE OF MANAGEMENT'S REVIEW**

Subsequent events were evaluated through July 30, 2024, which is the date the financial statements were available to be issued.

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

PLAN ADMINISTRATIVE EXPENSES

Certain administrative functions are performed by employees of the Employer. No such employee receives compensation from the Plan. The employer has absorbed all Plan administrative expenses that are not related to investments.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs- are quoted prices in active markets for identical assets the Plan has the ability to access at the measurement date and have the highest priority.

Level 2 inputs - are inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market date obtained from sources independent of the plan.

Level 3 inputs- are unobservable inputs for the asset. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions the market participants would use in pricing the asset, developed based on the best information available in the circumstances. Level 3 has the lowest priority.

FAIR VALUE MEASUREMENTS (continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

**Level 2 Fair Value Measurements**

The fair value of the variable return annuity contract for which a quoted market price is not available is valued at the net asset value (NAV) of shares of the underlying mutual funds held by the annuity.

**Level 3 Fair Value Measurements**

The fixed investment contract with an insurance company is not actively traded and significant other observable inputs are not available. Each contract is associated with a series of semi-annual coupon bonds. The fair value of the fixed investment contract is determined by considering the years until each bond matures, the book value of each bond, the coupon rate paid, and the yield on 7 year Treasury Bonds plus 2.00 %

**4. TERMINATION OF THE PLAN**

Although it has not expressed an interest to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100 % vested in their accounts.

**5. TAX STATUS**

The IRS has determined and informed the Company by a letter dated January 1, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2023 there were no uncertain positions taken that had an effect on the Plans financial statement or that required disclosure.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.
