NOTE 1 – PLAN ADMINISTRATION AND DESCRIPTION

The following brief description of the Riverhorse Logistics, LLC Retirement Readiness 401(k) Plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

A. General

The Plan is a defined contribution plan covering all full time (defined as 1,000 hours in the plan year) employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Eligibility

Employees are eligible to participate on the first day of the month coinciding with or following the date of employment.

C. Contributions

Each participant may contribute up to the maximum percentage allowed by the IRS for the plan year (January 1 to December 31). The Company determines the percentage it will match at the end of each Plan year. The Company is also permitted to make discretionary profit-sharing contributions to the Plan. The profit-sharing contribution is allocated to all eligible participants in the same ratio as each participant's compensation bears to the total of such compensation of all participants.

D. Participants' Accounts

Each participant account is credited with the participant's contribution and allocation of the Company's contribution and plan earnings. Allocations are based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

E. Vesting

Participants are always 100 percent vested in their salary deferral contributions plus actual earnings thereon. Match and discretionary contributions and earnings thereon vest as follows:

F. Forfeitures

Forfeited match and discretionary amounts may be used for plan expenses, to reduce employer contributions or be reallocated as employer contributions. Forfeitures used for the years ended December 31, 2020 and 2019 are \$4,550 and \$0, respectively.

G. Investment Options

Plan participants are permitted to direct their employee and employer match contributions into one of several pooled separate accounts maintained by Voya Retirement Insurance and Annuity Company.

H. Payments of Benefits

Upon normal retirement at age 65, death, disability termination of employment or in-service withdrawal on or after age 59 ½, the participant's vested benefits are paid to the participant or his or her beneficiary. Distributions may be made in lump sums, installments or in the form of an annuity.

I. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the interests of all participants and beneficiaries accrued to the date of the termination become non-forfeitable.

J. Payment of Plan Expenses

The employer pays certain Plan expenses including the audit fee.

K. Notes Receivable from Participants

Under the provisions of the Plan, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan repayments are made in equal installments through payroll deductions generally over a term not to exceed 5 years unless the loan proceeds are used for the purchase of the participant's principal residence. All loans are considered a direct investment from the participant's plan account with all payments of principal and interest credited to the participant's account. Only one outstanding loan is allowed per participant at any given time. Interest rates are determined based on the rates charged for similar loans from commercial lending institutions at the inception of the loan. Loan interest rates on outstanding loans as of December 31, 2020 range from 4.75 percent to 7.50 percent.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Method of Accounting

The financial statements are prepared on the accrual method of accounting in that revenues are recognized when earned and expenses are recognized when incurred. Allocations of the Plan's assets to the participant accounts include accrued employer contributions in accordance with the provisions of the plan.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

All assets of the Plan are maintained in pooled separate accounts or a fixed account at Voya Retirement Insurance & Annuity Company and reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 7 for additional information.

D. Income Taxes

Effective February 1, 2019 the Employer adopted the Retirement Plan Concepts & Services, Inc. Prototype Non-Standardized 401(K) Profit Sharing Plan. That Plan received a favorable 4remain in compliance with Internal Revenue Code revisions. Management believes the amendments would not affect the qualified status of the Plan and therefore, the Plan qualifies under Internal Revenue Code Section 401(a) and the trust is exempt from federal income taxes. The Company is required to file and does file Form 5500 with the Internal Revenue Service.

E. Subsequent Events

Subsequent events were evaluated through December 4, 2022, which is the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The following is a summary of the information included in the Plan's financial statements and financial schedules for 2020 and 2019 which was prepared by the custodian of the Plan assets and furnished to the plan administrator. The plan administrator has obtained a certification from the custodian that such information is complete and accurate.

- Investments at the beginning and end of the year.
- Changes in net assets resulting from investment activities for the years ended December 31, 2020 and 2019.
- Information included in the supplemental schedule of assets (held at end of year).

NOTE 4 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are administered by Voya Retirement Insurance and Annuity Company. Voya Retirement and Annuity Company is the Plan asset custodian. Therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

In March 2020, the World Health Organization declared the outbreak of novel coronavirus disease ("COVID-19") a global pandemic and recommended containment and mitigation measures worldwide. As a result, the Company adjusted certain aspects of its operations to protect its customers, contractors and workforce while still meeting the needs of its customers. The Company cannot reasonably estimate the length or severity of this pandemic, or the extent to which the disruption may materially impact its business, financial position, results of operations, and cash flows. This will also affect the retirement plans of the Company.

NOTE 6 - TERMINATED PARTICIPANTS

As of December, 31 2020 and 2019 there were no participants who had elected to withdraw from the plan but had not been paid.

NOTE 7 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset or inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2020 and 2019.

- The pooled separate accounts are valued based on the value of the underlying mutual funds adjusted for the value of dividends and realized and unrealized gains from the underlying mutual funds.

The investment contract with insurance company is valued at contract value which approximates fair market value.
