As of 01/01/2023 Gerali Custom Design, Inc. issued a new 401(K) Profit Sharing Plan & Trust through our vendor Paychex. The three-digit plan # 001 and was used in error when filing first return 5500-SF form on 06/27/2024.

On 07/24/2024 an Amended Return was filed, changing to three-digit plan #002 but did not reference the incorrect plan #001 on line 4d.

After speaking with representative at DOL on 7/26/2024, it was discovered that the three-digit plan for 401(K) should be Plan #003, as Plan #002 was used for previous plan that was terminated. Another amended First Return is being filed to correct from Plan #002 to Plan #003.

Plan #001 was assigned to original Gerali Custom Design, Inc. Profit Sharing Plan & Trust with the effective date of 01/01/1988. When third party tried to file 2023 - 5500-SF Final Return for original plan #001 the error code of Z-001 (see below) prevented the third party from filing.
