Note 1: Description of plan

The Athelas Inc. 401(k) plan is a defined contribution plan established for the benefit of the employees of Athelas Inc. ('the Company'). All full time employees are eligible to participate in the plan. The following is the brief general description of the plan:

Contributions

Participants may elect to make deferral contributions to the Plan from the pretax annual compensation, as defined in the plan, subject to certain limitations of the Internal Revenue Code (IRC). Participants who have attained the age of 18 before the end of the Plan year are eligible to make catch-up contribution. Rollover contribution from other qualified retirement plans are allowed by the plan. Participant direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contribution equal to a uniform percentage or dollar amount of the participant's elective deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of Company contributions, if any and Plan earnings and losses. Allocations are based participant earning or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are always fully vested with respect to their contributions and related earnings thereon. Participants are immediately vested in their contributions, rollover contributions, QNEC contributions, Company's discretionary matching and profit-sharing contributions and related earnings thereon.

Participant loans

The Plan Administrator i.e. Guideline Inc. makes loans available to Participants on a reasonably equivalent basis, so long as eligibility conditions are met. Participants must sign a promissory note along with a loan pledge to receive a loan.

Payment of benefits

On retirement, disability, or other termination of service, a participant may elect to receive a lump-sum distribution in the participant's vested account. The Plan does not allow hardship distribution.

Forfeited Accounts

As of December 31, 2023, forfeited non-vested accounts totaled NIL. These accounts will be used to reduce future employer contributions or to offset plan expenses.

Note 2 - Summary of significant accounting policies

Basis of Accounting

The preparation of financial statements is in conformity with generally accepted accounting principles and on accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investment is reported at fair market value except for the fully benefit responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing the information provided by the investment advisor and trustee.

Investment transaction are recorded on trade-date basis. Interest Income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses was recorded as of December 31, 2023.

Payment of benefits

Benefits are recorded when paid.

Corrective Distributions

Amounts payable to participants for contribution in excess of amounts allowed by the IRS are recorded as liability.

Plan expenses

Operating expenses of the Plan are absorbed by the plan sponsor and are included in these financial statements.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in United States of America which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets during the reported period. Actual results could differ from these estimates.

The Organization applies the provisions of FASB ASC 820, Fair Value Measurements and Disclosures, for fair value measures of investments that are recognized and disclosed at fair value in the financial statements on a recurring basis. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 – Quoted prices for identical instruments in active markets.

- Level 2 – Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which significant value drivers are observable.
- Level 3 – Valuations derived from valuation techniques in which significant value drivers are unobservable.

Level 1 Fair Value Measurements

The fair value of the investments in funds are based on the daily closing prices as reported by the fund. The funds held by the Plan are deemed to be actively traded. There are no Level 2 and Level 3 investments held at December 31, 2023 and December 31, 2022 respectively.

Note 4 - Income Tax Status

The Internal Revenue Service has ruled that the plan qualifies under section 401(a) of the Internal Revenue Code (IRC) and is, therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications.

The plan obtained its latest determination letter on August 14, 2020 in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of IRC.

Accounting principles generally accepted in United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

Note 5 - Plans termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan. Upon termination, all participants' account balances become fully vested in the amounts credited to their accounts after payment of any expenses, allocation of profit or loss, adjustment as a result of determination of the fair market value of Plan assets at the termination date, and reallocation of the Plan asset to the date of termination.

Note 6 - Information Certified by the Plan Trustee

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust

During December 31, 2023, the plan's investments were managed by Benefit Trust Company, the trustee of the Plan. Accordingly, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule under ERISA.

Note 10 - Subsequent events

The date to which events occurring after December 31, 2023 have been evaluated for possible adjustments to the financial statements or disclosure is July 25, 2024, which is the date on which financial statements were available to be issued.
