Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dealer-FX, Inc. Retirement Saving Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Retirement Saving Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Dealer-FX, Inc. Retirement Saving Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Dealer-FX, Inc. Retirement Saving Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan was a defined contribution plan sponsored by Dealer-FX, Incorporated (the Company). The Plan covered employees of Dealer-FX Incorporated which included employees of Blueprint Enterprises Inc. which became Dealer-FX Incorporated employees on December 31, 2022. The trustees of the Plan are PNC Bank, National Association from January 1, 2022 to June 30, 2022 and Newport Trust Company from July 1, 2022 to December 31, 2023.

Plan Merger

On December 31, 2023, the Company passed a resolution to freeze the Plan and merge the funds held in the Plan effective December 31, 2023 into the Snap-On Incorporated 401(k) Savings Plan.

Eligibility

Employees were eligible to make salary deferral contributions upon 60 days of service and reaching age 21. The entry date for participant contributions was the first day of the month within the Plan's year subsequent to the date of completing each of the Plan's eligibility requirements.

Contributions

Each year, participants could contribute a minimum of 1% up to a maximum of 100% of pretax annual compensation, as defined in the Plan, subject to limitations imposed by the Internal Revenue Code (IRC). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation.

The Company could, at its discretion, match a portion of participants' voluntary contributions. The Company could also make additional discretionary contributions to the Plan. During the years ended December 31, 2023 and 2022, there were no matching or discretionary contributions. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account was credited with the participant's contributions, Company matching contributions, and an allocation of Company discretionary contributions, and any earnings (losses) thereon, and charged with an allocation of administrative expenses. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of a participant's account was based on the number of years of service.

Company contributions vested according to the following schedule:

Participants were automatically fully vested upon attainment of age 65 or upon disability or death.

Forfeitures

At December 31, 2023 and 2022, there were no forfeited nonvested accounts. There were no forfeitures used to reduce Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or the participant's beneficiary could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participant accounts with values less than \$5,000 were be paid in a lump-sum distribution as soon as administratively feasible. In addition, hardship distributions from the participant's voluntary contributions account were permitted if certain criteria are met. The Plan also allowed for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Investment-related expenses were allocated proportionately to Plan participants based on their respective account balances and were included in net investment appreciation (depreciation).

Subsequent Events

The Plan has evaluated subsequent events through July 29, 2024, which was the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs were unobservable and have the lowest priority. The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust: The fair value of the underlying assets are used to determine the net asset value (NAV) of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Investments can be purchased and sold continuously. A notice of redemption is not required. The Plan had no obligation to buy additional units.

Note 4: Information Prepared and Certified by Trustees

The Plan Administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2023 and 2022, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Newport Trust Company from July 1, 2022 to December 31, 2023 and by PNC Bank, National Association for the period January 1, 2022 to June 30, 2022.

Note 5: Party-in-Interest Transactions

The Plan had fees to the third party administrator (Newport Group, Inc.). These transactions are party-in-interest transactions. These transactions were not considered prohibited under ERISA regulations.

Note 6: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 7: Tax Status

The Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator was not aware of any significant uncertain tax positions taken by the Plan.
