Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the accompanying financial statements of Innovations Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 15, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 through August 15, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

August 15, 2022

1. DESCRIPTION OF PLAN

The following description of the Innovations Group, Inc. 401(k) Plan (the “Plan”), sponsored by Innovations Group, Inc., Medquest Pharmacy, Inc., Medical Horizons, Inc., and Worldlink Medical, Inc. (the “Companies”), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a safe-harbor defined contribution 401(k) salary reduction plan covering all employees of the Companies who are eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute (defer) through salary reduction, the maximum allowable under the law. The Companies contribute a matching contribution under the safe harbor provisions of the Plan. The Companies contribute to the Plan an amount equal to 100% percent of each participant’s elective contribution, up to 3% of compensation. The Companies may also choose to make elective profit-sharing contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan investments consist of mutual funds, common/collective trusts, and a guaranteed interest account held by Delaware Charter Guarantee & Trust Company d/b/a/ Principal Trust Company and Principal Global Investors Trust Company. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the (a) participant’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Forfeitures of terminated participants’ non-vested accounts reduce future expenses of the Plan.

Vesting/Forfeitures

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting is also immediate in the Companies’ safe harbor contributions. For the Companies’ elective matching contributions, the vesting of those contributions is based on completed years of continuing service according to the following scale:

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum amount or as otherwise specified.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through September 28, 2023, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements under the Plan are prepared under the modified accrual basis of accounting. The asset amounts are reflected on a cash basis except for the contributions which are reported on a plan year accrual basis which includes contributions receivable and corrective distributions payable. Since the assets and liabilities are reflected as described below herein, there is substantially no difference between this basis of accounting and generally accepted accounting principles in the current year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trust company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements.

3. PLAN TERMINATION

On June 25, 2022, the Board of Directors of UpHealth, Inc., a controlling party of Innovations Group, Inc., Medquest Pharmacy, Inc., Medical Horizons, Inc., and Worldlink Medical, Inc., approved the merger of this Plan into the UPHEALTH 401(k) Plan ("401(k) Plan"), effective July 1, 2022. As a result, all investments were transferred from the Plan into the 401(k) Plan on August 15, 2022.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 15, 2022 and December 31, 2021.

Level 1

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Under FASB ASU 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient are not required to be categorized in the fair value hierarchy. They are, however, included in total to permit reconciliation to the amounts presented in the statement of net assets available for benefits. Investments using NAV as a practical expedient include the following:

Collective investment trusts: Collective investment trusts are valued at the NAV of units the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair market value. Portfolio securities of the underlying fund are valued at their daily closing price as reported by the fund. If market quotations are not readily available or are deemed unreliable, such securities are fair valued in good faith by the underlying fund's trustee. Participants have the ability to redeem their investments at net asset value without restrictions.

5. TAX STATUS

The IRS has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

6. EMPLOYER CONTRIBUTIONS

Total contributions of \$100,115 were made by the employers for the period from January 1, 2022 through August 15, 2022. The employers had a receivable of \$0 and was paid in 2021. Minimum funding requirements have been met.

7. ADMINISTRATIVE COSTS

Administrative costs of the Plan are generally paid by the Companies, the Plan, forfeitures, and partially by revenue-sharing from the earnings of the Plan. Administrative fees paid by the Plan for the period from January 1, 2022 through August 15, 2022 were \$29,995. Administrative fees paid by the Companies for the period from January 1, 2022 through August 15, 2022 were \$8,000.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. RELATED PARTY TRANSACTIONS

Certain Plan investments held during the year consisted of investments held by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal). Principal is considered a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the revenue sharing for Principal's services totaled \$29,995 for the period from January 1, 2022 through August 15, 2022.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

11. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) totaling \$0 at August 15, 2022 and \$205,608 at December 31, 2021. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Notes (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.
