### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Coe College Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 1, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended December 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Coe College Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 1, 2023 and December 31, 2022, and for the period ended December 1, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Coe College Defined Contribution Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis-of-Matter***

As discussed in Note 1 to the financial statements, the Plan was merged into the Iowa Association of Independent Colleges and Universities Multiple Employer Plan effective December 1, 2023, and substantially all of its assets were transferred to the successor plan on that date. Our opinion is not modified with respect to that matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Coe College Defined Contribution Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Coe College Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

**General**

Coe College, the Employer, established the Plan to provide employees with a systematic means of saving and investing for the future. The Plan was established on March 1, 1919, restated on April 1, 2019, and most recently amended effective December 2022. All eligible employees of the Employer as defined in accordance with the Plan document and universal availability standards are eligible to enroll on their date of hire. Employee deferrals begin on the first day of the month subsequent to enrollment. Employer contributions begin on the first day of the month subsequent to one year of service. Participants who were employed at other institutions of higher education are eligible to receive matching contributions immediately upon hire if they have met the minimum service hour requirements at the previous employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Oversight Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

**Contributions**

Each year, participants may elect to contribute amounts up to the maximum allowed by the Internal Revenue Code (IRC). Effective July 1, 2022, the Employer matching contribution made of 7% was reduced to 6% of the participant's compensation when the participant contributes 3% or more of their compensation into the Plan. Effective July 1, 2023, the Employer matching contribution of 6% was reduced to 4% of the participant's compensation when the participant contributes 3% or more of their compensation into the Plan. Effective May 31, 2018, 3% of all employee contributions will go to the defined contribution portion of the Plan. Any percentage over 3% will go to the tax deferred annuity portion of the Plan. The Plan offers various mutual funds, annuity contracts, pooled separate accounts, and guaranteed investment contracts as investment options for the Plan participants. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's elective contributions, rollover contributions, the employer's matching contributions, and Plan earnings and losses. Allocations are based on participant's compensation or account balances, as defined. Income is allocated daily based on each participant's share of the account.

**Vesting**

Participants are immediately vested in their elective contributions, rollover contributions, the employer's matching contributions, and actual earnings thereon.

**Benefit Payments**

Upon retirement, termination of employment, disability, or death, a participant or beneficiary is eligible to receive a lump sum, partial payment, or installment payments equal to the value of the participant's vested interest of their account.

**Plan Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are direct loans between the participant and TIAA and CREF, the insurance companies, and as such they are not treated as a transfer from the investment funds to a note receivable from participant or as a Plan asset.

However, 110% of the outstanding loan balance is collateralized by the participant's account and this portion of their account is transferred at the time of the loan and maintained in the TIAA Traditional Annuity within the participant's account. Loans must be repaid to TIAA and CREF by the participant in accordance with the repayment terms of the agreement. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan.

Outstanding loans between Plan participants and TIAA and CREF totals \$-0- and \$20,591 as of December 1, 2023 and December 31, 2022, respectively, and were collateralized by approximately the same amounts of investments included in the statements of net assets available for benefits as of December 1, 2023 and December 31, 2022, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Transfer of Assets**

On May 16, 2023, the Board of Trustees authorized the merger of Plan assets into the Iowa Association of Independent Colleges and Universities Multiple Employer Plan (MEP). The Plan merged into the MEP effective December 1, 2023 and transferred \$83,640,204 to the MEP on that date.

Effective December 1, 2023, participants in the Plan were eligible to participate in the Iowa Association of Independent Colleges and Universities Multiple Employer Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates in Preparing Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Oversight Committee determines the Plan's valuation policies utilizing information provided by the insurance companies. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized investment gains and losses.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 1, 2023 or December 31, 2022. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Employer pays certain administrative costs of the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through July 26, 2024, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

TIAA and CREF, and TIAA on behalf of TIAA, FSB and TIAA Trust, N.A., qualified institutions of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 1, 2023 and December 31, 2022, and the statement of changes in net assets available for benefits for the period ended December 1, 2023. TIAA and CREF, and TIAA on behalf of TIAA, FSB certified the Plan year ending December 31, 2022. TIAA and CREF, and TIAA on behalf of TIAA Trust, N.A., certified the Plan period ending December 1, 2023.

**NOTE 4 TIAA TRADITIONAL ANNUITY AND TIAA STABLE VALUE**

Each participant maintains an individual annuity contract with TIAA. As part of the contracts, TIAA may maintain a portion of the contributions in an unallocated fixed annuity contract that is fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts 1%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchase a guaranteed amount of lifetime annuity income.

When a participant’s account in the TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan.

Four different contracts are available to participants. Two of these contracts are considered benefit responsive and the other Two are nonbenefit responsive.

Certain Traditional Fixed Account individual annuity contracts meet the fully benefit-responsive criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); 2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain Traditional Fixed Account individual annuity contracts are considered to be nonbenefit responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer (see Note 5). These contracts are subject to an 84-month withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 5 FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 1, 2023 and December 31, 2022.

*TIAA Traditional Annuity (Nonbenefit-Responsive)* – Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the credit worthiness of the issuer. See also Note 4 for discussion of the TIAA Traditional Annuity and TIAA Stable Value Fund.

*Interest in Sub-Accounts of Variable Annuity Contracts* – Net asset value (NAV) of shares, which are valued by TIAA-CREF at accumulation unit value based on the estimated value of the underlying investments held by the Plan at year-end.

*Pooled Separate Account* – Value at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Due to the transfer of assets into the MEP, the Plan had no investments as of December 1, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022:

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

The Plan has invested in TIAA-CREF mutual funds, TIAA variable and fixed annuities, and CREF variable annuities. TIAA and CREF are the insurance companies as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The plan has entered into a revenue sharing agreement with TIAA-CREF. TIAA-CREF received revenue from the investment options under the Plan and/or sponsors of such investment options for services provided in connection with the investment options. This revenue is used to offset certain amounts owed to the Plan's service providers for their administrative services to the Plan. If the revenue received from the revenue sharing agreement exceeds the amounts owed to the service providers, TIAA-CREF, remits the excess to the Plan's trust. Such amounts may be applied to future administrative expenses or allocated to participant accounts. At December 1, 2023 and December 31, 2022, excess amounts totaled \$55,136 and \$52,613, respectively.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PLAN TERMINATION**

As described in Note 1, the Plan was terminated and assets transferred to the MEP on December 1, 2023.

**NOTE 9 PLAN TAX STATUS**

403(b) plans are not required to receive a favorable determination letter from the IRS indicating that the Plan is tax-exempt under present income tax law. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan Sponsor adopted a prototype document effective April 1, 2019 with a favorable opinion letter dated August 7, 2017, in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 NONEXEMPT TRANSACTIONS**

During 2023, the employer failed to remit employee deferral contributions for 3 payroll periods within the timeframe described by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The employer is in process to correct these late contributions.
