Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of VMware Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audits of VMware Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 1, 2024, and December 31, 2023, and for the period from January 1, 2024 through April 1, 2024, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of VMware Inc. 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of a Matter

As further discussed in Note 1, the VMware Inc. 401(k) Savings Plan was merged into the Broadcom U.S. 401(k) Plan effective April 1, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about VMware Inc. 401(k) Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of VMware Inc. 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

NOTE 1 – THE PLAN AND ITS SIGNIFICANT ACCOUNTING POLICIES

General – The following description of VMware Inc. 401(k) Savings Plan (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan that was adopted in March 2008 by VMware, Inc. (the Company), as a result of the Company's initial public offering and spin off from EMC Corporation in August 2007. The Plan was established to provide benefits to eligible employees, as defined in the plan document and was designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In November 2023, the Company was acquired by Broadcom Inc. Effective December 31, 2023, contributions to the Plan were frozen, except for rollover contributions, and all eligible employees of the Company became eligible to participate in the Broadcom U.S. 401(k) Plan (the Broadcom Plan) on January 1, 2024. In February 2024, the Broadcom U.S. 401(k) Plan Benefits and Investment Committee (Broadcom BIC), acting on behalf of Broadcom Inc., approved the amendment of the Broadcom Plan to merge the Plan effective April 1, 2024 into the Broadcom Plan. As a result, Plan assets of approximately \$4,080,343,000, including participant loans of approximately \$23,745,000, were transferred to the Broadcom Plan in April 2024.

Administration – The Company had appointed the Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company had contracted with Fidelity Management Trust Company (Fidelity) to act as the trustee and custodian, and an affiliate of Fidelity to act as the third-party administrator to process and maintain the records of participant data. Substantially all expenses incurred for administering the Plan were paid by the Plan.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with U.S. GAAP.

Investment valuation and income recognition – The Plan's investments are reported at fair value. The Plan's trustee and custodian, Fidelity, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2023.

Payment of benefits – Benefits are recorded when paid.

Income taxes – The Plan had adopted a prototype plan that had received an opinion letter dated June 30, 2020, from the Internal Revenue Service. The Plan had been amended since receiving the opinion letter. The plan administrator believed that the Plan was operated in accordance with, and qualified under, the applicable requirements of the Code and related state statutes, and that the trust, which formed a part of the Plan, was exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risks and uncertainties – Through April 1, 2024, the Plan provided for various investment options in any combination of investment securities offered by the Plan. Investment securities were exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it was at least reasonably possible that changes in market values, interest rates, or other factors could have materially affected participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent events – The Plan has evaluated subsequent events through July 25, 2024, which is the date the financial statements were available to be issued.

NOTE 2 – FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Brokerage link accounts: Accounts consist primarily of mutual, money market, and unit funds (valued as noted above), as well as common stocks that are valued at the closing price reported on the active market in which the individual securities are traded.

Common/collective trusts: Units held in a common/collective trust (CCT) are valued using the NAV practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information.

Participant transactions (purchases and sales) for all CCTs may occur daily. There are no redemption restrictions for all CCTs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by an affiliate of Fidelity, the trustee and custodian of the Plan, and therefore transactions with this entity qualified as exempt party-in-interest transactions.

The Plan includes a self-directed brokerage account (brokerage accounts) option through Fidelity. Included in the brokerage accounts are investments in common stock of Broadcom Inc. at December 31, 2023, totaling approximately \$355,000.

NOTE 4 – PARTICIPATION AND BENEFITS

Participant contributions – Prior to December 31, 2023, participants could have elected to have the Company contribute their eligible pre-tax or after-tax compensation (as Roth or after-tax contributions) to the Plan up to the amounts allowable under the plan document and current income tax regulations. The Plan also permitted the automatic enrollment of eligible employees in the Plan with an initial contribution of 6%, unless the employee affirmatively elected otherwise. Participants who had the Company contribute a portion of their compensation to the Plan agreed to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld were invested in accordance with the participant's direction.

Participants were also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions were deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions – Prior to December 31, 2023, the Company was allowed to make contributions to the Plan in the form of discretionary matching, profit sharing contributions and qualified nonelective contributions, as defined in the Plan and as approved by the Board of Directors.

For the year ended December 31, 2023, the Company matched 100% of participant contributions up to 6% of the participant's eligible compensation, not to exceed \$2,250 per quarter for a total of \$9,000 per year.

There were no profit sharing or qualified nonelective employer contributions made to the Plan in 2023.

Vesting – Participants are immediately vested in their entire account, including all employer contributions.

Participant accounts – Each participant's account was credited with the participant's contributions, Plan earnings or losses, and an allocation of the Company's contribution, if any. Allocation of the Company's contribution was based on participant contributions and eligible compensation, as defined in the Plan.

Payment of benefits – Upon termination, the participants or beneficiaries could have elected to leave their account balance in the Plan, elect a partial withdrawal, or receive their total benefits in a lump sum amount equal to the value of the participant's interest in their account. The Plan allowed for the automatic lump sum distribution of participant account balances that did not exceed \$1,000.

Notes receivable from participants – The Plan allowed participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance. The notes receivable were secured by the participant's balance. Such notes receivable bore interest at the available market financing rates and had to be repaid to the Plan within a five-year period, unless the proceeds were used for the purchase of a principal residence, in which case the maximum repayment period could have been longer. The specific terms and conditions of such notes receivable were established by the Committee.

NOTE 5 – CERTIFIED INFORMATION

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee and custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable reflected on the accompanying statements of net assets available for benefits as of April 1, 2024, and December 31, 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable reflected on the accompanying statements of changes in net assets available for benefits for the period from January 1, 2024 through April 1, 2024, and for the year ended December 31, 2023.
