Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

The following description of the Greenwich Biosciences, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

General

The Plan was established effective January 1, 2016 to enable eligible employees to make contributions to the Plan, thereby providing employees with an opportunity to accumulate funds for retirement. The Plan is a defined contribution plan established, sponsored and administered by Greenwich Biosciences, Inc. in the United States (the “Company”) for the benefit of substantially all employees of the Company. The Plan’s trustee, Delaware Charter Guarantee and Trust Company dba Principal Trust Company (the “Trustee”), has the authority and responsibility for the management and investment of plan assets. The Company’s 401(k) Plan Committee is the Plan’s named fiduciary for purposes of Section 402(a) of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective May 5, 2021, the Company was acquired by Jazz Pharmaceuticals Public Limited Company, which resulted in a change in ownership of the Company.

Effective January 1, 2022, the Company was converted from a Delaware corporation into a Delaware limited liability company, to be named Greenwich Biosciences, LLC.

Effective December 31, 2022, the Company merged into Jazz Pharmaceuticals, Inc., which is a subsidiary of Jazz Pharmaceuticals Public Limited Company.

Plan termination and transfers of assets

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts. In connection with the merger of the Company into Jazz Pharmaceuticals, Inc., the Plan was merged into the Jazz Pharmaceuticals, Inc. 401(k) Plan (“Jazz Plan”), effective January 19, 2023, at which point the Plan terminated. In connection with the merger and immediately prior to the transfer of the Plan’s assets to the Jazz Plan, all participants’ account balances became fully vested in the Plan. Participant accounts totaling \$30,290,620 were transferred out of the Plan and into the Jazz Plan as of January 22, 2023.

Eligibility

The Plan covers all employees of the Company, except for leased employees, once they have attained 21 years of age. An employee's entry date into the Plan will be the first day of the month coinciding with or next following the date he or she satisfies the eligibility requirements. Newly eligible employees are automatically enrolled at 3% of the employee's compensation, and automatically increased each January unless the employee affirmatively elects otherwise.

Contributions

Each participant may contribute from 1% to 100% of their annual compensation as pre-tax or Roth contributions, as defined in the Plan, subject to an annual limitation imposed by Internal Revenue Service ("IRS") regulations. Participants may also make rollover contributions into the Plan representing distributions from other tax-qualified employer-sponsored retirement plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan.

The Company makes matching contributions of 75% of the first 6% of base compensation that a participant contributes to the Plan. The Company may also make a discretionary contribution each plan year. Contributions are subject to certain limitations. There were no discretionary contributions made by the Company for the period ended January 22, 2023.

Participant investment account options

Participants direct the investment of all contributions into various investment options offered by the Plan.

Allocations

Each participant's account is credited with investment earnings and an allocation of certain Plan administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants immediately vest 100% in participant contributions plus actual earnings. Participants are also immediately vested 100% in the Company's matching and discretionary contributions.

Forfeitures

Unvested amounts forfeited by terminated participants may be used to pay Plan administrative expenses or applied to reduce the Company's contributions. At January 22, 2023 and December 31, 2022, there were no unvested forfeited accounts.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment periods may not exceed five years except for notes used to acquire a principal residence. Principal and interest are paid ratably through payroll deductions. The note interest rate is based on rates available for similar loans as determined by the Company. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Benefit payments

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of participant's vested interest in his or her account or may elect to receive a non-transferable deferred annuity contract. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may withdraw any or all of their elective deferral account balances at any time during the Plan year provided certain hardship conditions, as defined in the Plan document, have been met. Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of accounting

The Plan uses the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of income and expenses during the reporting period. Actual results could differ from estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 22, 2023 and December 31, 2022.

3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 22, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment valuation and earnings

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consisted of the realized gains or losses on sales of investments and the unrealized appreciation or depreciation of those investments.

4. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

5. Tax Status

The Plan is a non-standardized prototype plan. The non-standardized prototype plan received an opinion letter from the IRS dated June 30, 2020, indicating that the Plan and related trust satisfy the requirements of Section 401 of the Internal Revenue Code (the "Code"). The Plan is required to operate in accordance with the Code to maintain its tax qualification. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The tax positions taken by the Plan have been analyzed and, as of January 22, 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain Plan assets are invested in Trustee accounts. Certain officers of the Company and members of the Company's 401(k) Plan Committee are participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

7. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

7. Fully Benefit-Responsive Investment Contract, Cont'd

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%. The crediting interest rate is reviewed on a quarterly basis for resetting. The contract does not have a maturity date. However, the issuer may terminate the contract without application of any otherwise required market value adjustment or contract liquidation charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2022, approximately 17% of the Plan's investments were invested in American Funds Target Date Retirement 2035 R6 Fund and approximately 17% were invested in American Funds Target Date Retirement 2040 R6 Fund.

9. Reconciliation of Financial Statements to Schedule H of Form 5500

There were no differences between the accompanying financial statements as of January 22, 2023 and December 31, 2022 and the financial information reported on Schedule H of the Form 5500.
