To the Plan Administrator of

Opinion

We have audited the accompanying financial statements of Dietz & Watson, Inc. Union Employees Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 12, 2023 (in liquidation) and December 31, 2022 (ongoing, "going concern basis"), and the related statement of changes in net assets available for benefits for the period ended December 12, 2023 (in liquidation), and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 12, 2023 (in liquidation) and December 31, 2022 (ongoing), and the changes in its net assets available for benefits for the period ended December 12, 2023 (in liquidation), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, Dietz & Watson, Inc., the Plan Sponsor, adopted a resolution to terminate the Plan. As a result, the Plan has changed its basis of accounting from the ongoing basis ("going concern basis") used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(In Liquidation)

Note 1 – Termination of the Plan:

On July 24, 2023, management of Dietz & Watson, Inc., the Plan Sponsor, adopted a resolution to terminate the Dietz & Watson, Inc. Union Employees Pension Plan (the “Plan”) effective September 30, 2023. Final distributions were determined based on all participants being 100% vested and fully paid out as of December 12, 2023. Assets totaling \$342,196 were transferred into qualified retirement plans. As a result, the Plan has changed its basis of accounting from the ongoing basis (“going concern basis”) used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

Note 2 - Description of Plan:

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan Document for a complete description of the Plan’s provisions.

General - The Plan is a noncontributory defined benefit plan sponsored by the Plan Sponsor (or the “Company”) for the benefit of substantially all United Food and Commercial Workers Union Local 152 (formerly Local 56) employees of the Company who complete at least six months of service. Effective March 31, 2010, the Plan was frozen to new participants and benefit accruals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by UBS Financial Services (“UBS”) and The Glenmede Trust Company (“Glenmede”) (together the “Custodians”), who are responsible for the custody and management of the Plan’s assets.

Vesting - A participant has no vested interest in the Plan until he/she has attained five years of vested service, at which time he/she becomes 100% vested. All participants were 100% vested.

Retirement Benefits - Employees are entitled to elect to have annual benefits at a normal, early, or late retirement age. Normal retirement age is 65.

The normal form of benefit for a participant who has a spouse is a 50% joint and survivor annuity. The normal form of a benefit for a participant who has no spouse is a single-life annuity. Effective November 1, 2017, the Plan was amended to permit lump sum distributions.

The normal retirement benefit is based on years of credited service. The monthly retirement benefit payable at age 65 years under a single-life annuity is \$15 per year of credited service (as defined) prior to February 1, 1995, plus \$20 per year of credited service (as defined) from February 2, 1995 to February 3, 2002, plus \$25 per year of credited service (as defined) from February 4, 2002 to February 1, 2003, plus \$30 per year of credited service (as defined) from February 2, 2003 to February 5, 2005, plus \$35 per year of credited service (as defined) after February 5, 2005, up to a maximum of 35 years. However, if a participant was fully vested in his accrued benefit under the previous union plan, such participant shall not be credited with any years of service for the period prior to February 1, 1995.

If a participant terminates service before age 65, but after the attainment of age 55 and completion of 15 years of vested service, the participant may elect early retirement in which case the amount of the benefit payable will be based upon credited service (as defined) as of the termination date, reduced by 0.50% for each month that the participant’s early retirement date precedes the normal retirement date.

Effective January 1, 2018, the Plan was amended to permit in-service distributions to participants who have attained the age of 62 from participants who remained in employment with the Company, were past the age of 70 ½, and had two consecutive years of service less than 1,000 hours.

The maximum benefit payable at age 65 is limited to the lesser of \$195,000 or 100% of the participant's highest average annual earnings during three consecutive years of participation in the Plan.

Death and Disability Benefits - In the event of an active participant's death, the surviving spouse shall receive a monthly pension for life, commencing on the first day of any calendar month when the participant could have elected to receive immediate retirement benefits, but not later than the date that would have been the participant's normal retirement date. The benefit shall be equal to the benefit such spouse would have received if the participant had terminated employment on the earlier of the date of his/her death or his/her actual termination date.

A participant who is employed by the Company, who suffers a total and permanent disability for at least 6 months, shall be eligible for disability retirement benefits provided he/she has 10 or more years of vested service when he/she terminates employment due to such disability. An eligible disabled participant shall receive a single-life annuity commencing at his/her disability retirement date, at a value equal to his/her accrued benefit as of his/her termination date.

Transfers Out for Purchase of Group Annuity Insurance Contract - As part of the termination in 2023, the Plan purchased a contract with an insurance company for an annuity insurance contract in the amount of \$369,500. This contract was purchased for the benefit of the participants to continue receiving annuity payments with the termination of the Plan.

Note 3 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying 2023 financial statements are presented on the liquidation basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (see Note 1). The accompanying 2022 financial statements have been prepared on the (ongoing) accrual basis of accounting.

Use of Estimates - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results, as determined at a later date, could differ from those estimates.

Plan contributions and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

Investment Valuation and Income Recognition - For 2022, investments are reported at fair value. For 2023, investments are reported on the liquidation basis which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Interest-bearing Cash and Money Market Funds - Interest-bearing cash and money market funds include highly liquid short-term investments purchased with maturities of three months or less.

Actuarial Present Value of Accumulated Plan Benefits - Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to services rendered by the employees to the valuation date. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on a formula that includes number of years of credited service and a dollar amount associated for each year of credited service, as defined in the Plan document. The accumulated plan benefits for active employees are based on a formula that includes number of years of credited service and a dollar amount associated for each year of credited service, as defined in the Plan document, ending on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances - retirement, death, disability, and termination of employment - are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Administrative Expenses - The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan Document. Expenses that are paid directly by the plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Eligible expenses to the Plan, include, but are not limited to, investment managers' and custodial fees, actuarial fees, legal fees, recordkeeping fees, and audit fees. The Company may pay such eligible expenses on behalf of the Plan without reimbursement. The Plan paid the Pension Benefit Guaranty Corporation ("PBGC") fees and all other administrative expenses. Such expenses amounted to \$17,030 for the period ended December 12, 2023. In addition, certain investment-related expenses reduced investment income presented in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits - Benefits to participants are recorded when paid.

Subsequent Events - The Plan administrator has evaluated subsequent events from December 12, 2023 through July 30, 2024, the date the financial statements were available to be issued. The effect of those events and transaction that provide additional pertinent information about conditions that existed at the statement of net assets date have been recognized in the accompanying financial statements.

Note 4 - Funding Policy:

The Company contributed the amount necessary, if applicable, on an actuarial basis to provide the Plan with assets sufficient to meet the current and future obligations to Plan members.

The contributions of the Company are designed to fund the Plan's current service costs on a current basis and to fund over forty years the estimated accrued benefit cost arising from qualifying service before the establishment of the Plan. The yield on investments of the Plan serves to reduce future contributions that would otherwise be required to provide for the defined level of benefits under the Plan. The Plan has met minimum funding requirements.

Note 5 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement Level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 12, 2023 and December 31, 2022.

- *Mutual funds and exchange-traded and closed-end funds:* Valued at the closing price reported in the active market in which the individual security is traded.
- *Interest-bearing cash and money market funds:* Valued at the closing price in the active market in which they are traded.
- *Private equity fund:* The investments in the private equity fund are typically valued utilizing the NAVs provided by the underlying investment companies and/or their administrators. Plan management considers subscription and redemption rights, including any restrictions on the disposition of the interest in its determination of fair value.
- *Structured products:* Valued based on the net asset value per share, without further adjustment. Net asset value is based upon the fair value of the underlying investments. There are no unfunded commitments and redemptions are allowed daily without a notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the period and year ended December 12, 2023 and December 31, 2022, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 6 - Private Equity Fund:

The Plan invests in the Glenmede Private Investment Fund VII, LLC, a private equity fund that invests in limited partnerships and other pooled investment vehicles organized by independent fund sponsors to make private investments in nonpublic companies consisting primarily of equity and equity-related ownership interest. As an investor in the private equity fund, the Plan entered into a subscription agreement during 2010 in which the Plan committed to contribute capital of \$250,000 to the fund. Through December 31, 2021, the Plan made contributions of \$175,000, 70% of the total commitment, under the terms of the fund agreement. The fund manager determined that no further contributions are required from the investors subsequent to December 31, 2021. The private equity fund had an initial term which expired on December 31, 2018, with up to three one-year extensions under certain circumstances, which were all exercised by the fund manager through December 31, 2021. In 2022, the fund began liquidating assets and will remain open until the remaining investments are liquidated or exited. Prior to the liquidation of the fund, distributions are paid to investors at the discretion of the manager of the fund. Redemption for participants is not allowed. In 2023 the remaining investments were liquidated.

Note 7 - Risks and Uncertainties and Concentration of Investment Risk:

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Contributions to the Plan and the actuarial present value of accumulated plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates and employee compensation and demographics, all of which are subject to change. Due to the uncertainties inherent in estimations assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. The Plan held no such investments at December 12, 2023 and December 31, 2022.

The Plan's investments were fully liquidated in 2023; therefore, there are no investment concentrations as of December 12, 2023. The Plan's investment in one exchange-traded and closed-end fund comprised approximately 11% of total investments at December 31, 2022.

Note 8 - Income Tax Status:

The Plan was written on an Internal Revenue Service ("IRS") pre-approved Volume Submitter Document, which obtained its latest opinion letter on March 30, 2018 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the trust is exempt from Federal income taxes under Section 501(a) of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date, thus, no provision for Federal income taxes has been made in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 9 - Parties-in-Interest:

Certain Plan investments are managed by the Custodians, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.
