Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Huntingdon Valley Bank 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (in liquidation) as of December 14, 2023; and the statement of net assets available for benefits as of December 31, 2022; the related statement of changes in net assets available for benefits (in liquidation) for the year then ended; and the related notes to the financial statements (collectively, the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the short plan year ended December 14, 2023, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Plan Termination and Liquidation Basis

As discussed in Note 3 to the financial statements, the Board of Directors of Huntingdon Valley Bank, the Plan's sponsor, voted on June 12, 2023, to terminate the Plan, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due, or which may become due, to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance, and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



Auditor's Responsibilities for the Audit of the Financial Statements (Continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Note 1sho. Description of Plan

The following brief description of Huntingdon Valley Bank 401(k) Profit Sharing Plan and Trust (the “Plan”) for employees of Huntingdon Valley Bank (“the Bank” and “Plan Sponsor”) is provided for general information purposes only. Plan participants should refer to the Plan document and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of the Bank who are eligible to participate in the Plan when the individual has satisfied the eligibility condition of attainment of age of 21. However, an employee will actually become a participant in the plan once the employee reaches the entry date which is the first day of the month coinciding with or next following the date the individual satisfied the eligibility requirement. The Plan includes a 401(k) before-tax and Roth after-tax contributions, which permits participants to defer compensation under Section 401(k) of the Internal Revenue Code of 1986, as amended (“the Code”).

Merger and Plan Termination

HV Bancorp, Inc., the holding company for the Bank, entered into an agreement and plan of merger dated October 18, 2022, with Citizens Financial Services, Inc. (the “Merger”). The Merger closed on June 16, 2023. On June 12, 2023, the Board approved the termination of the Plan. The effective date of the plan termination was the date immediately preceding the Close Date as defined in the Merger Agreement. The final distributions were issued by December 14, 2023. Additional details are included in Note 3.

Administration

The Plan administrator was the Benefits Committee and was responsible for the oversight of the Plan. The Plan’s trustee is Reliance Trust Company and the recordkeeper is Pentegra Services, Inc. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code and the provisions of Employee Retirement Income Security Act (“ERISA”), as amended.

Contributions

A participant may elect to defer, on a pre-tax basis and Roth after-tax, up to 96% of his or her compensation in any plan year, subject to limits imposed by the Code. Participants who are or will attain age 50 before end of plan year are eligible to make catch-up contributions. The Plan also includes an automatic enrollment feature. Eligible employees who do not enroll at a self-directed deferral percentage or do not affirmatively opt-out will be enrolled at 3% pre-tax. A participant may direct the investment of his or her own account into various investment options offered, including HV Bancorp, Inc. common stock through the Stock Fund. In addition to salary deferral contributions, the Bank may make during the plan year: (1) a discretionary matching contribution to each participant’s account based on a percentage of the participant’s salary deferral contribution; and/or (2) a profit sharing contribution that would be allocated to each participant’s account pro-rata on the basis of each participant’s compensation relative to the aggregate compensation of all participants. For the short plan year ended December 14, 2023 and the year ended December 31, 2022, there was no profit sharing contribution to the Plan. For the short plan year ended December 14, 2023, the Bank’s discretionary matching contribution was equal to 50 cents for every dollar up to 3 percent of an employee’s eligible compensation.

The Plan has an In-Plan Roth conversion feature where a portion of participant’s funds held in one or more tax-deferred accounts under the Plan can be converted from a pre-tax basis to a Roth tax basis. The reclassified amounts will be treated by the Plan as Roth deferrals and not be taxed at the time of distribution. In addition, the Plan has an In-Plan Roth Rollover, which offers a participant who is eligible for a distribution from their account to elect to roll over all or a portion of the distribution to a designated Roth contribution account in the Plan. The participant may only roll over the distribution directly.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and allocations of Plan earnings as defined by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

A participant is immediately 100% vested in his or her salary deferral contributions. However, a participant will vest in his or her employer contributions at a rate of 20% per year after the completion of two years of credited service, such that the participant will be 100% vested upon completion of six years of credited service. Upon the plan termination, employees became fully vested in employer contributions.

Payment of Benefits

Pursuant to the Plan termination, participants had the opportunity to elect to receive a distribution of their vested account balance as single cash payment either (i) directly to the participant, subject to mandatory federal and state tax withholdings, or (ii) as a direct rollover by the Plans trustee into another eligible retirement account or an Individual Retirement Account (IRA). In the event the participant did not provide an election by August 14, 2023, the vested account balance was rolled over directly to an IRA on behalf of the participant established by the Plan Sponsor, or if the balance was less than \$1,000 paid as a direct taxable distribution to the participant.

As a result of the Plan termination, all balances were distributed to participants in the Plan by December 14, 2023.

Forfeitures

Amounts forfeited from non-vested accounts may be used to reduce future employer contributions. At December 14, 2023 and December 31, 2022, there were no unallocated forfeitures. During 2023, there were \$32,718 in forfeitures utilized for employer contributions. During 2022, there were \$55,953 in forfeitures utilized for employer contributions.

Notes Receivable from Participants

Participants were able to borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the vested balance in the participant's account and bared interest ranging from 4.25% to 9.25%, which is commensurate with local prevailing rates. Principal and interest were paid through biweekly payroll deductions. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. All loans were either repaid or treated as distributions of plan assets upon termination of the plan. No allowance for credit losses was recorded as of December 31, 2022.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan during 2023, the Plan's financial statements as of December 14, 2023, and for the short plan year ended December 14, 2023, have been prepared on the liquidation basis of accounting, in accordance with GAAP.

The financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America (US GAAP). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value, and liabilities are stated at their anticipated settlement amounts.

The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

Valuation of Investments and Income Recognition

There were no investments remaining at December 14, 2023. As of December 31, 2022, the Plan's investments were stated at fair value. (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest

income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments includes the gains and losses on investments purchased, sold, and held during the year. The Plan Administrator determines the Plan's valuation policies, utilizing information by the investment advisers and custodians.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 14, 2023, and December 31, 2022.

Investment Fees

Net investment returns reflect certain fees paid by the investments. funds to their affiliated investment advisers, transfer agents, and others, as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and, thus, are not separately identifiable as an expense. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan assets consisted of various investment securities which were exposed to numerous risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

At December 31, 2022, approximately 29% of the Plan's total investments were invested in the common stock of HV Bancorp Inc. The underlying value of the HV Bancorp Inc. common stock is entirely dependent upon the performance of HV Bancorp Inc. and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of HV Bancorp Inc. common stock in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Administrative Expenses

Administrative expenses of the Plan relating to investment management are paid by the Plan. Recordkeeping costs are by the Plan and the Bank. The Bank pays accounting and other administrative costs for the Plan.

Note 3. Plan Termination

On June 12, 2023, the Board approved the termination of the Plan. As a result, management determined that liquidation was imminent. The effective date of the plan termination was the date immediately preceding the Close Date as defined in the Merger Agreement. The merger closed on June 16, 2023. Participants became 100% vested in their accounts upon termination of the Plan.

In April 2023, a Notice of Plan Termination was distributed to Plan participants. The Notice of Plan Termination provided Plan participants or beneficiaries their available options to receive their vested account balances. As a result of the resolution to terminate the Plan, each participant with an account balance under the Plan had the option to receive his or her account balance distributed in a single cash payment either (i) directly to the participant, subject to mandatory federal and state tax withholdings, or (ii) as a direct rollover by the Plan's trustee into another eligible retirement account or an IRA. In the event the participant did not provide an election by August 14, 2023, the vested account balance was rolled over directly to an IRA on behalf of the participant established by the Plan Sponsor, or if the balance was less than \$1,000 paid as a direct taxable distribution to the participant.

Note 4. Tax Status

The Internal Revenue Service advised the Plan administrator by letter dated June 30, 2020, that the Plan and related trust, as then designed, is tax-exempt, under the appropriate sections of the Code. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is currently designed and being operated, in compliance with the applicable requirements of the Code.

The Plan's management has evaluated the effects of accounting guidance related to uncertain income tax positions and determined that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements at December 14, 2023 or December 31, 2022. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the plan years ending prior to 2020.

Note 5. Investments

The Plan Administrator has obtained certification from the trustee, Reliance Trust Company, that information provided to the Plan Administrator by the trustee related to the Plan's investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule, related to the investments.

The trustee also certified to the completeness and accuracy of \$317,014 of net appreciation in fair value of investments (including investments bought, sold, as well as held during the year) and \$56,307 of interest and dividends related to the aforementioned investments and participant loans for the short plan year ended December 14, 2023.

Note 6. Party-in- Interest Transactions

Notes receivable from participants and common stock of HV Bancorp, Inc. qualify as party-in interest transactions. The Plan held 67,069 shares of HV Bancorp, Inc., at December 31, 2022. The Plan invested in HV Bancorp Inc. common stock and short-term investments and had an estimated fair value of \$1,861,375 at December 31, 2022, respectively. There was no dividends received in 2023 for HV Bancorp, Inc. common stock.

Costs and expenses paid by the Plan Sponsor on behalf of the Plan totaled \$12,893 and \$44,338 for the short plan year and year ended December 14, 2023 and December 31, 2022, respectively.

Note 7. Fair Value

The following disclosures show the hierarchal disclosure framework associated with the level of pricing observations utilized in measuring assets and liabilities at fair value. The three broad levels of pricing observations are as follows:

Level 1 – Valuation is based on quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2 – Valuation is based on inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly at the measurement date.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds consist of investments in various types of funds that are actively traded for which closing prices are readily available.

Common stock: Common stock is valued at the closing price reported on the active market on which the individual securities are traded plus the carrying value of the short-term investment component of the fund, which approximates fair value.

Money market fund: Money market funds consist of investments in short-term securities that are traded in an active market for which closing prices are readily available.
