Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Circle Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 (liquidation basis) and December 31, 2022 (ongoing basis), and the related statement of changes in net assets available for benefits for the years ended December 31, 2023 (liquidation basis) and 2022 (ongoing basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis Of Matter - Plan Termination And Liquidation Basis Of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of the Great Circle approved a plan of liquidation, and management determined liquidation to be imminent. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

December 31, 2023 And 2022

1. Description Of The Plan

The following description of the Great Circle Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Great Circle (the Company) who are not highly compensated and who are aged 20 or older. Charles Schwab Trust Bank (Charles Schwab) serves as the custodian and the record keeper is EPIC Retirement Plan Services (EPIC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On March 3, 2023, the Board of Directors of the Company approved a resolution to terminate the Plan effective March 31, 2023, subject to the provisions of ERISA. All assets and participant accounts of the Plan were fully distributed by December 31, 2023. Upon termination, all participants became fully vested.

Contributions

Employees were eligible to start making deferral contributions immediately upon satisfying the eligibility requirement above. Each year, participants could contribute a percentage of their annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Service (IRS) limitations. Salary deferral contributions could be made as either pre-tax or Roth (after-tax) contributions. Participants over the age of 50 were eligible for catch up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Participants who completed one year of employment and 1,000 hours of service were eligible for the discretionary matching contribution. The discretionary matching contribution was equal to 100% of participants' deferrals up to a maximum of 6% up to each participant's compensation.

The Plan also provided for an additional discretionary matching contribution for participants that attained 10 years of service. The Company matched 167% of the first 6% of compensation for these participants.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Investment Options

Participants directed their deferrals, rollover and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants changed their investment options at any time throughout the year.

Vesting

Participants were immediately vested in their deferral and rollover contributions. Vesting in the Company's contribution portion of their accounts was based on years of service. A participant vested 20% each year after the second year of service and was fully vested after six years of service or upon reaching normal retirement age (age 65), death, or total and permanent disability.

Forfeitures

Forfeitures of nonvested benefits were used to pay administrative expenses related to the operation of the Plan. Remaining forfeitures, if any, were used to reduce any Company contributions. There were no forfeitures utilized to pay administrative expenses for the year ended December 31, 2023. Forfeitures utilized to pay administrative expenses for the year ended December 31, 2022 were \$106,649. All forfeiture balances were fully utilized as of December 31, 2023. At December 31, 2022, available forfeited nonvested accounts totaled \$3,707.

Notes Receivable From Participants

Participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans were for a period not exceeding five years unless used to acquire a personal residence, then the term was extended to 15 years. Loans bore interest at the USA Today prime rate plus 1%. Participants could have one loan outstanding at a time and were secured by participants' vested account balances. Loan repayments were made through payroll withholdings.

GREAT CIRCLE RETIREMENT SAVINGS PLAN

Notes To Financial Statements (*Continued*)

Payment Of Benefits

Upon termination of employment, retirement or death, a participant's vested balance could be distributed in a lump sum, installment payments, or partial payments.

In-Service And Hardship Withdrawals

Participants age 59 ½ or older could take an in-service withdrawal. A participant could also make withdrawals from his or her participant deferral contributions account in the event of undue financial hardship, which included, but not limited to, payments for education expenses, medical or burial expenses, the purchase of a home or delinquent mortgage payments. Withdrawals were subject to Internal Revenue Code (IRC) limitations.

Administrative Expenses

Significant costs of administering the Plan were paid by the Plan. Other fees were paid by the Company.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

Because the termination of the Plan was imminent, the 2023 financial statements of the Plan are prepared under the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. The 2022 financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment Of Benefits

Benefits are recorded when paid.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the years then ended, included throughout the Plan's financial statements that was prepared by or derived from information certified by Charles Schwab, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodian that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements related to the following assets:

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Collective Trust Funds

Valued at the net asset value (NAV) of units of bank collective trusts. The NAV, as provided by trustees of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The Plan used a non-standardized pre-approved plan document sponsored by EPIC Advisors, Inc. EPIC Advisors, Inc. received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since the date of the opinion letter. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
