## Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Petroleum Equipment Service of New Hampshire LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audits of Petroleum Equipment Service of New Hampshire LLC 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with the ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **1. Description of the Plan**

The following brief description of the Petroleum Equipment Service of New Hampshire LLC 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for more complete information regarding the terms of the Plan.

**General**

The Plan is a defined contribution plan dated February 1, 2004, and most recently restated effective May 20, 2020, that covered all eligible employees of Petroleum Equipment Service of New Hampshire, LLC, except nonresident aliens, employees covered by a collective bargaining agreement and certain other employees as defined in the Plan.

Employees are required to attain age 21 and complete three months of eligibility service to enter the Plan. Participants enter the Plan on the first of each month after they have met the eligibility requirements.

Employees are also required to have completed one year of eligibility service to receive employer matching contributions or profit-sharing contributions.

Effective June 30, 2023, the Plan was terminated. The Plan merged with the OWL Services 401(k) Plan. The Plan blackout period was July 3, 2023 through the week of October 6, 2023. Schwab Retirement Plan Services, Inc. is the new recordkeeper. The final transfer was \$6,943,153 and was completed on October 12, 2023.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Eligible employees may contribute up to 92% of their annual compensation, subject to Internal Revenue Code limitations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan.

The Plan also permits Roth elective deferrals. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not “pre-tax” deferrals as defined in the Code.

**1. Description of the Plan (continued)**

The Plan also includes an automatic enrollment feature. As a result, individuals hired by the Company who do not affirmatively elect not to participate are automatically enrolled in the Plan 30 days after eligibility requirements are satisfied and will have their compensation reduced by 3%.

The Company may provide a matching contribution. The matching contribution is 50% of 6% of eligible compensation for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022.

The Company may also provide a discretionary profit-sharing contribution as defined in the Plan. No amounts were provided for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, employer matching contribution, and Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeitures**

At October 12, 2023 and December 31, 2022, forfeited non-vested employer contributions totaled \$-0- and \$3,697, respectively. These amounts can be used to reduce future employer contribution, pay eligible plan expenses, or be allocated to participant accounts. Forfeitures used to reduce employer contributions for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022 amounted to \$-0- and \$-0-, respectively. Forfeitures of \$-0- and \$23,562 were used to pay plan expenses for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022, respectively.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in the Company's contribution portion of their accounts, if any, plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, 40% after three years, 60% after four years, 80% after five years and is 100% vested after the completion of six years of credited service.

**1. Description of the Plan (continued)**

**Payment of Benefits**

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount and other options as defined in the Plan. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. Loan terms range from 1-5 years or longer for purchase of principal residence. Loans are secured by the balance in the participant's account and bear an interest rate of the current prime lending rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**2. Significant Accounting Policies (continued)**

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid directly by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at October 12, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments and interest and dividend income for the period January 1, 2023 through October 12, 2023 and the year ended December 31, 2022, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan.

**4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

**4. Fair Value Measurements (continued)**

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at October 12, 2023 and December 31, 2022.

*Mutual funds* are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust* (Reliance MetLife) is valued at the net asset value provided by Reliance Trust. The net asset value is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market. Redemptions are processed daily. The net asset value is used as a practical expedient to estimate fair value. There are no unfunded commitments. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Withdrawals directed by a Plan Sponsor must be preceded by a 60-day written notice to the Trustee; provided, however, that the Trustee may, in its discretion, complete any such plan-level withdrawals before the expiration of such 60-day period. There are no reserves against contract value for credit risk, contract issues or restrictions.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. Parties-In-Interest**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the custodian are considered party-in-interest transactions.

**7. Income Tax Status**

The Plan has adopted the non-standardized pre-approved profit-sharing plan of Paychex, Inc. The non-standardized pre-approved profit-sharing plan sponsor received an advisory letter from the IRS dated October 31, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
