Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of New England Federal Credit Union Defined Benefit Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 4, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits (in liquidation) for the period January 1, 2023 to December 4, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 4, 2023 and December 31, 2022, and for the period January 1, 2023 to December 4, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of New England Federal Credit Union Defined Benefit Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, effective December 4, 2023 New England Federal Credit Union Defined Benefit Plan and Trust was fully liquidated and ceased to exist. As a result, the accompanying financial statements for the period January 1, 2023 to December 4, 2023 and for the year ended December 31, 2022 are prepared on the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of New England Federal Credit Union Defined Benefit Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following brief description of the New England Federal Credit Union Defined Benefit Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (a) General - The Plan was a noncontributory, defined benefit pension plan covering all employees of the New England Federal Credit Union (the "Company") prior to January 1, 2006 who had completed one year of service and attained the age of 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2022, the Plan was frozen to further benefit accruals. The Plan began termination procedures on January 1, 2023. After assets were distributed to participants and annuities were transferred, the remaining amount was determined to be an overfunding of the Plan. The overfunded assets were sent back to the Company. Full liquidation of Plan assets was completed by December 4, 2023.

- (b) Administration of Plan Assets - The Plan's assets were maintained by the custodians of the Plan. Certain direct expenses were paid by the Plan. All other administrative expenses were paid by the Company.
- (c) Pension Benefits - Participants were entitled to choose an annuity contract which would provide monthly pension benefits or lump sum distributions at normal retirement age of 65, early retirement at age 55 with 15 years of service, or upon termination of service with the Company.

The normal retirement benefit was the sum of 45.25% of average salary to the amount of covered compensation, 9.75% of average salary in excess of such compensation, and ¼% of average salary times years of service in excess of 15 years with a pro-rata reduction for service less than 15 years.

Upon termination of employment prior to normal or early retirement, vested benefits were reduced by ½ of 1% for each month that the termination preceded normal retirement up to sixty months, and ¼ of 1% for each complete calendar month in excess of sixty months that the termination date precedes normal retirement date.

- (d) Death and Disability Benefits - If an eligible employee died before retirement, their spouse was entitled to an amount which would be payable as a survivor annuity under the joint and survivor annuity provisions of the Plan. Participants that became totally and permanently disabled were entitled to their actuarial equivalent of their vested benefit.
- (e) Vesting - Employees were 100% vested in their accrued benefit upon either completing five years of eligible service, attaining normal retirement age while employed, death, or becoming totally and permanently disabled.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

- (a) Basis of Accounting - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Effective January 1, 2022, the financial statements were presented on the liquidation basis of accounting.
- (b) Valuation of Investments - Investments were stated at fair value using quoted market prices in active markets. Purchases and sales of securities were recorded on a trade-date basis. Unrealized gains and losses were based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest and dividend income was accrued as earned.
- (c) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Payments of Benefits - Benefit payments were recorded when paid.
- (e) Subsequent Events - The Plan evaluated subsequent events through July 29, 2024, the date the Plan's financial statements were available to be used.

(3) Actuarial Methods, Assumptions and Present Value of Accumulated Plan Benefits

No recent actuarial valuation has been performed as the Plan began termination on January 1, 2023.

(4) Funding Policy

The Plan used the unit credit actuarial cost method in prior years. Under the unit credit actuarial cost method, the benefits of all participants were rolled into one benefit portion. The cost base was the combined future salary of all the participants. The cost of the Plan was computed as a level percentage of payroll each year. From year to year the percentage was adjusted so that the remaining cost of the Plan incorporates the effect of actuarial gains and losses.

The normal cost for the year was equal to the present value of the projected benefit to be earned in the next year with the policy above. The accrued liability was equal to the actuarial present value of the benefits earned as of the valuation date. The unfunded accrued liability was equal to the excess of the actuarial accrued liability over the actuarial asset value.

Funding Policy (continued)

The Company's policy was to make cash contributions to the Plan equal to the amount which was determined by the actuary as necessary to properly fund the benefit being accrued under the Plan. Such contribution would be made to the custodians of the Plan who were engaged for the safe keeping and investment of the trust fund assets and the payment of benefits.

The Plan met or exceeded the minimum ERISA requirements. The minimum required contribution for the 2023 plan year was \$0.

(5) Information Certified by the Custodians

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the custodians, Principal Life Insurance Company and Principal Trust Company, has certified to the completeness and accuracy of all types and amounts of investments reflected on the accompanying statements of net assets available for plan benefits in liquidation as of December 4, 2023 and December 31, 2022, and the related investment activity reflected in the statements of changes in net assets available for plan benefits in liquidation for the period January 1, 2023 to December 4, 2023 and for the year ended December 31, 2022.

(6) Plan Termination

The Company reserved the right to amend or terminate the Plan at any time. As discussed in Note 1, the Plan was terminated and all assets disbursed in 2023. The net assets of the Plan were allocated, as prescribed by ERISA and its related regulations.

(7) Related Party Transactions

The Plan had a number of service providers. Such parties were considered parties-in-interest under ERISA.

(8) Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used for the period January 1, 2023 to December 4, 2023 and for the year ended December 31, 2022.

Pooled separate accounts: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

(9) Income Taxes

The Plan obtained its latest determination letter dated January 17, 2002, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan had been amended since receiving the determination letter. However, the plan administrator believes that the Plan had been designed and was operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and concluded that as of December 4, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions. The plan administrator believed it was no longer subject to income tax examinations for years prior to 2020.
