**1. DESCRIPTION OF THE PLAN**

The following description of the Employees 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description (the “Plan Documents”) for a more complete description of the Plan’s provisions.

General

The Plan, originally organized as the Drummond 401(k) Plan, is a defined contribution plan established by the Drummond Communications, LLC under the provisions of Section 401(a) of the United States Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as well as certain provisions of the federal income tax laws.

Effective July 15, 2019, Drummond Communications, LLC dba Premier Locations (“Drummond” and “Plan Sponsor”) became the Plan Sponsor of the Plan and the Plan name was changed to Employees 401(k) Retirement Plan. The Plan was adopted by participating employers (collectively, including the Plan Sponsor, the “Drummond Companies”).

NBC Bancshares in Pawhuska, Inc. (“NBC”) established the NBC Bancshares in Pawhuska, Inc. Retirement Plan. Effective November 19, 2018, the Bank of Cushing Retirement Plan entered into a merger and transfer agreement to merge into the NBC Bancshares in Pawhuska, Inc. Retirement Plan, and those assets were transferred in March of 2019. NBC adopted the Plan effective July 15, 2019 with several of its own provisions, noted in the following disclosures (the Plan as adopted by NBC). The Plan as adopted by NBC was also adopted by participating employers (collectively, including NBC, the “NBC Companies”).

Effective January 1, 2022, the Plan was amended and restated by means of a Cycle 3 restatement. The Plan’s significant provisions are further outlined within the amended and restated Plan documents. Further, effective November 4, 2022, the Plan was amended to recognize prior service with Security State Bank of Oklahoma.

Effective October 10, 2023, the Plan was merged into a pooled employer employee benefit plan (“New Plan”). Accordingly, as of October 31, 2023, the Plan’s assets have been distributed to New Plan.

Employees who have reached age 21 and completed one year of service are eligible to participate in the Plan except for the following:

- Union employees
- Nonresident aliens
- Leased employees

Upon satisfying the eligibility requirements, employees may begin participating in the Plan on the first day of the plan year or the first day of the 7th month of the plan year.

Under the Plan as adopted by NBC, employees who have reached age 21 are immediately eligible to participate, except for the same employee exclusions as noted above.

The Trustees of the Plan are responsible for oversight of the Plan and, in conjunction with the Investments Committee determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

**1. DESCRIPTION OF THE PLAN (continued)**

Contributions

The Plan is funded through pre-tax and Roth employee deferrals and employer contributions.

Each year, a participant may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. Rollover contributions representing distributions from other qualified defined benefit or contribution plans are permitted and may be contributed prior to meeting the eligibility requirements for participation in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are not to exceed the limits imposed by Section 402(g) of the IRC.

The Plan as adopted by NBC operates as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. NBC Companies make a safe harbor matching contribution of 100% of the participant's deferral up to 4% of their compensation. The Drummond Companies may make discretionary matching and profit-sharing contributions which will be allocated in accordance with the plan document provisions. The NBC Companies may make discretionary matching and profit-sharing contributions which will be allocated in accordance with the plan document provisions.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of employer contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Prior to January 1, 2019, participants from NBC Companies who were active employees could borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. New loans are no longer permitted, but outstanding loans continue to be paid off. The loans, in the form of promissory notes, are secured by the balances in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the plan administrator.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for profit-sharing and matching contributions is based on vesting periods of service. Participants are credited with a period of service for each Plan year in which they are credited with 1,000 hours of service. A participant is always 100% vested in their matching and profit-sharing if they terminate employment on account of their death or disability.

Participants are 100% vested upon date of hire in NBC Companies' matching and profit-sharing contributions. Further, participants are vested in Drummond Companies' matching and profit-sharing contributions based on the schedule shown on the following page.

Payment of Benefits

On termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary. Additionally, the Plan allows for hardship and in-service withdrawals.

Forfeited Accounts

Forfeitures are used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan, such as employer contributions. During the period ended October 31, 2023, \$5,185 in forfeitures were transferred to New Plan. At October 31, 2023, forfeited non-vested accounts totaled \$0.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are presented on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Notes Receivable from Participants

Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses (Note 5). Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Recent Accounting Pronouncements

During the period ended October 31, 2023 and through July 26, 2024, there were several new accounting pronouncements issued by the Financial Accounting Standards Board ("FASB"). Each of these pronouncements, as applicable, has been or will be adopted by the Plan. Plan management does not believe the adoption of any of these accounting pronouncements has had or will have a material impact on the Plan's financial statements.

Date of Management Review

Subsequent events were evaluated through July 26, 2024, which is the date the financial statements were issued.

**3. UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The following is a summary of the Plan's asset information as of October 31, 2023 and December 31, 2022, and for the period ended October 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by, or derived from information provided by, Voya Retirement Insurance and Annuity Company (Trustee) and furnished to the Plan Administrator.

The Trustee also certified to the completeness and accuracy of \$548,482 of net depreciation in fair value of investments, \$21,865 in dividends and interest and \$2 of interest on notes receivable from participants related to the aforementioned Plan assets for the period ended October 31, 2023.

**4. FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1           Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2           Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and
- Level 3           Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at October 31, 2023.

*Mutual funds:* Valued at the net asset value or quoted market prices of shares held by the Plan at year end.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to their fair value measurement.

**5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL Regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (the “TPA”), investment managers, investment advisors, legal counsel, and Plan auditor.

The Plan’s recordkeeper and custodian is Voya Retirement Insurance and Annuity Company, its TPA is FuturePlan Administrative Services, LLC, and its investment advisor is Intellicents Inc. During the period ended October 31, 2023, the Plan made direct payments to certain parties-in-interest as allowed by ERISA as follows:

The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. TAX STATUS**

The Plan is a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with Cash or Deferred Arrangement. The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. DESCRIPTION OF THE PLAN**

The following description of the Employees 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description (the “Plan Documents”) for a more complete description of the Plan’s provisions.

General

The Plan, originally organized as the Drummond 401(k) Plan, is a defined contribution plan established by the Drummond Communications, LLC under the provisions of Section 401(a) of the United States Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as well as certain provisions of the federal income tax laws.

Effective July 15, 2019, Drummond Communications, LLC dba Premier Locations (“Drummond” and “Plan Sponsor”) became the Plan Sponsor of the Plan and the Plan name was changed to Employees 401(k) Retirement Plan. The Plan was adopted by participating employers (collectively, including the Plan Sponsor, the “Drummond Companies”).

NBC Bancshares in Pawhuska, Inc. (“NBC”) established the NBC Bancshares in Pawhuska, Inc. Retirement Plan. Effective November 19, 2018, the Bank of Cushing Retirement Plan entered into a merger and transfer agreement to merge into the NBC Bancshares in Pawhuska, Inc. Retirement Plan, and those assets were transferred in March of 2019. NBC adopted the Plan effective July 15, 2019 with several of its own provisions, noted in the following disclosures (the Plan as adopted by NBC). The Plan as adopted by NBC was also adopted by participating employers (collectively, including NBC, the “NBC Companies”).

Effective January 1, 2022, the Plan was amended and restated by means of a Cycle 3 restatement. The Plan’s significant provisions are further outlined within the amended and restated Plan documents. Further, effective November 4, 2022, the Plan was amended to recognize prior service with Security State Bank of Oklahoma.

Effective October 10, 2023, the Plan was merged into a pooled employer employee benefit plan (“New Plan”). Accordingly, as of October 31, 2023, the Plan’s assets have been distributed to New Plan.

Employees who have reached age 21 and completed one year of service are eligible to participate in the Plan except for the following:

- Union employees
- Nonresident aliens
- Leased employees

Upon satisfying the eligibility requirements, employees may begin participating in the Plan on the first day of the plan year or the first day of the 7th month of the plan year.

Under the Plan as adopted by NBC, employees who have reached age 21 are immediately eligible to participate, except for the same employee exclusions as noted above.

The Trustees of the Plan are responsible for oversight of the Plan and, in conjunction with the Investments Committee determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

**1. DESCRIPTION OF THE PLAN (continued)**

Contributions

The Plan is funded through pre-tax and Roth employee deferrals and employer contributions.

Each year, a participant may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. Rollover contributions representing distributions from other qualified defined benefit or contribution plans are permitted and may be contributed prior to meeting the eligibility requirements for participation in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are not to exceed the limits imposed by Section 402(g) of the IRC.

The Plan as adopted by NBC operates as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. NBC Companies make a safe harbor matching contribution of 100% of the participant's deferral up to 4% of their compensation. The Drummond Companies may make discretionary matching and profit-sharing contributions which will be allocated in accordance with the plan document provisions. The NBC Companies may make discretionary matching and profit-sharing contributions which will be allocated in accordance with the plan document provisions.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of employer contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Prior to January 1, 2019, participants from NBC Companies who were active employees could borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. New loans are no longer permitted, but outstanding loans continue to be paid off. The loans, in the form of promissory notes, are secured by the balances in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the plan administrator.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for profit-sharing and matching contributions is based on vesting periods of service. Participants are credited with a period of service for each Plan year in which they are credited with 1,000 hours of service. A participant is always 100% vested in their matching and profit-sharing if they terminate employment on account of their death or disability.

Participants are 100% vested upon date of hire in NBC Companies' matching and profit-sharing contributions. Further, participants are vested in Drummond Companies' matching and profit-sharing contributions based on the schedule shown on the following page.

Payment of Benefits

On termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary. Additionally, the Plan allows for hardship and in-service withdrawals.

Forfeited Accounts

Forfeitures are used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan, such as employer contributions. During the period ended October 31, 2023, \$5,185 in forfeitures were transferred to New Plan. At October 31, 2023, forfeited non-vested accounts totaled \$0.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are presented on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Notes Receivable from Participants

Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses (Note 5). Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Recent Accounting Pronouncements

During the period ended October 31, 2023 and through July 26, 2024, there were several new accounting pronouncements issued by the Financial Accounting Standards Board ("FASB"). Each of these pronouncements, as applicable, has been or will be adopted by the Plan. Plan management does not believe the adoption of any of these accounting pronouncements has had or will have a material impact on the Plan's financial statements.

Date of Management Review

Subsequent events were evaluated through July 26, 2024, which is the date the financial statements were issued.

**3. UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The following is a summary of the Plan's asset information as of October 31, 2023 and December 31, 2022, and for the period ended October 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by, or derived from information provided by, Voya Retirement Insurance and Annuity Company (Trustee) and furnished to the Plan Administrator.

The Trustee also certified to the completeness and accuracy of \$548,482 of net depreciation in fair value of investments, \$21,865 in dividends and interest and \$2 of interest on notes receivable from participants related to the aforementioned Plan assets for the period ended October 31, 2023.

**4. FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1           Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
  
- Level 2           Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and
  
- Level 3           Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at October 31, 2023.

*Mutual funds:* Valued at the net asset value or quoted market prices of shares held by the Plan at year end.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to their fair value measurement.

**5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL Regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (the “TPA”), investment managers, investment advisors, legal counsel, and Plan auditor.

The Plan’s recordkeeper and custodian is Voya Retirement Insurance and Annuity Company, its TPA is FuturePlan Administrative Services, LLC, and its investment advisor is Intellicents Inc. During the period ended October 31, 2023, the Plan made direct payments to certain parties-in-interest as allowed by ERISA as follows:

The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. TAX STATUS**

The Plan is a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with Cash or Deferred Arrangement. The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
