This is a summary of the Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for the CO.CO. COUNTY DRAIN CLEANING AND PLUMBING, INC. SALARY DEFERRAL 401(K) PLAN, EIN 81-1400040, Plan 001, for period January 1, 2024 through February 29, 2024. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, age/service weighted or new comparability, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

**Basic Financial Statement**

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$375,672. These expenses included \$697 in administrative expenses and \$374,975 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of February 29, 2024, compared to \$424,506 as of January 1, 2024. During the plan year, the plan experienced a decrease in its net assets of (\$424,506). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$48,834), including employer contributions of \$0, employee contributions of \$0, other contributions of \$0 and earnings from investments of (\$48,834).
