Independent Auditor's Report

To the Plan Administrator and Participants
GXO Logistics Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of GXO Logistics Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of GXO Logistics Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about GXO Logistics Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2023 AND 2022**

1. Description of Plan

The following description of the GXO Logistics Retirement Savings Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

GXO Enterprise Services, LLC (the "Company"), a subsidiary of GXO, established the Plan effective August 2, 2021.

On December 31, 2023, GXO completed the transfer of net assets available for benefits of \$54,737,985 and outstanding loan balances from the Plan to the GXO Logistics 401(k) Plan.

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (the "IRC").

Fidelity Management Trust Company ("Fidelity") was the trustee and recordkeeper of the Plan. At the time the Plan was established, the Company combined the assets of the Plan and the GXO Logistics 401(k) Plan into the GXO Defined Contribution Plan Master Trust ("Master Trust").

Overall responsibility for overseeing the Plan rested with the GXO Logistics, Inc. Retirement Plan Administrative Committee. Fidelity was responsible for the control of the Plan's assets, which were held in individual participant investment accounts.

Eligibility

Eligible employees were limited to certain employees previously participating in the XPO, Inc. Retirement Savings Plan. The Plan was closed to new participants.

Contributions

Participants could contribute up to 50% of eligible compensation subject to certain limitations. Upon reaching the age of 50, eligible employees could make additional catch-up contributions as allowed by the IRC. Participants could also roll over amounts representing distributions from other qualified defined contribution plans or individual retirement accounts into the Plan.

The Company made a non-discretionary basic contribution to eligible employees equal to 3% of eligible compensation. The Company, at its discretion, could make an additional 1 - 2% basic contribution of eligible compensation to eligible employees based on years of employment. Additionally, the Company implemented a discretionary transition contribution for select participants when the XPO Pension Plan was frozen in 2006. The transition contribution ranged from 1 - 3% of eligible compensation based on the employee's age and years of service on December 31, 2006.

Participant Accounts

Individual accounts were maintained by the Plan's record-keeper for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Each participant's account was charged with benefit payments, loan withdrawals, and an allocation of administrative expenses. The benefit to which a participant was entitled to is the benefit that was provided from the participant's vested account.

Vesting

Participants were fully vested in their account balances.

Investment Options

Fidelity served as trustee for all Plan investments. Participants directed the investment of their contributions and the Company's safe harbor matching contributions into one or more formal investment options offered by the Plan, including various mutual funds and collective investment trusts.

If a participant did not direct the investment of contributions, they were invested in the age-appropriate target date fund. Participants could change their deferral percentage and investment direction at any time.

Notes Receivable from Participants

The Plan had a loan provision allowing participants access to funds. The minimum loan amount was \$1,000 and could not exceed the lesser of \$50,000 or 50% of a participant's vested account balance (subject to administrative adjustment to ensure compliance with the 50% limit) and no more than three loans could be outstanding at any time. Loans were secured by the vested account balance of the participant. Loans could be made for a term not to exceed 54 months and bear interest at Reuters prime plus 1%. Due to the transfer of assets, there were no loans outstanding as of December 31, 2023.

Payment of Benefits

Participants could withdraw the vested value of their accounts upon retirement, disability, death or termination of employment. Participants could elect to receive distributions in a lump sum, installment payments or partial payments, or accounts could be rolled over into another IRS approved tax deferral account, as defined by the Plan. The Plan provided for mandatory distribution of account balances less than \$5,000 following termination of employment with i) the automatic rollover to an Individual Retirement Account ("IRA") of any mandatory distributions exceeding \$1,000 but equal to or less than \$5,000 for which the participant did not elect a direct rollover to an IRA or another qualified plan; and ii) a direct payment to the participant of any mandatory distributions less than \$1,000. Hardship withdrawals were permitted on demonstration of financial hardship, and all fully vested balances were available for distribution after the participant reaches the age of 59 ½.

Upon certain conditions, participants, while still employed by the Company, were permitted to withdraw, in a single sum subject to a minimum of \$500, a portion of their elective deferrals as a result of an immediate and heavy financial need.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The fair value of the Plan's interest in the Master Trust is based on the beginning-of-year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment gain or loss, less actual benefit payments to participants and administrative expenses. Investments in the Master Trust are reported at fair value, as more fully discussed in Note 7, "GXO Defined Contribution Plan Master Trust".

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on the trade-date basis.

Notes Receivable from Participants

Notes receivable from participants are carried at amortized cost plus accrued interest.

Payment of Benefits

Benefits paid to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included the Plan's participation in GXO Defined Contribution Plan Master Trust investment income.

3. Risks and Uncertainties

The Plan offers various investments that are generally exposed to various risks, such as interest rate, credit and overall market-volatility risks. Investments are reported at fair value. Due to the risk associated with certain investment securities, it is reasonably possible that the value of investment securities will change and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

4. Income Tax Status

Effective August 2, 2021, the Plan was adopted utilizing an individually designed plan document. The Plan received a favorable determination letter from the IRS dated September 13, 2022, that the Plan and related trust was designed in compliance with the applicable requirements of the IRC. Therefore, the Company believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2023. The Plan is subject to routine income tax examinations. However, there are currently no audits for any tax periods in progress.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

5. Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are investments managed by Fidelity. Additionally, certain investment fees are paid by Fidelity and are reflected in the Plan's share of Master Trust investment gains or losses for the period. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Additionally, the Plan sponsor, GXO Enterprise Services, LLC, is a party-in-interest to the Plan. The transactions between the Plan and the Plan sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements was provided and certified by the trustee, Fidelity Management Trust Company, as of December 31, 2023 and 2022 and for the years then ended as complete and accurate.

- Investment in GXO Defined Contribution Plan Master Trust
- Notes receivable from participants
- Plan's participation in GXO Defined Contribution Plan Master Trust investment income
- Interest on notes receivable from participants
- GXO Defined Contribution Plan Master Trust (see Note 7)

7. GXO Defined Contribution Plan Master Trust

The Master Trust was formed to hold the assets of the Plan and the GXO Logistics 401(k) Plan. Each plan has a divided interest in the Master Trust.

Fair Value Measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodology used as of December 31, 2023 and 2022.

Mutual funds - Valued at the daily closing price reported on the active market on which the individual securities are traded.

Common collective trusts - The Plan's interest in the common collective trusts are valued at the net asset value ("NAV") of the common collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trust at year-end. The NAV is used as a practical expedient to estimate fair value. Participant transactions can occur daily.

The common collective trusts include investments that are operated by a trust company that manages a pooled group of trust accounts. Common collective trusts combine the assets of various institutional investors to create a larger, well-diversified portfolio. The objectives of a common collective trust are to lower the costs to investors through economies of scale available by combining assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in units and represents a portion of the holdings of the fund.

The investments in common collective trusts can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading.
