### **Opinion**

We have audited the financial statements of Homeland Security Solutions Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 13, 2023 (in Liquidation) and December 31, 2022, and the related statement of changes in net assets available for benefit for the period from January 1, 2023 through December 13, 2023 (in Liquidation), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 13, 2023 (in Liquidation) and December 31, 2022, and the changes in its net assets available for benefits for the period from January 1, 2023 to December 13, 2023 (in Liquidation), in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. The assets of the Plan were fully distributed by December 13, 2023. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis. Our opinion is not modified with respect to that matter.

### ***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The schedule of reportable transactions is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. **Note 1. Description of Plan**

The following brief description of the Homeland Security Solutions Employee Stock Ownership Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan agreement for complete information.

***General***

Homeland Security Solutions, Inc. (the “Company”) established the Homeland Security Solutions Employee Stock Ownership Plan effective January 1, 2014. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (“ESOP”). The ESOP Committee of the Board of Directors controls and manages the operation and administration of the Plan. GreatBanc Trust Company serves as the trustee of the Plan (“Trustee”). The Plan is subject to the provisions of Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (“IRC”) and is also subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On October 31, 2014, the Plan purchased 300,000 shares of the Company’s common stock. The purchase was seller financed. The seller notes were assigned to the Company and the Plan entered into a term loan agreement with the Company. The Plan holds the stock in a trust established under the Plan. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- a) the accounts of employees in allocated stock (allocated) and
- b) stock not yet allocated to employees (unallocated).

***Plan Status***

On July 12, 2023, the Board of Directors of the Plan Sponsor resolved to terminate the Plan. In accordance with GAAP, the Plan has changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis as of December 13, 2023, and for the period from January 1, 2023 through December 13, 2023. The ongoing basis of accounting approximates the liquidation basis of accounting from January 1, 2023, through the date of termination July 12, 2023.

In accordance with the Plan termination, effective February 15, 2023, the Board of Directors of the Company amended the Plan to (i) freeze all new entry or participation in the Plan, (ii) cease employer contributions and allocations to participants’ accounts, (iii) provide for full and immediate vesting of participants in their accounts, and (iv) distribute all participants’ and beneficiaries’ accounts in a single lump sum cash payment.

***Eligibility***

The Plan covers substantially all employees of the Company, other than those who are covered by a collective bargaining agreement that provides retirement benefits, who have one year of service and are age 18 or older. Participants who do not have at least 1,000 hours of service during a plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for that year.

***Employer Contributions***

The Company is obligated to make contributions in cash to the Plan equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The Company is able to make additional discretionary contributions as needed. Participants are not permitted to make contributions to the Plan.

***Payment of Benefits***

Distributions are made in accordance with the following Plan policies:

Death, disability or retirement: distributions are paid by lump sum as soon as administratively possible after the allocation has been completed for the plan year of death, disability or retirement.

Termination with a vested balance of \$10,000 or less: distributions are paid by lump sum as soon as administratively possible after the allocation has been completed for the plan year of termination.

Termination with a vested balance of greater than \$10,000: distributions are paid in 5 annual installments as soon as administratively possible after the allocation has been completed for the plan year of termination and subsequent years.

Statutory diversification (available at age 55 and 10 years of participation): distributions are paid as soon as administratively possible after the allocation has been completed for the plan year of eligibility.

Required minimum distribution ("RMD"): distributions are paid as required.

To prevent any financial impairment to the Company, the Board of Directors will authorize distributions up to a maximum of \$100,000 annually. Should the potential distributions exceed \$100,000 in any given plan year, the priority order will be: 1) RMDs 2) statutory diversifications and 3) death, disability or retirement. Any remaining funds will be allocated pro-rata among requests associated with termination for other reasons.

***Voting Rights***

Except for matters which constitute a merger, consolidation, recapitalization, reclassification, liquidation, dissolution or sale of substantially all assets of the Company, shares of Company stock in the Plan shall be voted by the Trustee.

***Participant Accounts and Forfeitures***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who 1) retired, became disabled or died during the plan year or 2) are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of year account balance to all participants' beginning of year account balances or based on allocated Company common shares.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, the participant will vest in the balances in their account based on total years of service with the Company. Participants vest 20 percent per year of service, beginning with their second year. A participant is 100 percent vested after six years of credited service.

***Put Options***

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification will be offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify have that portion of their account converted to cash and transferred to the Company's 401(k) Plan.

***Forfeitures***

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. For the period from January 1, 2023 through December 13, 2023, no forfeitures were allocated to Plan participants. There were no unallocated forfeitures as of December 13, 2023 and December 31, 2022.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are valued at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Distribution fees are deducted from the distribution paid to the participant or beneficiary.

***Subsequent Events***

The Plan has evaluated events through July 31, 2024, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**     Observable inputs such as quoted prices in active markets.
- Level 2**     Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**     Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There were no plan assets as of December 13, 2023. There have been no changes in the methodologies used at December 13, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value.

***Money Market Mutual Fund***

Mutual funds are publicly traded investments and are valued daily at the closing price on the active market on which the funds are traded.

***Company Common Stock***

The Company common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow, net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

Level 3 assets are measured at fair value on a recurring basis for the period from January 1, 2023 through December 13, 2023. There were purchases of the Company's common stock of \$890,081 for the period from January 1, 2023 through December 13, 2023. There were no issuances and no transfers in and out of Level 3 assets for the period from January 1, 2023 through December 13, 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the Company stock could result in a different fair value measurement at the reporting date.

**Note 5. Loan Payable**

The seller notes were assigned to the Company and the Plan entered into a \$23,576,230 term loan agreement with the Company. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. As part of the termination and liquidation of the Plan, the Company's common stock was sold and the related seller notes were assumed by the buyer. There was no outstanding balance as of December 13, 2023.

**Note 6. Tax Status**

The Plan has not received a determination letter; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties in the estimates and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
