Dear Sir or Madam,

I am writing on behalf of PayrollMD regarding the late filing of Form 5500-SF for the PayrollMD 401k Plan for the plan year 2023. We acknowledge that the form was submitted after the due date, and we sincerely regret this oversight. We would like to provide an explanation for the delay and request that the associated penalties be waived due to reasonable cause.

The delay in filing occurred because a family member of a key employee responsible for filing was involved in a serious accident at the end of July. This unfortunate and unexpected event required immediate attention and prevented the timely processing of the necessary paperwork.

Once the situation was under control, we acted promptly to complete and file the required form as soon as possible. Additionally, we have implemented new procedures to ensure that all future filings are completed on time, even in the case of unforeseen personal emergencies.
