#### **Note 1 - Description of the Plan**

The following description of the Ainsworth Engineered Pension Plan for Minnesota OSB Employees (the Plan) is provided for general information purposes. Participants should refer to the plan document for more complete information.

**General** - The Plan is a defined benefit pension plan established September 22, 2004, to provide retirement benefits for eligible hourly and salaried employees of Ainsworth Engineered (USA), LLC. On July 29, 2008, Ainsworth Lumber Co. Ltd. (Ainsworth), the Canadian parent company of Ainsworth Engineered (USA), LLC effected a recapitalization whereby the existing bondholders of Ainsworth received an approximate 96 percent stake in Ainsworth. As part of the recapitalization process, Ainsworth Engineered (USA), LLC, the prior plan sponsor of the Plan, was liquidated and a successor plan sponsor, Ainsworth Engineered LLC (the Company), was created.

Effective March 31, 2015, Ainsworth merged with Norbord Inc. (Norbord). Under the terms of the transaction, Norbord acquired all of the outstanding common shares of Ainsworth in an all-share transaction and Ainsworth became a wholly-owned subsidiary of Norbord. On July 15, 2015, Ainsworth was amalgamated with Norbord, and as a result, Norbord became the parent company of Ainsworth Engineered, LLC. On February 1, 2021 West Fraser Timber Co. Ltd. (West Fraser) acquired all of the outstanding common shares of Norbord, and as a result, West Fraser became the parent company of Ainsworth Engineered, LLC.

Eligible hourly employees were employed by the Company in the Grand Rapids, Minnesota OSB manufacturing facility which is no longer owned by Ainsworth or the Company. They were paid on the Company's United States payroll on an hourly basis and the terms of their employment were subject to collective bargaining between the Company and their union. Eligible salaried employees were employed by the Company and were paid on the Company's bi-weekly United States payroll. Eligible salaried employees also included any former employees receiving benefits under the Company's disability plan. The Retirement Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. US Bank National Association serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Freeze** - During 2009, the Plan's management elected to freeze the Plan. Effective July 31, 2009, benefits and years of service will no longer accumulate and no new participants are allowed to enter the Plan.

**Plan Termination** - On January 14, 2022, the Board of Managers of the Company adopted a resolution authorizing and approving the termination of the Plan and a plan of liquidation effective March 31, 2022. Management determined liquidation is imminent.

The Company entered into an agreement with United of Omaha Life Insurance Company (United) to purchase an annuity contract in order to satisfy the Plan's remaining benefit obligations. On January 20, 2023, a final premium payment of approximately \$4,004,000 was made from the Plan to United in connection with this agreement. Effective March 1, 2023, United is responsible for making benefit payments directly to the Plan's remaining participants.

Upon plan termination, the plan document allows for any excess funds after liabilities have been satisfied to revert back to the Company. A reversion was made to the Company in the amount of approximately \$150,000 during October 2023. The reversion to the Company was not subject excise or federal income taxes since it was deemed to be due to a "mistake of fact" contribution to the Plan.

**Pension Benefits** - Participants with five years of continuous service, as defined by the Plan, are entitled to pension benefits upon retirement. Pension benefits are provided to participants under several types of retirement options based upon years of continuous service and age. Retirement benefits are paid to pensioners or beneficiaries in various forms including single life annuities, joint and survivor annuities, certain and life annuities, or level income annuities.

**Death and Disability Benefits** - If an active employee with five or more years of vesting service dies, a death benefit is paid to the employee's beneficiary. Active hourly employees with ten or more years of vesting service who become permanently disabled receive disability benefits that are equal to the normal retirement benefits they have accumulated as of the time they become disabled.

**Funding** - Contributions to provide benefits under the Plan are made solely by the Company. The Company's funding policy is to make cash contributions to the Plan in amounts as determined by the Plan's independent actuary. For the period ended November 7, 2023 and the year ended December 31, 2022, the Company has met the minimum funding requirements of ERISA.

#### **Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP). Due to the termination of the Plan effective March 31, 2022, the 2023 and 2022 financial statements have been prepared subject to the liquidation basis of accounting as described in Accounting Standards Codification 205. The Plan will dispose of its assets and settle its liabilities by making benefit payments to participants, funding an annuity to settle the remaining benefit obligations, and by paying administrative expenses to service providers and the PBGC. The Company assumes that all net assets will be disposed of in an orderly manner, and that there is no expected change in value of assets that would be due to the decision to liquidate remaining assets in the Plan. Liabilities are incurred and measured based on estimated costs to be incurred in the process of disposing assets, including PBGC premiums and trustee fees.

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits, and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Administrative Expenses** - Mutual funds are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Certain administrative expenses of the Plan are paid by the Plan, as provided in the plan document, and all other administrative expenses are paid by the Company. The Company provides accounting and other administrative services to the Plan at no charge.

**Subsequent Events** - The Plan's management has evaluated subsequent events through July 23, 2024, the date on which the Plan's financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 7, 2023 and December 31, 2022.

Mutual Fund - Valued at the daily closing price reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily value net asset value and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Money Market Account - The Plan's money market account is valued at cost plus accrued interest, which approximates fair value.

**Note 4 - Accumulated Plan Benefits**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service rendered by employees as of the valuation date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have deceased, and (c) present employees or their beneficiaries. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The Plan's actuarial present value of accumulated plan benefits increased by \$267,000 as a result of the Plan's termination effective March 31, 2022. Significant assumptions used to determine the increase include annuity purchase rates ranging from 3.40% to 3.71%, lump sum payment interest rates ranging from 1.02% to 3.08%, and 50% of terminated vested participants would take a lump sum distribution during the window of availability.

The Plan's actuarial present value of accumulated plan benefits as of December 31, 2022, is primarily based on the final premium paid to United to cover Plan obligations as a result of the Plan's termination. United uses proprietary models and adheres to life insurance reserving requirements to calculate the final premium. The final premium also incorporates United's own set of assumptions to calculate the amount needed to cover Plan obligations. The "Other changes" component noted above reflects actuarial (gains)/losses as well as differing assumptions used by United to calculate Plan obligations compared to those used as of December 31, 2021.

The significant actuarial assumptions used in the December 31, 2021 valuation are as follows:

Discount Rate:	2.60%
Mortality:	Base Table: Pri-2012 benefits weighted table. Projection: Mortality rates are projected generationally from 2012 using Scale MP-2021.
Retirement Age:	55 for terminated vested participants (65 if not eligible for early retirement).

The interest rate used to discount the obligation as of December 31, 2021 includes a reduction of 0.25% to reflect anticipated administrative expenses associated with providing benefits.

**Note 5 - Partial Plan Termination**

During the fourth quarter of 2008, the Company announced the permanent closure of its mills located in Minnesota. As a result, the Company determined the Plan experienced a partial plan termination. All participants that had any service during 2008 became 100% vested in their accounts. The actuarial present value of accumulated plan benefits reflects the effect of the partial plan termination.

**Note 6 - Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the net assets of the Plan will be allocated for payment of plan benefits to the participants in an order of priority determined in accordance with ERISA, applicable regulations thereunder, and the plan document. As described in Note 1, the Company adopted a resolution authorizing and approving the termination of the Plan effective March 31, 2022.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal-age retirement benefits, early retirement benefits, and certain disability and survivor's pensions; however, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, subject to a statutory ceiling on the amount of an individual's monthly benefit. Whether all participants receive their benefits when the Plan terminates will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid, and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all.

**Note 7 - Parties-in-Interest Transactions**

The Plan invested in a US Bank money market account. US Bank National Association serves as the trustee of the Plan. Therefore, the Plan's transactions with this investment and fees charged by the trustee qualify as party-in-interest transactions.

**Note 8 - Tax Status**

The Company has received a favorable determination letter from the Internal Revenue Service (IRS) dated May 30, 2017, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

On February 15, 2022, the Plan filed for a determination letter from the IRS advising that the termination of the Plan does not adversely affect the qualified status of the Plan. During 2022, the Company received an updated determination letter from the IRS dated September 13, 2022.

**Note 9 - Risks and Uncertainties**

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, employee demographics, and anticipated liquidation related expenses, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
