Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Enable, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Emphasis of Matter

As discussed in Note 1(a) to the financial statements, the Plan Sponsor's Board of Directors approved a plan of liquidation with a termination date of October 1, 2023, and accordingly, determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

(1) Description of plan

The following description of the Enable, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was established to provide retirement benefits for employees of Enable, Inc. (the "Plan Sponsor"). The Plan covered substantially all employees that had completed sixty days of service (participants). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). 401k SAFE, LLC (the "Plan Administrator") was responsible for oversight of the Plan.

In connection with the sale of the Plan Sponsor in October 2023, the decision was made to terminate the Plan effective October 1, 2023. As such, all contributions to the Plan ceased as of September 30, 2023. All of the Plan's funds were distributed by December 31, 2023. As a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

(b) Contributions

Prior to October 1, 2023, participants could voluntarily make qualified retirement contributions to the Plan which were deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code (IRC) or after-tax in the form of a Roth 401(k) contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

Employer safe harbor matching contributions were permitted for all eligible employees who were at least 18 years old and had earned 1,000 hours of service. During 2023 and 2022, the Employer made safe harbor matching contributions equal to 100% of the eligible compensation deferred by each participant up to a maximum of 4% of the participant's eligible compensation deferred by each participant.

Employer and participant contributions could not exceed the maximum amount allowable for income tax purposes.

(c) Participant accounts

Each participant's account was credited or charged with the participant's contributions, Employer contributions, investment earnings (losses) of the investment options selected by the participants, and an allocation of administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Prior to the approval to terminate the Plan, participants were immediately vested in their elective salary deferral contributions and Plan Sponsor safe harbor matching contributions plus actual earnings (losses) thereon.

(e) Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants were secured by the balances in the respective participants accounts and bore interest at fixed rates ranging from 4.25% to 8%, which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive a lump sum payment equal to the value of the participant's entire interest in their account. For termination of service due to other reasons, a participant was entitled to receive the value of the vested interest in his or her account as a lump sum distribution.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(h) Administrative expenses

Certain administrative expenses were paid by the Plan Sponsor; while certain administrative expenses were paid by the Plan. Fees related to the administration of distributions and notes receivable from participants were charged directly to the applicable participants' accounts. Certain fees incurred by the Plan for the investment management services were netted within net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

As described in Note 1(a) of the financial statements, the Plan Sponsor's Board of Directors elected to terminate the Plan, with the Plan being liquidated by December 31, 2023. In accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), the Plan changed its basis to the liquidation basis as of December 31, 2023, and for the period from January 1, 2023 to December 31, 2023.

(b) Investment valuation and income recognition

Investments were stated at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value as of December 31, 2022. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies by utilizing information provided by Voya Retirement Insurance and Annuity Company ("Voya"). See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract at contract value.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year or period.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements, including the fair and contract value of investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividend income for the years ended December 31, 2023 and 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya.

(4) Investments measured at net asset value using the practical expedient

The Plan's pooled separate accounts were measured at net asset value (NAV) as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

The following table summarizes investments for which fair value was measured using NAV as a practical expedient as of December 31, 2023 and 2022. There were no participant redemption restrictions for these investments.

The Plan held various pooled separate accounts that were not direct filing entities. These pooled separate accounts had investment strategies that included various target date and lifestyle funds, international and sector funds, equity and income funds.

(5) Investment contracts with insurance companies

The Plan maintained a Guaranteed Investment Contract (GIC) related investment option with Voya, the Voya Fixed Account. The contract underlying this investment option was considered to be fully benefit-responsive. As of December 31, 2022, the contract value of the investment in the Voya Fixed Account was \$109,684.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of the invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The underlying contract had no restrictions on the use of Plan assets and there were no valuation reserves recorded to adjust contract amounts. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the plan documents (including a complete or partial plan merger with another plan) (ii) changes to the Plan's prohibition on competing investment options; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Voya Fixed Account did not permit Voya to terminate the agreement prior to the scheduled maturity date.

(6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated the non-standardized pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the Plan Administrator believes that the Plan, as amended, was designed and operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2023 and 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related-party and party-in-interest transactions

During 2023 and 2022, plan investments consisted of pooled separate accounts and a guaranteed investment contract which were managed by Voya, and, therefore, these transactions qualified as party-in-interest transactions. As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualified as party-in-interest transactions.
