## INDEPENDENT AUDITORS' REPORT

## **1. DESCRIPTION OF THE PLAN**

The following description of Professional Electric Products Co., Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Sonepar Management US Inc. officially acquired the stock of the Professional Electric Products, Co., Inc. (the Plan sponsor or the Company) on September 30, 2022. The Company continued to operate as a subsidiary of Sonepar Management US Inc. The Plan merged into the Sonepar USA 401(k) Plan on January 2, 2024.

The following key provisions of the Plan and footnotes are relative to the Plan prior to the Plan merger.

### **General**

The Plan is a defined contribution plan covering substantially all employees of the Company who are age 21 or older and who have completed at least 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees, which are designated individuals of the Company, are responsible for oversight of the Plan.

### **Contributions**

A participant in the Plan may elect to reduce their compensation up to the amount allowable by law and contribute such amount to the Plan on their behalf through either traditional or Roth contributions (participant elective deferral). The Plan sponsor ceased employer contributions effective August 28, 2009. Additional discretionary profit sharing contributions may be contributed annually as determined by the Board of Directors. A discretionary profit sharing contribution in the amount of approximately \$650,000 was made for the period April 1, 2023 to January 2, 2024. This contribution was remitted in 2024 to the Sonepar USA 401(k) Plan.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan administrator in 1% increments. Participants may change their investment options daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions as well as allocations of any profit-sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their elective contributions plus actual earnings thereon. Participants are 20% vested in the Sponsor's contributions plus actual earnings thereon less than two years of service and continue to vest an additional 20% per year; thereafter, until participants are 100% vested after six years of service.

**Payment of Benefits**

Participants are entitled to receive 100% of their account balance following normal retirement age 65, death or disability. If a participant is terminated prior to normal retirement, death or disability, they are entitled to receive only the vested portion of their account balance. Participants may elect to receive their benefits as a lump-sum. Benefits are recorded in the year requested by the participant.

**Participant Notes Receivables**

Participants may borrow from their fund accounts the lesser of: (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans from the plan during the one year period ending on the date before the date on which such loan is made; or (b) 50% of the present value of their non-forfeitable accrued benefit. Loan terms are amortized over a reasonable period of time, not-to-exceed five years. However, if the loan is used to acquire a principal residence, the loan may be repaid over a reasonable period of time that may be longer than five years.

**Forfeitures**

Forfeitures are used to reduce future Plan sponsor contributions or pay Plan expenses. As of January 2, 2024 and March 31, 2023, forfeitures totaled \$0 and \$10,500, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates and Risks and Uncertainties**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the guaranteed investment contract which is stated at contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through July 31, 2024, the date the financial statements were available to be issued, and all relevant, subsequent information is included within the applicable notes to the financial statements.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN ASSETS**

Certain information related to investments disclosed in the accompanying financial statements as of March 31, 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by the Nationwide Life Insurance Company as the custodian of the group annuity contract and Nationwide Trust Company as the custodian of the separate accounts.

**4. FAIR VALUE MEASUREMENTS**

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of January 2, 2024 and March 31, 2023.

*Separate accounts (in 2023):* The valuations of the investment in the pooled separate accounts are based upon the net asset value (NAV) as provided by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The Plan uses fair value measurements to record fair value adjustments to certain assets and liabilities and to determine fair value disclosures. In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy:

- Level 1 – Financial assets and liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access. These include investments that are recorded at fair value on a recurring basis and fair value measurement is based upon quoted prices, if available. Securities valued using Level 1 inputs include those traded on an active exchange and other exchange trade securities.
- Level 2 – Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable either directly or indirectly for subsequently the full term of the asset or liability.
- Level 3 – Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

Due to the Plan merger, there were no investments held by the Plan as of January 2, 2024.

## **5. GROUP ANNUITY CONTRACT**

The Plan has a fully benefit-responsive investment contract with Nationwide Life Insurance Company (Nationwide). Nationwide maintains the contributions in the Nationwide general account. The account is credited with earnings on the underlying investments at guaranteed crediting rates and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. When establishing interest crediting rates for this contract, Nationwide considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account. These rates are established without the use of a specific formula.

Generally, there are no events that would limit the Plan's ability to transact at contract value with Nationwide.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan sponsor contributions.

## **7. TAX STATUS**

The Plan adopted a non-standardized prototype plan sponsored by FIS Business Systems LLC. The prototype plan has received an opinion letter, dated June 30, 2020, from the IRS as to the prototype's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since the prototype received the opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. RELATED PARTY TRANSACTIONS**

Nationwide Life Insurance Company is the custodian of the group annuity contract and the Nationwide Trust Company is the custodian of the separate accounts which holds the mutual fund platform. Moskal Gross Orchosky Inc. serves as the Plan's third party administrator (TPA) and MGO Investment Advisors, Inc. is the investment advisor for the Plan. Administration and investment management fees paid by the Plan are included within administrative fees within the statement of changes in net assets available for benefits for the period April 1, 2023 to January 2, 2024.



## INDEPENDENT AUDITORS' REPORT

### **Opinion on the 2024 Financial Statements**

We have audited the accompanying financial statements of Professional Electric Products Co., Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of January 2, 2024, and the related statement of changes in net assets available for benefits for the period April 1, 2023 to January 2, 2024, and the related notes to the financial statements.

## **1. DESCRIPTION OF THE PLAN**

The following description of Professional Electric Products Co., Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Sonepar Management US Inc. officially acquired the stock of the Professional Electric Products, Co., Inc. (the Plan sponsor or the Company) on September 30, 2022. The Company continued to operate as a subsidiary of Sonepar Management US Inc. The Plan merged into the Sonepar USA 401(k) Plan on January 2, 2024.

The following key provisions of the Plan and footnotes are relative to the Plan prior to the Plan merger.

### **General**

The Plan is a defined contribution plan covering substantially all employees of the Company who are age 21 or older and who have completed at least 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees, which are designated individuals of the Company, are responsible for oversight of the Plan.

### **Contributions**

A participant in the Plan may elect to reduce their compensation up to the amount allowable by law and contribute such amount to the Plan on their behalf through either traditional or Roth contributions (participant elective deferral). The Plan sponsor ceased employer contributions effective August 28, 2009. Additional discretionary profit sharing contributions may be contributed annually as determined by the Board of Directors. A discretionary profit sharing contribution in the amount of approximately \$650,000 was made for the period April 1, 2023 to January 2, 2024. This contribution was remitted in 2024 to the Sonepar USA 401(k) Plan.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan administrator in 1% increments. Participants may change their investment options daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions as well as allocations of any profit-sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their elective contributions plus actual earnings thereon. Participants are 20% vested in the Sponsor's contributions plus actual earnings thereon less than two years of service and continue to vest an additional 20% per year; thereafter, until participants are 100% vested after six years of service.

**Payment of Benefits**

Participants are entitled to receive 100% of their account balance following normal retirement age 65, death or disability. If a participant is terminated prior to normal retirement, death or disability, they are entitled to receive only the vested portion of their account balance. Participants may elect to receive their benefits as a lump-sum. Benefits are recorded in the year requested by the participant.

**Participant Notes Receivables**

Participants may borrow from their fund accounts the lesser of: (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans from the plan during the one year period ending on the date before the date on which such loan is made; or (b) 50% of the present value of their non-forfeitable accrued benefit. Loan terms are amortized over a reasonable period of time, not-to-exceed five years. However, if the loan is used to acquire a principal residence, the loan may be repaid over a reasonable period of time that may be longer than five years.

**Forfeitures**

Forfeitures are used to reduce future Plan sponsor contributions or pay Plan expenses. As of January 2, 2024 and March 31, 2023, forfeitures totaled \$0 and \$10,500, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates and Risks and Uncertainties**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the guaranteed investment contract which is stated at contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through July 31, 2024, the date the financial statements were available to be issued, and all relevant, subsequent information is included within the applicable notes to the financial statements.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN ASSETS**

Certain information related to investments disclosed in the accompanying financial statements as of March 31, 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by the Nationwide Life Insurance Company as the custodian of the group annuity contract and Nationwide Trust Company as the custodian of the separate accounts.

**4. FAIR VALUE MEASUREMENTS**

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of January 2, 2024 and March 31, 2023.

*Separate accounts (in 2023):* The valuations of the investment in the pooled separate accounts are based upon the net asset value (NAV) as provided by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The Plan uses fair value measurements to record fair value adjustments to certain assets and liabilities and to determine fair value disclosures. In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy:

- Level 1 – Financial assets and liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access. These include investments that are recorded at fair value on a recurring basis and fair value measurement is based upon quoted prices, if available. Securities valued using Level 1 inputs include those traded on an active exchange and other exchange trade securities.
- Level 2 – Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable either directly or indirectly for subsequently the full term of the asset or liability.
- Level 3 – Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

Due to the Plan merger, there were no investments held by the Plan as of January 2, 2024.

## **5. GROUP ANNUITY CONTRACT**

The Plan has a fully benefit-responsive investment contract with Nationwide Life Insurance Company (Nationwide). Nationwide maintains the contributions in the Nationwide general account. The account is credited with earnings on the underlying investments at guaranteed crediting rates and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. When establishing interest crediting rates for this contract, Nationwide considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account. These rates are established without the use of a specific formula.

Generally, there are no events that would limit the Plan's ability to transact at contract value with Nationwide.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan sponsor contributions.

## **7. TAX STATUS**

The Plan adopted a non-standardized prototype plan sponsored by FIS Business Systems LLC. The prototype plan has received an opinion letter, dated June 30, 2020, from the IRS as to the prototype's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since the prototype received the opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. RELATED PARTY TRANSACTIONS**

Nationwide Life Insurance Company is the custodian of the group annuity contract and the Nationwide Trust Company is the custodian of the separate accounts which holds the mutual fund platform. Moskal Gross Orchosky Inc. serves as the Plan's third party administrator (TPA) and MGO Investment Advisors, Inc. is the investment advisor for the Plan. Administration and investment management fees paid by the Plan are included within administrative fees within the statement of changes in net assets available for benefits for the period April 1, 2023 to January 2, 2024.
