Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Infused Solutions, L.L.C. 401(K) Profit Sharing Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statement of net assets available for benefits (in liquidation) as of December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the year then ended, the statement of net asset available for benefits (on-going) as of December 31, 2022 and the related statement of changes in net assets available for benefits (on-going) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Infused Solutions, L.L.C. 401(K) Profit Sharing Plan Trust's financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state of federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Infused Solutions, L.L.C. 401(K) Profit Sharing Plan Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





Emphasis of Matter

As discussed in Note 5 to the financial statements, the governing body of Infused Solutions, L.L.C. 401(K) Profit Sharing Plan Trust approved the termination of the Plan effective September 29, 2023 and management determined that liquidation is imminent. The Plan has changed its basis of accounting from on-going basis to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified in respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Infused Solutions, L.L.C. 401(K) Profit Sharing Plan Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Note 1 - Description of Plan

The following description of the Infused Solutions, L.L.C 401(K) Profit Sharing Plan Trust provides only general information. The Plan name was changed from Infused Solutions L.L.C. the Contractors Retirement Plan and the custodian was changed effective December 1, 2014. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, effective January 1, 2001, is a defined contribution and profit-sharing plan covering substantially all full-time employees of Infused Solutions, L.L.C. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan was amended effective May 17, 2022 for Cycle 3 restatement. The plan will terminate effective September 29, 2023.

Plan administration

The Plan is sponsored by Infused Solutions, L.L.C. (the "Company"). The Plan is currently administered by ADP. At December 31, 2023 and 2022, the trustee was Reliance Trust Company.

Eligibility

All employees who have reached 21 years of age and three consecutive months of service are eligible to participate in the Plan for elective deferrals. For matching contributions and non-elective contributions, all employees must have one year of service. After meeting the eligibility requirements, an employee becomes a member of the Plan on the first day of the month occurring on or after his/her qualification.

Contributions

Contributions to the Plan are made primarily for employees rendering services for the Company on contracts subject to the Davis-Bacon Act, Service Contract Act, or a state or municipal prevailing wage law. Such contributions are determined by the Company. These contributions may be utilized to satisfy the wage determination issued by the governmental agency responsible for the contract subject to the prevailing wage law.

The Plan provides for both pre-tax and ROTH participant contributions. Eligible employees may contribute a dollar amount or a percentage of annual compensation up to certain limitations in the Internal Revenue Code. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. In addition, the Company may make discretionary matching contributions, profit sharing contributions and prevailing wage contributions not to exceed the Federal statutory maximum. The Company did not make a discretionary match contribution or a profit sharing contribution in 2023 and 2022.

Participant accounts

Each participant's account is credited with (a) the participant's contribution and the Company's contribution and (b) Plan earnings and then charged with an allocation of administrative expenses. Investment earnings are allocated to the account on a daily basis. Certain expenses directly reduce the company's account and other expenses directly reduce the investment earnings that are allocated. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant's account is divided into sub-accounts known as a voluntary contribution account, an employer prevailing wage contribution account, and where applicable, a rollover contribution account. During the year ending December 31, 2023 and 2022, the Plan permitted each participant to direct their investment to any of the 24 funds managed by Reliance Trust Company.

Notes receivable from participants

Participants may borrow from their fund accounts up to a maximum equal to fifty percent of their vested account balance or \$50,000, whichever is less. Participants must borrow a minimum of \$1,000. For year ending December 31, 2023 and 2022, the loans are secured by the participant's vested account balance. The interest rate will be determined on the first business day of each month and apply to all loans applied for in that month. The interest rate will be the current prime rate listed by the trustee plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability, hardship withdrawal or retirement, as defined in the Plan. In-service distributions are allowed for participants attaining age 59 ½. Up to 100% of the participant's vested account balance can be paid in a lump-sum, direct rollover to another qualified plan, or partial withdrawal, with the minimum being \$5,000, to the participant or their beneficiaries. Benefit claims are recorded as deductions when they have been approved for payment and paid by the Plan.

Upon showing of "financial hardship", a participant may withdraw the amount of the participant's financial need as well as applicable taxes.

Vesting

Participants are immediately 100% vested in the voluntary deferral contributions and the Company's prevailing wage contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures

At December 31, 2023 and 2022, the forfeited nonvested account balances were \$-0-. Forfeiture account balances are used to reduce employer contributions. During 2023 and 2022, forfeitures of \$-0- and \$-0- were used to offset employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the liquidation basis of accounting for 2023 and the accrual basis of accounting for 2022.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income

The Plan's registered investments are stated at fair value as of the last day of the Plan year. During 2023 and 2022, investments are valued based on share values as reported by Reliance Trust Company. During 2023 and 2022, the five common/collective trusts are fully benefit-responsive investment contracts and reported at contract value. These contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses. The fair value of the common/collective trust accounts represent the amount that would be paid at any time funds are withdrawn prior to their maturity for an event other than death, disability, termination, or retirement, and reflects the applicable surrender charge. A surrender charge is applied for transfers or withdrawals before the end of the guarantee period if the rate for new deposits is higher than the accounts guaranteed rate. Participant loans are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment, interest and dividend income are recorded on the accrual basis.

As described under FASB ASC 962-325-35 "*Plan Accounting – Defined Contribution Pension Plans*", the Plan values all fully-benefit responsive contracts at fair value, which is contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Common/collective trusts

Individual participant accounts for the common/collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes of net assets available for benefits.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Substantially all administrative expenses are paid by the Company. Certain transaction fees are paid by the Plan.

Concentration of credit risk

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

All of the plan investments are invested in marketable securities, which are subject to the financial risk of the United States financial market.

Note 3 – Fair value measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p style="text-align: center;">If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies - Valued at quoted net asset values of the shares actively traded on the market held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment in common collective trust

The Plan has benefit-responsive investment contracts in common collective trusts. The contracts are included in the financial statements at contract value as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract value of the investment contracts at December 31, 2023 and 2022 was \$-0- and \$167,372, respectively.

Certain events limit the Plan’s ability to transact at contract value. Such events include the following: (a) assignment of the contract to another party without consent of the issuer, (b) realization of full contract value is no longer probable, (c) amendments to the plan document or plan termination, or (d) participants are not permitted reasonable access to their retirement assets. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants are probably of occurring.

Note 5 – Plan termination

Effective September 29, 2023, the Plan will terminate. All participants became 100% vested in their accounts.

Note 6 – Income tax status

The Internal Revenue Service has determined and informed the Plan’s third-party administrator by a letter dated October 6, 2020, that the standardized prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the “IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, no uncertain positions are taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 7 – Information prepared and certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

Note 8 – Party-in-interest transactions

Although not required by the plan, a portion of the cost of plan administration was absorbed by the Company.

The Plan sponsors, owners and key management are also participants in the Plan. Their account balances totaled approximately 0% of the net assets available for benefits as of December 31, 2023 and 2022, respectively.
