Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of EXB Solutions Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 DESCRIPTION OF PLAN

The following description of the EXB Solutions Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for eligible employees of EXB Solutions, Inc. (the Company) who have reached the age of 21 and have 30 days of service.

The Company's investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was acquired by Quest Defense Systems & Solutions, a subsidiary of Quest Global, on September 1, 2022. The Plan was merged into the Quest 401(k) Plan effective January 1, 2024. Due to the New Year's holiday, the assets were transferred on January 2, 2024 when the markets reopened. Eligible employees became eligible to participate in the Quest Global 401(k) Plan effective January 1, 2024.

Contributions

Prior to January 1, 2024, participants were able to contribute up to 100% of eligible compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participant contributions were made on a pre-tax basis or after tax as Roth contributions. The Plan had an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elected not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions were automatically invested in a designed balanced fund until changed by the participant. In addition, employees who were automatically enrolled in the Plan had their deferral rate increase by 1% annually, up to 12%, unless they opted out.

For the year ended December 31, 2023, Company made a discretionary matching contribution equal to 33% of the first 9% of eligible compensation. In addition, the Company had the option to make profit sharing contributions but did not elect to make such contributions for the year ended December 31, 2023. No contributions were made to the Plan during the period from January 1, 2024 through January 2, 2024.

All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (the Code).

Participant Accounts

Each participant's account was credited with the participant's contributions and Company contributions, and allocations of Plan earnings and losses. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income and administrative expenses were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants were able to direct contributions into any of the funds offered by the Plan, which were held at Reliance Trust Company (Reliance). These funds included a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants became immediately vested in their deferral and rollover contributions, including the earnings and losses on those amounts. Vesting in discretionary Company contributions was based on years of credited services. A participant became fully vested in Company contributions after three years of credited service. In addition, participants became fully vested upon reaching normal retirement age, death or disability.

Notes Receivable from Participants

Prior to January 1, 2024, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms ranged from one to five years, except for loans to purchase a primary residence, which were offered over a longer term. The loans were secured by the balance in the participants' accounts and bore interest at rates commensurate with local prevailing rates, as determined by the Plan administrator. Generally, principal and interest were paid ratably through payroll deductions. In connection with the merger and transfer of assets to the Quest Global 401(k) Plan, loan balances totaling \$109,550 were transferred out of the Plan to the Quest Global 401(k) Plan on January 2, 2024.

Payment of Benefits

Upon retirement, disability, death, or termination of employment, participants became entitled to the total value of his or her vested account. Distributions were paid in a lump sum or in installments over a number of years, based upon election of the participant or as defined in the Plan or the Code. If a participant terminated employment for any reason and his or her vested account balance did not exceed \$1,000, the Plan administrator could distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance was between \$1,000 and \$5,000, the Plan administrator could roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

The Plan also provided for in-service withdrawals by participants who have attained the age of 59½. In addition, upon financial hardship, a participant was entitled to the value of his or her fully vested accounts, which was payable immediately in a lump-sum distribution.

Forfeitures

Forfeitures of nonvested balances, discretionary matching contributions and discretionary profit sharing contributions were used to pay eligible Plan expenses or offset discretionary Company contributions. Forfeited nonvested discretionary matching and profit sharing accounts totaled \$-0-, \$3,642 and \$8,707 at January 2, 2024, December 31, 2023 and December 31, 2022, respectively. During 2023, the Company used forfeitures totaling \$29,773 to offset Company matching contributions. In connection with the merger and transfer of assets to the Quest Global 401(k) Plan, forfeiture balances totaling \$3,631 were transferred out of the Plan to the Quest Global 401(k) Plan on January 2, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through June 24, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATIONS BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and supplemental schedule as of January 2, 2024, December 31, 2023, and December 31, 2022, and for the period January 1, 2024 through January 2, 2024 and for the year ended December 31, 2023, for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Reliance Trust Company, the Trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market and Mutual Funds: Money market and mutual funds are valued using the quoted price of shares held by the Plan at year-end.

Stable Value Collective Trust Fund: The common and collective trust is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2023 and 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the merger and transfer of assets to the Quest Global 401(k) Plan, the Plan held no assets at fair value as of January 2, 2024. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023 and 2022:

(a) Certain investments that are measured using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

There were no transfers between levels of investments during the period from January 1, 2024 through January 2, 2024 or for the year ended December 31, 2023.

Investments in the stable value collective trust fund provided for daily liquidity and there were no participant redemption restrictions on the fund.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by T. Rowe Price. T. Rowe Price serves as the recordkeeper of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company who participated in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the IRS that it was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
