To Whom it may concern:

As Trustee of the Lacey Medical Clinic, P. S. 401(K) Plan with a John Hancock Pension Plan contract number 18866, I formally request relief of penalties related to late filing of our Form 5500-SF for our Fiscal Year 2022 (1Oct2022-30sept 2023). EIN is 91-1525481. The office has closed 1February2022 for providing medical care and the business' need for any retirement plan will cease at the end of our current fiscal year, 30September2024.

While we have appreciated the long-term relationship with John Hancock, this year has offered long-awaited retirement. The past week has been especially difficult after receiving notification (26July2024) of the unexpected death of our plan's TPA, Michael Colasurdo, and inherent difficulties with plan administration (omissions) in his absence. On afternoon the 31st of July 2024, I received an email from James Colasurdo, the POA and apparent Executor of the Estate notifying me of the likely need for forms to be filed. Federal reports and 5500 forms had not been accessible to me but knowing that the plan would be terminated on 30 September 2024 offered conclusion to the need for any TPA or group relationship with John Hancock Retirement Plan Services. All employee participants have been advised to contact John Hancock to pursue rolling over their funds to individual retirement accounts before 30September2024.

Please understand the extenuating circumstances for the late filing and request for relief of penalties. I hope for relief based on reasonable cause for the late filing.
