SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Annapolis Pediatrics, P.A. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of November 30, 2023 and December 31, 2022, the related Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2023 to November 30, 2023, and the related notes to the financial statements.

NOTE 1 **DESCRIPTION OF PLAN**

The following description of the Annapolis Pediatrics, P.A. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined-contribution plan covering all employees of Annapolis Pediatrics, P.A. and its subsidiaries (collectively referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 30, 2023, the Plan merged with Trusted Doctors and their associated benefit plans. On November 30, 2023, the plan terminated. Participants' account balances were transferred into new accounts established with the new Plan Administrator, another financial institution or cash distribution was taken with tax implications.

ELIGIBILITY

Eligible employees may make deferrals into the Plan beginning the first day of the month following the month in which they became eligible.

CONTRIBUTIONS

Each year, participants may elect to defer up to the maximum amount of pretax annual compensation as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC). Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may designate some or all of their own contributions as Roth 401(k) contributions. Participants may also rollover distributions received from other qualified plans.

Under safe harbor provisions of the Plan, the Company makes matching contributions equal to 100% of a participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Company may also make non-elective discretionary contributions to the Plan. The Company did not make discretionary contributions during the period ended November 30, 2023.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances,

as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow against the balance in their accounts up to the lesser of 50% of their vested balance of \$50,000 with a minimum borrowing amount of \$1,000. Principal and interest are repaid through payroll deductions. Participants may also make additional loan payoff payments directly to the Plan.

VESTING

Participants are immediately vested in their contributions, rollover contributions, and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions is based upon years of service with full vesting obtained after six years or the attainment of normal retirement age, whichever is earlier.

PAYMENT OF BENEFITS

Benefits are payable as soon as practicable following normal retirement, retirement due to permanent disability, death, or termination of employment, subject to specific benefit payment requirements in the Summary Plan Description. If the balance of the account is less than \$5,000, the balance is automatically distributed as a lump-sum payment. Hardship withdrawals are permitted by the Plan.

FORFEITED ACCOUNTS

At November 30, 2023, the forfeited non-vested accounts did not have a balance. At December 31, 2022, forfeited non-vested accounts totaled \$148. These accounts can be used to reduce employer contributions or allocated to the participants in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for the Plan year.

ADMINISTRATIVE EXPENSES

Substantially all administrative expenses are paid by the Plan.

INVESTMENT OPTIONS

Plan assets are invested in various mutual funds designated by participants.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

BASIS OF PRESENTATION

The accompanying financial statements are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

VALUATION OF INVESTMENTS

The Plan's investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Summary Plan Description.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 17, 2024, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan’s investments were held by the Trustee, Reliance Trust Company, through November 30, 2023 and at December 31, 2022. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at November 30, 2023 and December 31, 2022.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan paid administrative fees of \$62,736 to the Trustee for the period ended November 30, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

NOTE 6 TAX STATUS

The Plan obtained its latest determination letter in October 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan since was amended and restated. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions taken as of November 30, 2023.
