### SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Bayhealth Medical Center, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and related notes to the financial statements.

### **EMPHASIS OF MATTER - PLAN TERMINATION**

As discussed in Note A to the financial statements, the Board of Directors of Bayhealth Medical Center, Inc. has approved a plan merger between the Bayhealth Medical Center, Inc. Savings Plan and the Bayhealth Medical Center, Inc. Retirement and Savings Plan. All participants of the Bayhealth Medical Center, Inc. Savings Plan became eligible for the Bayhealth Medical Center, Inc. Retirement and Savings Plan and all plan assets of the Bayhealth Medical Center, Inc. Savings Plan were transferred to the Bayhealth Medical Center, Inc. Retirement and Savings Plan effective December 31, 2023.

### **RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A - DESCRIPTION OF PLAN

The following description of the Bayhealth Medical Center, Inc. Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution savings plan available to eligible employees of Bayhealth Medical Center, Inc. (the "Medical Center"). The Bayhealth Medical Center Employee Benefit Plan Committee and the Plan administrator control and manage the operation and administration of the Plan. Lincoln Financial Group Trust serves as the trustee of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan began accepting participant contributions on July 1, 1999.

**Plan Termination** - All participants of Bayhealth Medical Center, Inc. Savings Plan became eligible participants of Bayhealth Medical Center, Inc. Retirement and Savings Plan effective December 31, 2023. All participants accounts and plan assets were transferred to the Retirement and Savings Plan, effective December 31, 2023. The Plan and related trust will cease to exist subject to provisions of ERISA.

**Eligibility** - This plan is limited to employees who are grandfathered into the Bayhealth Medical Center's Pension Plan. If a terminated Savings Plan participant with a remaining Savings Plan account balance is rehired, the participant's balance is rolled over into the Retirement and Savings Plan.

**Contributions** - Participants may contribute up to 100% of their annual compensation, as defined in the Plan, or such dollar limit as established by the Internal Revenue Service. For plan years ended before December 31, 2023, the Medical Center matches participant contributions at a rate of 50% of the first 4% of base compensation that a participant contributes to the Plan. For the plan year ended December 31, 2023, participants received a 3% annual retirement savings contribution and a matching contribution of 50% up to the first 6% of compensation. All participants who have completed at least 1,000 hours of service during the year are eligible for the matching contribution. Additional amounts may be contributed at the option of the Medical Center's Board of Directors.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, charged with withdrawals, as applicable, and credited with allocations of (a) the Medical Center's contributions, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on the proportionate value, as of the immediately preceding valuation date, of each participant's account to the value of all participant accounts, but adjusted for any additions or distributions since such date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Investments** - Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Medical Center's contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after three years of credited service. All participants are fully vested in their accounts as of December 31, 2023.

NOTE A - DESCRIPTION OF PLAN - CONTINUED

**Notes Receivable From Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note transactions are treated as a transfer between the investment fund and the note fund. Payments on notes are to be made at least quarterly, not to exceed 5 years. However, notes for the purchase of a primary residence may exceed the 5-year threshold and be repaid within a period of time that is determined by the Plan administrator at the time the note is granted. The notes are secured by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably (at least quarterly) through payroll deductions and automatic bank drafts. At December 31, 2023, the interest rates of participant notes receivable ranged from 4.25% to 8.50%.

**Payment Of Benefits And Withdrawals** - Participants (or their beneficiaries in the case of death during active employment) are entitled to the vested value of their participant accounts upon their retirement, death during active employment, or total disability, or termination of employment. In the event of death during active employment, or upon the attainment of early, disability or normal retirement, or attaining age 65, if earlier, a participant's benefit becomes fully vested and non-forfeitable.

Distributions are payable in a lump sum. If a participant dies after termination, a distribution of the vested portion of the deceased participant's account, if any, shall be made to the designated beneficiary.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are used to pay administrative expenses of the Plan and to fund future Medical Center discretionary and matching contributions. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$7, respectively. During the years ended December 31, 2023 and 2022, no employer contributions receivable were reduced by forfeitures.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis Of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting.

**Valuation Of Investments And Income Recognition** - Investments in money market funds, common stocks and registered investment companies are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan holds a fully benefit-responsive group fixed annuity contract with Lincoln Financial Group (LFG) as a stable value option. Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the price participants would receive if they were to initiate permitted transactions under the terms of Plan.

See Note D for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use Of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

**Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for uncollectible participant notes has been recorded as of December 31, 2023 and December 31, 2022.

**Plan Expenses** – Certain expenses of maintaining the Plan are paid directly by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

**Payment Of Benefits** - Benefits are recorded when paid.

**Subsequent Events** – During 2023, steps were taken to merge the Plan with the Bayhealth Medical Center, Inc. Retirement and Savings Plan. All Plan assets were scheduled for transfer on December 31, 2023. The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through July 31, 2024, the date the financial statements were available to be issued.

NOTE C - CERTIFIED ASSETS

All information on investments and notes receivable from participants included in the Plan's financial statements and supplemental schedule was obtained or derived from information prepared by Lincoln Financial Group Trust Company, trustee, and certified as complete and accurate.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles as required to measure the fair value. Generally accepted accounting principles require disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The generally accepted accounting principles require fair value measurement be classified and disclosed in one of the following three categories:

- Level 1 – inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 – inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

NOTE D - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Money Market Fund** - The money market fund is valued at cost which approximates fair value.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-Directed Brokerage Account** - These accounts hold common stocks which are valued at the closing price reported on the major market on which the individual securities are traded and are generally classified within Level 1 of the valuation hierarchy.

**Pooled Separate Accounts** - These investments are accounts maintained by an insurance company for the collective investment and reinvestment of assets contributed thereto from employee benefit plans maintained by more than one employer or controlled group of corporations. They are valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment, the insurance company reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

The following tables present the financial instruments carried at fair value as of December 31, 2023 and 2022, by caption on the Statements of Net Assets Available for Benefits and by the valuation hierarchy described above. The Plan did not have any level 2 or 3 investments in either year.

NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Lincoln Financial Group Stable Value Account is a fixed annuity contract and is reported at contract value which is the principal plus accrued interest and is provided by Lincoln Financial Group. Contributions received in any quarter will earn interest at the portfolio rate. The portfolio rate is declared for the quarter and is in effect only for that quarter. The portfolio rate is the 3 year average of the Barclays Capital Intermediate U.S. Government/Credit Index yield minus .50% as of one month prior to the beginning of each quarter. The contract can be discontinued at any time by giving Lincoln written notice and will be paid in a market value lump sum.

This Stable Value Option Investment is backed by the general account of Lincoln Financial Group and are fully benefit-responsive based on the following characteristics:

1. The Stable Value Option investment choice is a non-tradable obligation of Lincoln Financial Group. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Lincoln Financial Group.
2. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Lincoln Financial Group. However, if an event should occur such that realization of full contract value for a particular investment contract is no longer probable – for example, a significant decline in creditworthiness of Lincoln Financial Group, the Stable Value Option investment choice may no longer be considered fully benefit-responsive.
3. The terms of Lincoln Financial Groups Fixed Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to other investment choices within the plan.
4. Because the Stable Value Option investment choice is an obligation of Lincoln Financial Group, the occurrence of an event that limits the ability of the investment to transact at the contract value between Lincoln Financial Group and a participant holding the investment is not probable.
5. The Stable Value Option investment choice allows a participant reasonable access to their assets.

NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY - CONTINUED

While Lincoln Financial Group Trust Company guarantees a minimum interest rate and backs the principal and interest of these investment choices, any guarantees are subject to the claims paying ability of the insurance company. Although plan participants generally may withdraw assets from the Stable Value Option investment choice without restrictions, Lincoln Financial Group Trust Company may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance.

This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits in the particular investment choice are credited with the same interest rate on a daily basis, and with no set maturity. The effective credited interest rate is set monthly and effective on the first day of the month at a rate that is the daily equivalent of the effective annual rate of interest applicable for each month. The credited interest rate is backed by the income received from assets held in the general account. The Stable Value Option investment choice is not considered a Guaranteed Interest Contract (GIC). Contract charges may reduce this return.

NOTE F - RELATED PARTY TRANSACTIONS

The Plan invests in a stable value account, managed by Lincoln Financial Group, the servicing agent for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Fees are also paid by the Plan to Lincoln Financial Group Trust Company for investment management services and are reflected as a reduction of the return earned on each fund.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2023 and 2022. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2022 were \$54,223. Outstanding loans of \$69,289 as of December 31, 2023 were transferred to Bayhealth Medical Center, Inc. Retirement and Savings Plan.

NOTE G - TAX STATUS

The Plan record keeper obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). Although the Plan has been restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code. Accordingly, no provision for taxes has been reflected in the financial statements.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities and mutual funds. Investment securities and mutual funds, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities and mutual funds, it is reasonably possible that changes in the values of investment securities and mutual funds will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
