Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sequel Youth and Family Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 5, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to October 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Sequel Youth and Family Services 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of October 5, 2023 and December 31, 2022, and for the period from January 1, 2023 to October 5, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sequel Youth and Family Services 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Mater

As discussed in Note 7 to the financial statements, management of the Sequel Youth and Family Services 401(k) Plan resolved to terminate the plan. As of October 5, 2023, all plan assets have been distributed to all participants. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sequel Youth and Family Services 401(k) Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

General

The following description of Sequel Youth and Family Services 401(k) Plan (the “Plan”) provides only general information. Sequel Youth and Family Services, LLC was the sponsor of the Plan (the “Company” or “Plan Sponsor”). The Plan was a contributory, defined contribution 401(k) Plan available to qualifying employees of the Plan Sponsor. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective January 1, 2020. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Employees of the following companies were previously covered under the Plan prior to its termination:

- SYS of Arizona, LLC
- SYS of South Dakota, LLC
- SYS of Forest Ridge, LLC
- Sequel of Kansas, LLC fka Camelot of Kansas, LLC

- SequelCare of Florida, LLC
- Sequel TSI of Florida, LLC
- SequelCare of Maine, LLC
- SequelCare of Oklahoma, LLC
- Sequel TSI of Alabama, LLC

Effective February 28, 2022, the Plan has terminated, and all employees became fully vested. Refer to Note 7.

SECURE 2.0 Act

On December 29, 2022, the SECURE 2.0 Act was signed into law to enhance the retirement savings system. Principle areas of the act addressed automatic enrollment, required minimum distributions (“RMD”), and catch-up contributions. Effective January 1, 2023, the age requirement for minimum distributions was raised to 73 from 72 for any participant who turns 72 on or after January 1, 2023.

Eligibility

Employees who were at least 21 years of age and had completed 60 days of service were eligible to participate in the Plan on the first day of the month following meeting the eligibility requirements.

Contributions

Participant Contributions

Each year, participants may have contributed up to 90% of pretax eligible compensation, as defined by the Plan, not to exceed limits as set by the Internal Revenue Service (“IRS”). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also be permitted to rollover amounts representing distributions from other qualified retirement plans. Newly eligible participants of the Plan were automatically enrolled at a pretax deferral rate of 1%. All funds from automatic enrollments were invested according to the participant’s election. However, if participants did not make an election of investment allocation, their accounts were invested in the Plan’s qualified default investment alternative (“QDIA”), which was a target-date fund determined based on the participant’s date of birth. An eligible employee became a participant under the automatic enrollment requirement effective as of the first day of the month coinciding with or next following the date the employee met the eligibility requirement, provided said employee was still employed as of such date.

Company Matching Contributions

The Plan Sponsor may have elected to contribute a discretionary matching contribution. During the period from January 1, 2023 to October 5, 2023, the Plan Sponsor authorized no discretionary matching contributions.

Investment Options

Participants may have directed the investment of their contributions into various options offered by the Plan. The Plan offered various mutual funds, a common collective trust fund, and a guaranteed investment contract.

Participant Accounts

Each participant’s account was credited with the participant’s contributions and Company’s contributions. Plan earnings were allocated based on participant account balances. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account. Participant accounts were valued daily to reflect income earned.

Vesting

Participants were always fully vested in their deferral contributions and any earnings thereon. A participant was 100% vested in Company matching contributions after three years of credited service. Refer Note 7.

Notes Receivable from Participants

Participants borrowed from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount was \$1,000. The loans were secured by the balance in the participant’s account. Participants were only allowed one outstanding loan at a time. The interest rates for loans were equal to one percent above the prime rate. The loans were repaid ratably through payroll deductions over a period of five years or less, unless such loan was for the purchase of a participant’s primary residence.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of employment, a participant elected to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum payment. A participant may have withdrawn part of the vested interest in his or her account upon attainment of age 59 ½, subject to the Plan's provisions. For account balances less than \$5,000, a single lump sum payment would have been made automatically into an individual retirement account upon termination. The Plan also permitted hardship distributions to participants that could demonstrate an immediate and heavy financial need.

Forfeited Accounts

During the period from January 1, 2023 to October 5, 2023, participants forfeited \$0 in prior employer contributions. During the period from January 1, 2023 to October 5, 2023, \$1,532 in forfeited nonvested accounts were used to reduce administrative expenses. At October 5, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$1,528, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for the fully benefit-responsive guaranteed investment contract (“GIC”), which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent loans and were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recognized on the accrual basis. No allowance for credit losses had been recorded as of October 5, 2023 and December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loans to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Expenses

The Plan Sponsor paid the administrative costs associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent trustee fees and other recordkeeping fees paid directly from the Plan assets to the Plan's trustee. Loan fees and other administrative fees related to benefit payments were deducted directly from the participants' accounts.

Recently Adopted and New Accounting Principles

In June 2016, the FASB issued ASU No. 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments, and subsequent amendments to the initial guidance, ASU 2019-10. This accounting standard changes the methodology for measuring credit losses on financial instruments and the timing of when such losses are recorded. ASU No. 2016-13 is effective for fiscal years, and interim periods within those years, beginning after December 15, 2022. The Plan adopted the provisions of ASU 2016-13 for the period from January 1, 2023 to October 5, 2023. The adoption of this standard did not have a material impact on the Plan's financial statements.

Subsequent Events

Subsequent events have been evaluated through the date of the report of independent auditors, which is the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Information Prepared and Certified by the Custodian (unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 5, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the period from January 1, 2023 to October 5, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, collectively, the custodian of the Plan.

As permitted under such election, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurements

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 5, 2023, and December 31, 2022.

Common collective trust fund: Valued at the net asset value ("NAV") of units of the collective trust. The NAV is used as a practical expedient to estimate the fair value of the common collective trust. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Fair Value Measurements (continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets at fair value as of October 5, 2023 were \$0, as all assets in the Plan were distributed. Refer to Note 7.

5. Fully Benefit-Responsive Guaranteed Investment Contract

The Plan previously invested in a guaranteed investment contract (“GIC”), the Fixed Interest Fund, with the custodian that qualifies as a fully benefit-responsive investment contract.

The Fixed Interest Fund investment option was provided through a group annuity contract in which the Plan was invested. Under the terms of a group annuity contract, a crediting rate is established for amounts invested in the Fixed Interest Fund and participants may have directed permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. The interest rate credited on the contract varies based on a formula determined by the Plan custodian. The Plan considered this investment option to be fully benefit-responsive notwithstanding the liquidation value events under the contract that limit the ability of the Plan to transact at contract value.

Certain events limited the ability of the Plan to transact at contract value. Such events included but may not be limited to the following: (1) the Plan or Plan trust failed to maintain its exempt status under 401(a) of the IRC, (2) there was a termination or partial plan termination of the Plan, or (3) a provision of the contract was breached. Plan management resolved to terminate the Plan and all assets have been fully liquidated as of October 5, 2023. Refer to Note 7.

6. Related-Party and Party in Interest Transactions

Empower Annuity Insurance Company of America and Empower Trust Company, LLC provided certain administrative services to the Plan pursuant to a custodial agreement between the Plan and the custodian and insurance carrier. In addition, the insurance carrier was party to the GIC held by the Plan. The Plan issued loans to participants, which were secured by the vested balance in the participants’ accounts.

Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they were paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to the trustee, custodian, auditor, and third-party administrator totaling \$41,085. These costs incurred by the Plan are included in administrative expense on the statement of changes in net assets available for benefits. The Plan Sponsor paid directly any other fees related to the Plan’s operations.

7. Termination of the Plan

On February 28, 2022, plan management resolved to terminate the Plan. Upon termination, all participants with an account balance as of the date of termination became 100% vested. Participants with account balances were provided with notification of the termination and were provided instructions for processing distribution of their account balance. Plan management believes that the use of the liquidation basis of accounting would not result in a material difference to the Plan’s financial statements. As of October 5, 2023, all Plan assets have been distributed to all participants.

8. Income Tax Status

The Plan had adopted a volume submitter 401(k) and profit-sharing Plan with cash or deferral arrangement sponsored by Nova 401(k) Associates, Inc. (“Nova”), which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan, as then designed, was acceptable under Section 401(a) of the Code, and therefore, the related trust was exempt from taxation. The Plan itself had not received a determination letter from the IRS. However, Plan management believes the Plan, as adopted and amended, was operating within the guidelines of the Internal Revenue Code. Accordingly, no provision for federal income taxes had been provided in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization had taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan was subject to routine audits taken by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

9. Risks and Uncertainties

The Plan invested in various investment funds, a common collective trust fund, and a guaranteed investment contract. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the values of investments would occur in the near term and that such change could have materially affected participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Administrative Failures

During the year ended October 5, 2023, plan management failed to properly oversee the administration of the Plan, which resulted in the following administrative failures:

- Lack of documentation supporting employee demographic information
- Lack of documentation supporting employee death distribution
