Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tallahassee Orthopedic Clinic III P.L. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 22, 2023 (in liquidation) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to November 22, 2023 (in liquidation), and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 22, 2023 and December 31, 2022, and for the period January 1, 2023 to November 22, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Tallahassee Orthopedic Clinic III, P.L., the Plan's Sponsor, voted to terminate the Plan effective May 25, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. Description of Plan

The following description of the Tallahassee Orthopedic Clinic III P.L. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established and made effective April 1, 1999, for the benefit of the employees of Tallahassee Orthopedic Clinic III P.L. (the Company). The Plan and the Trust of which it is a part of are intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's Sponsor and Administrator. The Plan's third party administrator is Latitude Retirement. The Plan's directed Custodian is Empower Retirement (Empower). The Board of Directors are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Plan Termination

The Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In May 2023, the Plan Sponsor, Tallahassee Orthopedic Clinic III, P.L., was acquired by Orthopedic Solutions Management, LLC, contingent upon the termination of the Plan. As a result, the Board of Directors of Tallahassee Orthopedic Clinic III, P.L., the Plan's Sponsor, voted to terminate the Plan effective May 25, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements.

Effective May 25, 2023, the Plan was terminated, and the Plan document amended to freeze the addition of new eligible participants and contributions to the Plan. The Company provided proper notice of the Plan's termination to participants and beneficiaries including elections for their account balance distribution and rollover options. If participants failed to make an election regarding the distribution of their account balances, the Plan Sponsor rolled over the balance of their accounts to an individual retirement account (IRA), in accordance with the Plan terms and applicable rules and regulations.

Plan Termination (continued)

As a result of the decision to terminate the Plan during 2023, all participants became fully vested in their account balances. All Plan assets were either fully distributed or transferred, as elected by each participant or beneficiary, by November 22, 2023.

Eligibility

The Plan covered all employees of the Company, with the exception of common-law, leased or union employees. Employees, other than the previously mentioned excluded employees, could become a participant on the first day of the quarter coinciding with or next following 90 days of service.

Contributions

Effective May 25, 2023, contributions were no longer permitted to be remitted to the Plan pursuant to the Company's resolution to terminate the Plan. Prior to that date, participants could elect to make pre-tax and after-tax contributions to the Plan as defined in the Plan limited by the provisions of the IRC. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company contributed a Safe Harbor non-elective contribution equal to 3% of eligible compensation to the Plan. Additional discretionary profit sharing contributions were made at the discretion of the Company's Board of Directors. The Company made Safe Harbor contributions of \$192,058 and elected to make a discretionary profit sharing contribution of \$805,725 for the eleven months ended November 22, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company Safe Harbor contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

1. Description of Plan (continued)

Vesting

Participants are vested immediately in their contributions and in the employer's Safe Harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions and earnings thereon are based on years of continuous service. A participant is 100% vested in the Company's discretionary profit sharing contributions after three years of service.

As a result of the decision to terminate the Plan during 2023, all participants became fully vested in their account balances.

Payment of Benefits

Upon termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$5,000 may elect to receive a single lump-sum equal to the value of the participant's vested interest in his or her account. A single lump-sum distribution will be made to terminated participants whose vested balance is less than \$5,000 unless alternative instructions are provided by the participant within a reasonable period of time.

All Plan assets were either fully distributed or transferred, as elected by each participant or beneficiary, by November 22, 2023.

Forfeitures

At November 22, 2023 and December 31, 2022, the forfeited nonvested accounts totaled \$0 and \$1,218, respectively. These accounts were used to reduce employer contributions or pay qualified plan expenses. Forfeitures used to reduce employer contributions and pay qualified plan expenses totaled \$9,544 during the period January 1, 2023 to November 22, 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan presented as of November 22, 2023 and for the period January 1, 2023 to November 22, 2023, are prepared under the liquidation basis of accounting pursuant to the Plan's termination as described in Note 1. The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than the fully benefit-responsive investment contract discussed in Note 3, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodian, and insurance company. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments at November 22, 2023, are reported at liquidation value due to the Plan termination discussed in Note 1. There were no investments remaining at November 22, 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

The Plan has evaluated subsequent events through July 30, 2024, the date the financial statements were available to be issued. During the period from November 22, 2023 to July 30, 2024, the Plan did not have any material recognizable subsequent events.

3. Guaranteed Interest Fund with Empower Retirement

The Plan invested in a Guaranteed Interest Fund (GIF) provided through a group annuity contract with Empower. Under the terms of the group annuity contract, a crediting rate was established for amounts invested in the GIF and participants could direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as “book value.” The contract met the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

Because the GIF was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIF. The GIF is presented on the face of the statements of net assets available for benefits at contract value for the year ended December 31, 2022. Investments at November 22, 2023 are reported at liquidation value due to the Plan termination discussed in Note 1. There were no investments remaining at November 22, 2023.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor’s business.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract; (2) partial or complete plan termination; (3) plan disqualification; or (4) the issuer provides at least ninety days notice of termination. Consult your Plan’s contract for further information. See Note 1 regarding the Plan termination.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Investments at November 22, 2023 are reported at liquidation value due to the Plan termination discussed in Note 1.

Cash equivalents: Valued at the closing account balance held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements (continued)

Publicly traded common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds: Valued at the closing price reported in the active market in which the bonds are traded.

Common collective trusts: Valued at the net asset value (NAV) of shares held by the Plan at year end, as determined by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities

5. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by CCH Incorporated. The pre-approved profit sharing plan received an advisory letter from the IRS as to the pre-approved profit sharing plan's qualified status. The pre-approved profit sharing plan advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the IRC.

6. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 22, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. Information Certified by Empower Retirement

Certain information related to investments disclosed in the accompanying financial statements including investments held at November 22, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period January 1, 2023 to November 22, 2023, was obtained from management and agreed to or derived from information certified as complete and accurate by Empower (Custodian).

8. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by the Plan Custodian, Empower. Transactions involving these investments are considered to be party in interest transactions. Total fees paid for plan administration and investment management amount to \$205,895 for the period January 1, 2023 to November 22, 2023.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
