Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the NYCHSRO/Medreview, Inc. Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Other Matter – Merger of Plan

As discussed in Note 1 to the financial statements, the Plan transferred all of its assets to the NYCHSRO/MedReview, Inc. 401(k) Plan. As a result, the Plan ceased to exist as of May 1, 2022 (the date the transfer was completed). Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan Description

The following brief description of the NYCHSRO/MedReview, Inc. Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

Effective May 1, 2022 the assets of the Plan were merged into the NYCHSRO/MedReview, Inc. 401(k) Plan. The actual transfer of assets occurred on October 28, 2022.

Eligibility

The Plan is a defined contribution plan covering all full time employees of New York County Health Services Review Organization, Inc. and MedReview, Inc. (collectively, the "Company") who have completed one year of eligible service and attained the age of 21 and are employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees of the Company is responsible for oversight of the Plan. Management of the Company determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Trustees.

Contributions

Each year, the Company contributes to employees that have met the eligibility requirements an amount equal to 6% of each participant's compensation for participants hired before July 1, 2011, and an amount equal to 3% of each participant's compensation for participants hired on or after July 1, 2011. Compensation is defined in the Plan as "before-tax" earnings up to a maximum in accordance with Section 415(c) of the Internal Revenue Code ("IRC"), but not including overtime and bonuses. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers").

Effective April 15, 2022 the Company adopted a resolution to freeze the Plan. After April 15, 2022, no participant will accrue benefits under the Plan.

Participant Accounts

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollovers the participants make, Company contributions, and Plan earnings. Income earned and net appreciation or depreciation on Plan investments, are allocated in proportion to the participant's account balance in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (*continued*)

Vesting

Vesting in employer contributions is based on years of continuous service. A participant is vested in all employer contributions as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

Rollovers, along with the earnings associated with rollovers, are always 100% vested.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one outstanding loan at a time. The interest rate on the loan will be based on the prime rate of interest published by Wall Street Journal as of the date of the loan plus 2 percent. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 9.25% at December 31, 2021. Principal and interest are paid ratably through payroll deductions.

Distributions

Upon termination of service, including death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments not to exceed the life expectancy of the participant or the surviving spouse. For termination of services for other reasons, a participant shall receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions are subject to the applicable provisions of the Plan agreement. A participant may receive in-service distributions if they have achieved the age of 65.

Forfeitures

Forfeitures of non-vested benefits may be used to pay administrative expenses, or to reduce future employer contributions. Forfeited non-vested accounts totaled \$0 and \$158,130 at May 1, 2022 and December 31, 2021 respectively. During the period from January 1, 2022, to May 1, 2022, there were no forfeitures used to reduce administrative expenses or employer contributions. The forfeiture balance was transferred to the NYCHSRO/MedReview, Inc. 401(k) Plan effective May 1, 2022.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2021, all of the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the group annuity contract, which is stated at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in, less any withdrawals and transfers out. Registered investment companies held by the Plan are valued at fair value based on the daily closing price as reported by the companies. All of the registered investment companies are open-ended and are registered with the Securities and Exchange Commission. These companies are required to publish their daily NAV and to transact at that price. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at their outstanding principal amounts plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Other expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and notes receivable from participants held at May 1, 2022 and December 31, 2021, and net depreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the period from January 1, 2022 to May 1, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Group Annuity Contract

The Plan has a benefit-responsive investment contract with Empower Retirement (formerly MassMutual). The Guaranteed Interest Account (the "GIA") is provided through a group annuity contract (the "Contract"). A crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

4. Group Annuity Contract *(continued)*

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value. Such events include removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events may also include (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investor Service Aa3, A.M. Best Company A++, Fitch AA+, and Standard and Poor's AA+. These ratings are as of May 2021.

The group annuity contract represents approximately 0% and 46% of the Plan's net assets available for benefits as of May 1, 2022 and December 31, 2021, respectively.

5. Tax Status

The Internal Revenue Service has issued an opinion letter to the prototype plan document preparer dated March 31, 2014, which states that the Plan is designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2019; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain investments of the Plan were managed by Reliance Trust Company, the Trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.
