Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



(1) Description of the Plan

The following description of the *Haydon Building Corp 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General** – The Plan is a defined contribution plan covering all full-time employees of the Company who are age eighteen or older. Union employees and nonresident alien employees are not eligible to participate in the Plan. It is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).
- B. **Contributions** – Prior to 2023, newly eligible employees were automatically enrolled in the Plan with a salary reduction rate of 3%, unless affirmative election to the contrary was made. At the end of 2022, this provision was removed, and employees are no longer automatically enrolled. For the year ended December 31, 2023, participants may contribute up to \$22,500 of pretax and/or Roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. All eligible employees become participants on the first day of the month coinciding with or immediately following the date of employment. Employee after-tax contributions are no longer allowed in the Plan effective February 2023.

The Company matches 25% of qualified employee contributions to the Plan that do not exceed 15% of participants' annual compensation. Additional qualified non-elective contribution (QNECs) amounts may be contributed at the option of the Company's board of directors. Participants may share in any QNEC only if they are a non-highly compensated employee. Participant contributions as well as Company discretionary contributions are invested in a portfolio of investments as directed by the participant. Both employee and employer contributions are subject to Internal Revenue Service limitations.

Effective January 1, 2024, the Plan was amended, and a safe harbor match was implemented. Participants will receive 100% of the first 3% and 50% of the next 2% of eligible participant compensation contributed to the Plan.

- C. **Participant accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. **Investments** – Participants direct the investment of their contributions and the Company's matching contributions into any of the investment options offered by the Plan.
- E. **Vesting** – Participants are immediately vested in their contributions and any QNECs plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.
- F. **Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance. The loans are secured with an irrevocable pledge and assignment of the participant's vested interest or other substitute acceptable collateral and bear interest at the prime rate on the loan date.

(1) Description of the Plan (continued)

G. **Payment of benefits** – On termination of service due to disability or retirement, participants may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or have the distribution delayed, under certain rules of the plan. Participant consent to the distribution is required. If the participant dies, the entire account balance will be paid to the beneficiary as a death benefit.

H. **Forfeited accounts** – Forfeited non-vested accounts shall be applied to reduce contributions of the employer. Notwithstanding any other provision of the Plan to the contrary, forfeitures shall first be used to pay administrative expenses under the Plan if so directed by the Employer. Forfeited non-vested accounts totaled \$53,800 and \$5,920 at December 31, 2023 and 2022, respectively. Forfeitures totaling \$37,512 and \$125,816 were applied to employer contributions for the years ended December 31, 2023 and 2022, respectively.

(2) Summary of Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received if an asset was sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Under certain circumstances, a note that is in default may be considered a distribution from the Plan based on the terms of the Plan document. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded.

Payment of benefits – Benefit payments to participants were recorded when paid.

Administrative expenses – Administrative expenses of the Plan are paid by the Plan or by the Company, as provided in the Plan document.

Subsequent events – Management has evaluated subsequent events through August 5, 2024, the date the financial statements were available to be issued.

(3) Fair value measurement

FASB ASC 820, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or collaborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investments measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022:

Mutual funds and money market fund: Valued at net asset value of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Common collective trust: Common/collective trusts are valued based on the quoted redemption value of units, or the equivalent of net asset value, which is a practical expedient for estimating fair value. These investments have no unfunded commitments as of December 31, 2023 and 2022 and can be redeemed daily with no redemption notice period or other redemption restrictions.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their nonforfeitable accrued benefits.

(7) Tax status

The Internal Revenue Service has determined and informed the trustee by an opinion letter dated June 20, 2020 the volume submitter plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(8) Party-in-interest transactions

Plan investments are managed by Fidelity Management Trust Company; therefore, these transactions qualify as exempt party-in-interest transactions. The net administrative fee paid to Fidelity Management Trust Company was \$84,380 for the year ended December 31, 2023. The Company is the Plan Sponsor and provides all matching contributions to the Plan; consequently, these transactions also qualify as party-in-interest transactions.

(9) Excess contributions refundable

Excess contributions refundable consist of amounts contributed by participants to the Plan in excess of allowable limits established by ERISA requirements. Excess contribution refunds for the years ending December 31, 2023 and 2022 were \$172,809 and \$39,150, respectively.
