## **Independent Auditors' Report**

To the Plan Administrator and Participants

### **Report on the Financial Statements**

We were engaged to audit the accompanying financial statements of the Shape Security, Inc. 401(k) Savings Plan ("the Plan"), which comprise the statements of net assets available for benefits as of September 10, 2020 (Liquidation basis) and December 31, 2019 (Going concern basis), and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2020 to September 10, 2020, and the related notes to the financial statements.

### **Management's Responsibility for the Financial Statements**

Plan management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Our responsibility is to express an opinion on these financial statements based on conducting the audits in accordance with auditing standards generally accepted in the United States of America. Because of the matter described in the Basis for Disclaimer of Opinion paragraph, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

### **Basis for Disclaimer of Opinion**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 4, which was certified by Ascensus, LLC ("Ascensus"), as agent on behalf of Ascensus Trust Company ("Ascensus Trust"), the trustee and custodian of the Plan, except for comparing the information with the related information included in the financial statements. We have been informed by the Plan Administrator that Ascensus Trust holds the Plan's investment assets and executes investment transactions. The Plan Administrator has obtained a certification from Ascensus as of September 10, 2020 and December 31, 2019, and for the period January 1, 2020

to September 10, 2020, that the information provided to the Plan Administrator by Ascensus is complete and accurate.

### **Disclaimer of Opinion**

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

### **Other Matter - Supplemental Schedule**

The supplemental Schedule of Delinquent Participant Contributions for the period ended September 10, 2020 is required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 and is presented for the purpose of additional analysis and is not a required part of the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we do not express an opinion on the supplemental schedule.

### **Report on Form and Content in Compliance With the Department of Labor's Rules and Regulations**

The form and content of the information included in the financial statements and supplemental schedules, other than that derived from the information certified by Ascensus, have been audited by us in accordance with auditing standards generally accepted in the United States of America and, in our opinion, are presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Other Matter - Plan Termination**

As further discussed in Note 1, the Plan Sponsor decided to terminate the Plan effective January 21, 2020 and all plan assets were distributed in 2020 in accordance with ERISA. The Plan changed its basis of accounting from the going concern basis used in presenting the 2019 financial statements to the liquidation basis used in presenting the September 10, 2020 financial statements. Our opinion is not modified with respect to this matter.

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Shape Security, Inc. 401(k) Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

On December 19, 2019, F5 Networks, Inc. ("F5") agreed to acquire Shape Security, Inc. ("the Company" or "Plan Administrator"), and the Company was acquired by F5 on January 24, 2020. In connection with the acquisition, the Company terminated the Plan effective January 21, 2020 and all plan assets were distributed in 2020 in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**General** - The Plan is a defined contribution plan that was established on January 1, 2013 by the Company covering all eligible employees of the Company as defined in the Plan agreement. The Plan is subject to the provisions of the ERISA.

A Plan Committee ("the Committee") manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company has contracted with Ascensus Trust Company ("Ascensus Trust") to act as trustee and custodian. Ascensus, LLC. ("Ascensus") is the parent company for Ascensus Trust and certifies plan activity as agent and on behalf of Ascensus Trust. The Vanguard Group, Inc. ("Vanguard") provides record-keeping services for the Plan and processes and maintains records of participant data.

**Contributions** - In connection with the Plan termination, all contributions ceased on January 21, 2020. Prior to January 21, 2020, participants could contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allowed for automatic enrollment for eligible employees as defined in plan documents with a deferral rate of 6% of eligible compensation, unless the employee elects differently. The Plan allowed for ROTH deferral contributions. Participants who are age 50 or older could elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants could also contribute amounts representing distributions from other qualified eligible plans.

The Plan allowed for an employer discretionary matching and an employer discretionary profit sharing contribution subject to certain eligibility requirements; none were made for the period ended September 10, 2020.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution (if any), an allocation of the discretionary profit sharing contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary profit sharing contribution are based on participant compensation. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are 100% vested in their accounts at all times.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance (except for Roth deferrals), whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan Administrator. There were no outstanding notes receivable from participants as of September 10, 2020. Outstanding notes receivable from participants as of December 31, 2019 carry interest rates which range from 4.50% to 6.50%. Principal and interest is paid per the terms of the note and in accordance with plan provisions. The Plan Administrator establishes the specific terms and conditions of such notes.

**Payment of Benefits** - Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their account balance and are paid in accordance with plan provisions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting. In connection with the Plan termination on January 21, 2020 and in accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the going concern basis used in presenting the 2019 financial statements to the liquidation basis used in presenting the September 10, 2020 financial statements.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Ascensus Trust. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of September 10, 2020 and December 31, 2019, there were no material excess contributions payable.

**Plan Expenses** - For the period ended September 10, 2020, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Recordkeeping fees, certain participant transaction fees and investment advisory fees are paid through the Plan and charged to participant accounts as applicable. For the period ended September 10, 2020, some recordkeeping fees were paid by the Plan through the plan's expense account which is funded by charging participants. The Plan credits back recordkeeping fees as funds from registered investment advisor to those participants who generated it.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through August 1, 2024, the date the financial statements were available to be issued.

### **NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 4 - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at September 10, 2020 and December 31, 2019, interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the period January 1, 2020 to September 10, 2020, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus.

### **NOTE 5 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 10, 2020 and December 31, 2019.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### NOTE 6 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Ascensus Trust. Any purchases and sales of these investments are performed in the open market at fair value. Plan related fees are paid to Ascensus Trust, Ascensus, Vanguard, and an investment advisory firm. The Plan has other service providers. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **NOTE 7 - TAX STATUS**

The Plan adopted a prototype plan which received an opinion letter dated January 1, 2018 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 - NONEXEMPT TRANSACTIONS**

During 2019, certain participant contributions in the amount of \$330,795 were not deposited with the custodian on a timely basis, in accordance with the Department of Labor's Rules and Regulations. Since the Plan has terminated, the Plan Sponsor will not restore lost earnings to participants as the administrative costs involved exceed the lost earnings.
