Opinion

We have audited the financial statements of Miller Engineers, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of October 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended October 31, 2023, and the related notes to the financial statements.

1) Summary of Significant Plan Provisions

The following description of Miller Engineers, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan and Trust agreement for a more complete description of the Plan’s provisions.

General

The Plan is an employee stock ownership plan (ESOP) established by Miller Engineers, Inc. dba Souder, Miller & Associates (the “Company”) effective November 1, 2000. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of the Company are generally eligible to participate in the Plan retroactively to the first day of the Plan year in which the employee is age twenty-one or older and completes 1,000 hours during 12-consecutive month period from date of hire. The Trustees of the Plan are officers of the Company and are appointed by the Company’s Board of Directors. Effective November 1, 2022, Inberg-Miller Engineers (IME) merged with the Company and their employees were allowed to participate in the Plan, including retaining credit from prior service with IME.

Contributions

To become eligible for an ESOP contribution, participants must have 400 hours of service during the Plan year and be employed on the last day of the Plan year, or have terminated service due to normal retirement (age 65), disability, or death. Contributions to the Plan are at the discretion of the Company, and are typically based on the need to fund cash distributions to exiting participants, or to fund participant investment diversifications.

To the extent necessary, the Company and its subsidiaries (collectively, the Companies) shall contribute to the Plan the amount necessary to provide the top heavy minimum contribution as set forth by the Internal Revenue Code (IRC). Employer contributions may be paid in cash, shares of the Company’s stock, or other as determined by the Company. Shares of the Company’s stock and other contributions are measured at their fair value. Employee contributions are not permitted.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Allocations of the Companies’ contributions (including fractional shares), Plan earnings, forfeitures of terminated participants’ nonvested accounts, dividends paid on the Company’s stock, appreciation (depreciation) of the Company’s stock, realized gains (losses), and Plan expenses are made to each eligible participant’s account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Effective November 1, 2021, the vesting schedule was updated to a 3-year cliff schedule. A year of vesting is met when 400 hours have been completed during the Plan year.

The below vesting schedule is applicable to anyone who does not have an hour of service after November 1, 2021. If a participant's employment with the Company ends for any reason other than retirement, total or permanent disability, or death, the participant will vest in the balances in their account based on years of service as follows:

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant's vested interest shall become 100% vested and distribution shall commence no later than one year after the close of the Plan year in which such event occurs. If a participant terminates employment for reasons other than death, disability, or retirement, distribution shall commence as soon as possible after the close of the Plan year in which the participant occurs a one-year break in service. The amount to be distributed is based upon the most recently appraised value of the Company stock in place at the time the employee terminated. Upon termination, shares of Company stock owned will be converted to other investments at the fair value at the end of the Plan year in which there is a one-year break in service. Distributions are made in cash, with timing based on the participant's termination reason, as defined. If the total vested value of the distribution is over \$5,000, the distribution is made in sustainably equal annual installments over a period of five years.

The Plan may automatically distribute a participant's account if their total vested value is \$5,000 or less.

Voting Rights

All Company stock held by the Plan shall be voted by the Trustees. Notwithstanding the foregoing, participants or beneficiaries may direct the voting of any voting shares of Company stock allocated to their accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation.

Put Options

Under federal income tax regulations, the Company stock that is held by the Plan and its participants is not readily tradable on an established market, or subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. If a distribution was not part of a total distribution, full payment must be made in cash within thirty days. If the distribution was a total distribution, the Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Participants who are at age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account from Company stock to other investments. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Proceeds from diversified shares are converted to cash and distributed to participants as a lump sum or to another qualified plan or individual retirement account, at the participant's direction.

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are allocated as soon as possible after the close of the Plan year in which the terminated participant with a nonvested account balance incurs a five-year break in service. Plan forfeitures are allocated to each remaining participant's account based on their eligible compensation relative to total eligible compensation for the Plan year. There were no unallocated forfeitures at October 31, 2023 or 2022.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The significant estimate in the accompanying financial statements is the valuation of the Company's stock.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in common stock of the Plan sponsor. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect the participants' account balances and the amounts reported in the financial statements.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan permits, but does not require, the Company to pay significant costs of the Plan administration. The Company paid substantially all the Plan's expenses for the year ended October 31, 2023.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through June 24, 2024, the date which the financial statements were available to be issued. See Note 7 for subsequent events detail.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan invests in shares of common stock issued by the Company. Shares are valued as Level 3 inputs based on an annual valuation of the Company stock performed by an independent appraiser. This valuation was based on a combination of the market, income, and asset valuation methods, which is consistent with prior years. The appraiser considered the historical and projected cash flow and net income, return on assets, return on equity, market comparisons, and estimated fair value of the Company's assets and liabilities. Additionally, the acquisition of Inberg–Miller Engineers, LLC (IME) as of November 1, 2022 (Note 7) was also considered by the appraiser. As of October 31, 2023 and 2022, the fair value of the Company's stock was \$297.35 per share and \$195.39 per share, respectively.

The methods used to measure fair value may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

4) Related-Party and Party-In-Interest Transactions

The Plan invests in the Company stock. These are related-party and party-in-interest transactions. The Company also provides certain accounting, administrative, and measurement services to the Plan for which no fees are charged.

During the years ended October 31, 2023, the Company redeemed 2,824.04 shares, resulting in a gain of \$287,939.

5) Plan Termination

Although it has not expressed intent to do so, the Company, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would immediately become 100% vested in their accounts.

6) Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2023 and 2022, there are no uncertain positions taken or expected to

be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's tax return is currently under examination by the IRS for fiscal year ending October 31, 2022, however, management does not anticipate any significant adjustments.

7) Subsequent Events

On November 1, 2023, pursuant to a purchase agreement, the Company changed their plan sponsor and name to Azurite Professional Community Employee Stock Ownership Plan.
